## Final Rule Requirements In Effect

## Final Rule Requirements In Effect

- Any agency that covers pre-purchase, post purchase, default, or HECM counseling must cover <u>all</u> homeownership topics relevant to the client:
  - The decision to purchase a home
  - The selection and purchase of a home
  - Issues arising during and affecting the period of ownership of a home (including financial, refinancing, default, and foreclosure, and other financial decisions)
  - The sale or other disposition of a home
- Distribution of Home Inspection Materials
  - As part of the homeownership counseling process, participating agencies shall provide clients with importance of obtaining an independent home inspection using materials available

# Final Rule Requirements In Effect (cont)

- Agencies will be asked to provide updated work plans as part of the performance review process
- Work plan modifications related to homeownership counseling and home inspection materials
  - How the agency will cover homeownership counseling topics
    - Pre-purchase, Non-Delinquency Post Purchase Counseling, Reverse mortgage – <u>all homeownership topics</u>
    - Mortgage Delinquency Default Resolution Counseling topics related to post purchase/default
  - Address distribution of home inspection materials
    - HUD 92564-CN "For Your Protection: Get a Home Inspection" [HUD 92564-CN-SP if in Spanish]
    - Ten Important Questions to Ask Your Home Inspector (available at hud.gov and espanol.hud.gov)

## **Certification – Accomplishments**

- Since December 14, 2016:
  - Launched two separate websites, including numerous pages and tools/refinements as necessary
  - Edited a number of other HUD Exchange pages – Approval process, Intermediary page, etc.
  - Launched the Housing Counseling Agency Eligibility Tool, including accompanying tools
  - Launched exam August 1, 2017
  - Created Intro to Housing Counseling for prospective agencies











## **Certification – Accomplishments** (cont)

- Since December 14, 2016 (cont):
  - Published 181 **FAQs**
  - Held 16 webinars
  - Participated in over 50 outreach events
  - Published 24 certificationrule specific Bridge articles

## **Practice Exam and Certification Exam**

- Practice exam
  - One set of questions
  - Designed to provide example of test format
  - Not scored, but feedback provided
    - Areas recommended for continued success
    - Areas for additional study is needed for moderate improvement
    - Areas where significant study is needed for considerable improvement
- Certification exam available either in person or online
  - No pen and paper due to security issues
  - Exam structure tests all six topic areas due to Cert Rule requirements
  - Scored in a range (500+ out of 800 is passing), with same feedback noted above for practice exam
- Reasonable Accommodation Requests Bixal needs 30 days to review requests and schedule accommodations





## **Key Intermediary Steps in Certification**



## 1. Identify internal timeline and benchmarks

- Determine agency goals for certification
  - Type of training to offer internal or external
  - Identify tools to use (e.g., practice exam, training prep, etc.)
  - Determine and/or revisit # of housing counselors certified by specific date/month
    - Intermediary (as applicable)
    - Affiliates
- Decide available time and resources
  - Intermediary resources, affiliate resources, or combination
    - Hours
    - Funds for reimbursement

## 2. Determine the Intermediary's Role in the Process

- Expertise in all six areas of the exam
  - Affiliates cross train as necessary
- Encouragement and support
  - Financial incentives?
  - Training Support
- Define policies and procedures around certification
- Manage certification process directly or
  - Expect affiliates to handle those processes
  - Change affiliate agreements?
- Identify FHA Connection Roles
  - Select FHA Connection Application Coordinators
  - Supporting FHA Connection ID Application sign up

## 3. Modify Quality Control Plan

- Update plan for certification goals and timeline
- Describe training, tools and support activities that will be provided to affiliates
- Systems for tracking housing counselor certification
  - FHA Connection
  - HUD Page
- Include certification-related tasks in performance reviews
- Plan now for policies and procedures that will be implemented August 1, 2020

## 4. Prepare Affiliates to take Exam

- Get affiliates prepared
  - Make sure counselors have time to study
  - Develop a cohort of counselors taking the exam
  - Provide internal Training
  - Send links to HUD Exchange and Training websites



#### Preparing for the Certification Exam

- Create an account on www.hudhousingcounselors.com
- Online proctored exam costs \$60 and an in-person proctored exam costs \$100
- Check your system requirements for online proctoring
- Before scheduling your exam, test equipment compatibility which includes checks for webcam, microphone, an internet speed
- Review the Test Taker Gu the System Requirements for online testing

- Exam registration, cancellations, and changes are handled through your www.HUDHousingCounselors.com account
- · Avoid no show fees!
- For both online and onsite exams, the
   Exam Status Center provides access to
   exam details and allows you to
   reschedule, cancel or change the mode
   of delivery of your exam.

- Prior to exam launch, you should have already downloaded the Sentinel software and completed your Biometrics enrollment
- No books, papers, or other reference materials are allowed
- No use of paper or writing utensils during the exam

# 4. Prepare Affiliates to take Exam (cont)

- Carpool for in person courses
- Set up an exam space for online courses
  - Test office at Intermediary, or central location
- Use a training partner(s) for external training prep and practice classes
  - NeighborWorks
  - RCAC
  - NCRC
  - UnidosUS


## 5. Follow up with Affiliates

- Revisit by 8/1/2019 # of certified housing counselors
- Reward housing counselors who receive their certification
  - Feature on intermediary website, newsletters, email blasts, etc.
- Leverage certified housing counselors
  - Mentor those who have not yet been certified
  - Create tips sheet, study tools, etc.
- Keep HUD point of contact updated as necessary
  - Report on lessons learned, best practices, etc.
- Adjust agency goals and timeline as necessary

#### 6. Conclude Certification Standard Met

- On or before 8/1/2020, all housing counselors certified
  - Earlier goal strongly recommended, such as 8/1/2019
  - Remember that cost of exam may increase
- Prepare for nonrenewal of affiliates and/or housing counselor duties reassigned
  - Update Quality Control plan
- Add new affiliates with certified housing counselors

# FHAC Coordinator Application Process

- FHA Connection used for both counselors and coordinators
- If applying only as a coordinator, apply only for an FHAC User ID
- If applying to be both a coordinator and counselor, complete the HUD Certified Housing Counselor application first and be accepted by HUD
- An agency cannot have the same person registered in eLOCCS and FHAC Coordinator\*

#### FHAC Application Coordinator Responsibilities

The purpose of the FHAC Application Coordinator is to certify the counselor's employment at the agency and to manage the data regarding the counselor's employment status in the future.

HUD-approved housing counseling agencies must designate at least one individual to act as FHAC Application Coordinator. An agency can have a maximum of four FHAC Application Coordinators and at least two are recommended. The coordinator cannot be the same person currently registered in in the Line of Credit Control System (LOCCS) or the Web Access Security Subsystem (WASS), nor can the coordinator currently act as the FHA lender coordinator for the agency. The coordinator cannot certify their own employment. Intermediary Coordinators may perform the coordinator functions for their affiliates. Intermediaries may also obtain an FHAC ID simply to view their affiliates or if they want to validate and/or terminate counselors from their network.

You must register in FHA Connection (FHAC) as the FHAC Application Coordinator for your agency. Upon completion of your registration, you will get an email stating that a letter with your User ID will be mailed to the Executive Director of your agency and should be received in 7-10 days.

Certifying HUD Certified Housing Counselors' Employment

- 1. Log into the FHA Connection.
- 2. Navigate to the HUD Certified Housing Counselor Database by following these steps:
  - Select Single Family FHA
  - · Select Single Family Origination
  - · Select Counseling Functions
  - · Select HUD Certified Housing Counselor Database
- Enter the counselor's last name, select NO under Validated by agency, and select Certified for Counselor type, then click the Send button. You don't need to change any of the other fields. You should now see the

## **Coordinator Verifies Employment**

- 1. Log into the FHAC
- 2. Navigate to **HUD Certified Housing Counselor Database**

Single Family FHA > Single Family Origination > Counseling Functions > HUD Certified Housing Counselor Database

- Enter the counselor's last name, select *Certified* for **Counselor Type**, and select *No* for **Validated by Agency**
  - Leave the name blank to receive a list of all counselors who have indicated they work for the agency.
- 4. Then, click the **Send** button



# Intermediary FHAC Application Coordinator Options

## **Option 1**

- Verify network agencies' compliance
- View affiliates' certification information
- Serve as a back-up FHAC
   AC for network affiliates

### **Option 2**

- Verify employment of housing counselors for all affiliates
- Remove counselors no longer employed by affiliates
- Print counselor certification certificates


