Someone who is fleeing or attempting to flee their housing due to sexual assault need not first lose their housing to qualify under Category 4 of HUD's definition of homeless. They need to be fleeing or attempting to flee sexual assault and lack the resources or support network to obtain other permanent housing. If they meet those criteria then they would qualify under Category 4. If they have already lost their housing, but are no longer fleeing or attempting to flee sexual assault, then they may still qualify under one of HUD's other categories of homelessness, but that would depend upon where they are currently living (e.g., an emergency shelter). Also, it's important to note as it relates to Category 4, that it is the survivor who determines whether they are fleeing or attempting to flee, not HUD or the recipient of HUD funds.
