





Substantial OModerate OLow





#### **4-Week Forecasting of National COVID-19 Cases**





### Top Line Take-Away: Two Rules, One Goal

**OSHA Rule:** Applies to (non-health care) private employers with 100+ employees

- Mandates weekly testing if unvaccinated
- **CMS Rule:** Applies to nearly all health care providers
  - Mandates vaccination, no testing option

# **Common goal:** Increase COVID-19 vaccinations



### **OSHA Rule**

#### • Important Deadline Dates:

- December 6: All requirements implemented (to include creating policies), except testing
- January 4: Testing requirements must be in effect

#### • Important Details:

- 1. Rule currently on hold pending legal challenges
- 2. Weekly testing is at <u>employee</u> time & expense
- 3. Rules are <u>minimum</u> standard and pre-empt state laws; states/employers may impose stricter rules
- 4. Federal law re: medical/religious exemptions apply (may be subject to state laws)
- 5. Unvaccinated employees must mask at work (unless 100% telework or outside)
- 6. Employers must track employee vaccination status and all testing results
- 7. Employers must provide up to 4 hours paid time off for workers to get vaccinated and "reasonable time and paid sick leave" for side effects
- 8. Employers must not discriminate against those who wear masks or get vaccinated
- 9. Employers must provide information in all languages spoken at worksite
- 10. Prior COVID-19 infection does <u>not</u> exempt employees from requirements

#### **CMS Rule**

#### • Important Deadline Dates

- December 6: All employees must have at least one vaccination dose or submit for exemption
- January 4: All employees must have completed second dose (or just one dose, if J&J) or have an approved exemption

#### • Important Details

NATIONAL HEALTH CARE for the HOMELESS COUNCIL

- Includes volunteers, contractors, students/interns, housekeeping, security, facilities staff, etc.—anyone who is ever onsite, or goes to offsite locations (e.g., encampments, supportive housing sites, etc.)
- Rules are <u>minimum</u> standard and pre-empt state laws; states/employers may impose stricter rules
- Federal law re: medical/religious exemptions apply (may be subject to state laws)
- Prior COVID-19 infection does <u>not</u> exempt employees from requirements

#### • <u>Wild Card</u>: Navigating Homeless Services Spaces

 Homeless services providers co-located with health care providers or who have contracting/close relationships may fall under this rule



Lawndale Christian Health Center Mobile Health Team: 17 providers including 1 psychiatrist; 5 Mobile Health Assistants; 3 Care Managers; 1 Referral Coordinator >>12 weekly MH sites; 1854 pts in 6,667 encounters in 2020-21 >>In 2021, the Point in Time Count noted 4,447 PEH in Chicago.

### Lesson 2: Antiracist Engagement

- Acknowledge past and present experience of systemic racism in health care
- Ask what have you heard; acknowledge the confusing information in social media
- Ask permission to share scientific information and provider's own experience
- Affirm person's strengths and interest in their own care
- Emphasize messengers from the same racial/ethnic background, but ALL must be involved
- Work with person to develop their own plan and respect that plan
- No matter what their decision, emphasize that we will always be happy to see you in the future





Engagement efforts led to shelter-based coronavirus vaccination efforts with >2700 doses given by LCHC, with >52.0% of PEH in Chicago receiving at least one dose

Lesson 3: Challenges in Data Sharing: HMIS, City Departments, Health Care Providers, & Housing Providers

- Just to start: How to determine an accurate denominator= the total number of PEH
  - HMIS numbers may be more accurate than Point In Time count, but challenges and misconceptions remain with HMIS data sharing with city departments and health care providers, even for important public health information such as vaccination status
  - How could data sharing be improved?



Housing is Health Care: In response to the COVID-19 pandemic, 259 high-risk PEH received protective housing at a downtown Chicago hotel from April-Sept 2020 ; 132 achieved housing using AMEs







# 104 PEH Assessed by Medical/Mental Health Teams before Accelerated Moving Events (AMEs) in Feb-Mar 2021

- 20 were being seen for the first time
- 69 needed case management
- 26 had problems with stairs
- 46 had problems emailing or texting
- 20 needed medications
- 27 needed meds for Substance Use Disorder (SUD)
- 51 had ANY mental illness
- 28 were opened for ACT/CST/RST support
- >>>We STRONGLY advocate for the health care team to see every PEH in shelters AT LEAST ONCE to ensure PEH have the supports they need once housed



Lesson 4: The Intersection of Health Care and Housing

- Would CoCs benefit from representation by active clinicians who serve PEH face to face?
  - Aim to increase housing success and retention with supports for: medical, behavioral health, SUD, SMI, social isolation, and spiritual issues
- Would appropriate housing and the health of shelter residents be improved by requiring PEH to see a health care provider at least once to discuss unmet needs for health, including vaccination?
- What are the accountability mechanisms for CoCs?

### **Transportation Considerations**

- Transporting Participants to a COVID-19 Vaccination Event
- Detailed plan needed for safely and efficiently transporting clients for offsite vaccination
- Explore community transportation partnerships
- Explore ESG, CDBG, and/or HOPWA funding to cover costs
- Consider rural vs. urban logistical challenges
- Communication is key!
- Proactive planning to be ready at a moment's notice



# Vaccination in Unsheltered Settings: Guiding Principles

- Vaccinations in Unsheltered Settings: Event Types and Considerations
- Multipronged approach
- Inclusive
- Trauma-informed
- Communicate using trusted individuals and locations
- Ease and access
- Maximize time with clients
- Safety



# Vaccination in Unsheltered Settings: General Considerations

- Case Study: <u>Oahu, HI</u>
- Use HMIS and by-name lists, street outreach and street medicine teams to identify where people are located and map out distance between vaccination event(s), central hub for supplies, and consider how to move between the two during the event.
- During the observation period, collect UDEs and other information in a private location.
- Offer vaccination events frequently at the same location and time ex. come to the library every Tuesday from noon-2pm for a vaccination



# Vaccination in Unsheltered Settings: Strategy #1 - Encampments

- Sync vaccination event hours with times when individuals are most likely to be at the location, including at night.
- Encampments can be formal or informal, so if there is existing leadership within the encampment, include these individuals in the planning process to ensure better turnout and acceptance by the individuals living there.
- To minimize intrusion into personal space, set up vaccination events at the outside perimeter of encampments with street access or other routes that can be used to bring additional vaccine supplies.



# Vaccination in Unsheltered Settings: Strategy #2 - Rural

- Identify regular gathering places (libraries, food banks, faith centers, transit centers, gas stations) that can be used for vaccination events.
- There may be no local homeless service providers or health department, so partner with a healthcare provider or community stakeholder who can connect with the resources needed to bring the vaccine to unsheltered people.
- Get creative when seeking out vaccine ambassadors (church leaders, postal workers, park rangers, convenience store clerks).
- Equip team with Wi-Fi hot spots and paper collection forms if there is not broadband available.



# Vaccination in Unsheltered Settings: Strategy #3 – Mobile Vaccination

- Outreach staff can ask individuals what time works best for them and accommodate their preferences to the greatest extent possible. Attempt to identify multiple individuals who can receive vaccines at the same time to maximize vaccine supplies.
- Mobile vaccination requires less infrastructure, so consider the minimum setup (supplies, staff) needed to vaccinate safely.
- Staff may be limited to a set number of hours for vaccination attempts depending upon their travel schedule (distance, punctured vials), so factor this into planning.




## Vaccine Incentives

- Vaccine incentives have always been one of the tools to support and encourage individuals to get vaccinated, along with opportunities to talk with and ask questions of trusted sources and easy and frequent access to vaccination events.
- ESG-CV funds can be used to pay for incentives
  - \$50 per dose
    - Boosters (if applicable) another \$50
- \*ESG-CV funds may only be used for vaccine incentives to the extent other vaccine incentives are inaccessible or unavailable to people experiencing homelessness within the community.


