Given the low vacancy, they are limited to working with landlords of more luxury rental units who are apprehensive to work with them. They are expanding landlord engagement and outreach and offering incentives. At the same time, this county is having increased difficulty getting hotels to rent rooms to them for non-congregate sheltering, and many remain unsheltered. They are working hard to re-house folks out of non-congregate shelter to create turnover in those opportunities, but they are very concerned about how they will shelter people in the winter months given the presenting challenges.
