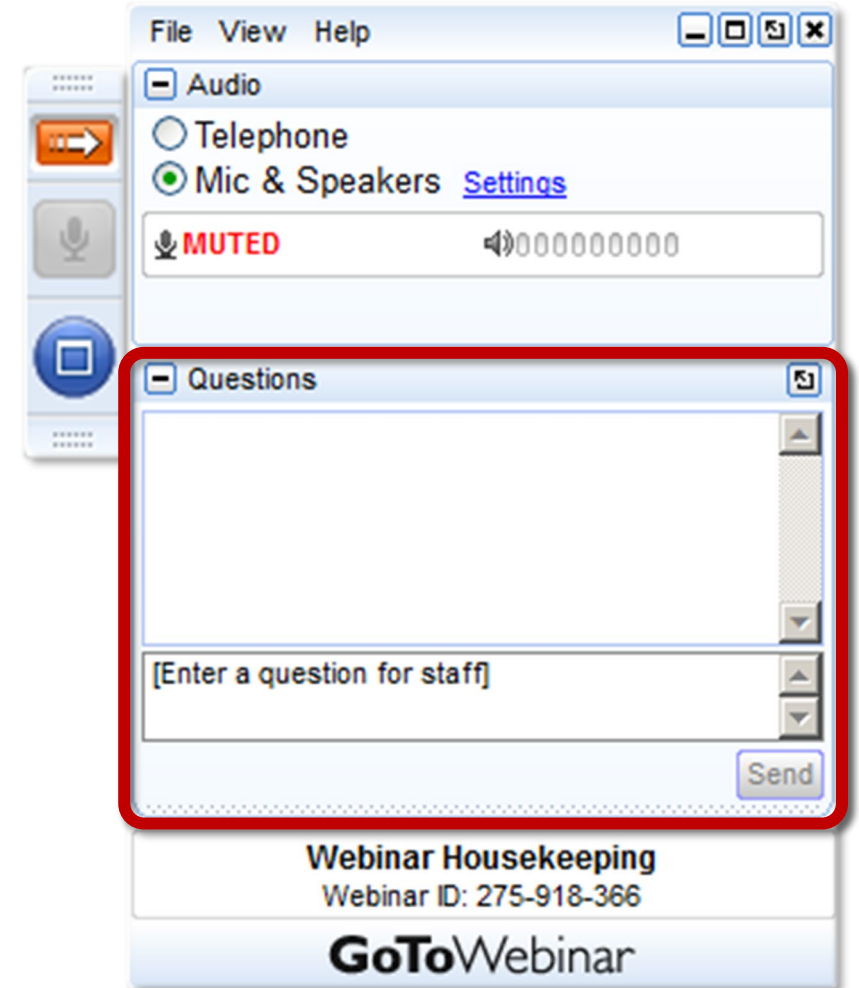

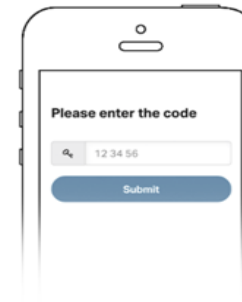

HUD's Housing Counseling Program

- HUD's Housing Counseling program provides counseling to consumers on seeking, financing, maintaining, renting, or owning a home.
- The program also addresses homelessness through counseling and assists homeowners in need of foreclosure assistance.

What is Housing Counseling?

- Housing Counselors provide independent, expert advice customized to the needs of the consumer to address the consumer's housing barriers and to help achieve their housing goals. Counseling must include the following elements:

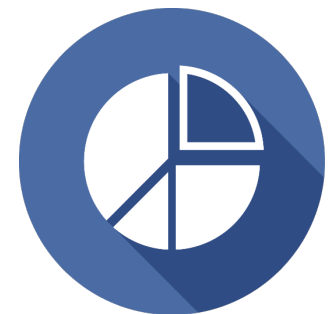

Federal Agency	Program and Allocation	Description of Funding	Applicable Eligible Activities	Housing Counseling Related Uses	Contact
Treasury (Treasury Department) 	Coronavirus Relief Fund (CRF) \$150 billion	Treasury disburses payments to states and eligible units of local government, D.C. and U.S. Territories, and Tribal governments to cover necessary expenses incurred due to the COVID-19 public health emergency. Each unit of government is responsible for making determinations regarding which expenses are necessary due to the public health emergency.	Eligible expenses may include: <ul style="list-style-type: none"> • Medical expenses • Public health expenses • Payroll expenses for public safety, public health, health care, human services, and similar employees • Expenses to facilitate compliance with COVID-19-related public health measures • Expenses associated with the provision of economic support 	Uses specific to housing counseling include: <ul style="list-style-type: none"> • Payment of overdue rent or mortgage payments related to the public health emergency • Eviction prevention related to the public health emergency • Utility fees to maintain essential services, related to the public health emergency 	View CRF allocations (search by state, county, and/or city/metro)
	Emergency Rental Assistance Program \$25 billion	Passed on December 21, 2020 the Emergency Rental Assistance program makes available \$25 billion to assist households that are unable to pay rent and utilities due to the COVID-19 pandemic. The funds are provided directly to States, U.S. Territories, local governments, and Indian tribes. Grantees use the funds to provide assistance to eligible households through existing or newly created rental assistance programs.	Eligible expenses include: <ul style="list-style-type: none"> • At least 90% of the funds must be used to provide financial assistance, including back and forward rent and utility payments incurred due to the pandemic. Assistance can be provided for 12 months. States and localities can provide an additional 3 months of assistance if necessary, to ensure housing stability for a household. • When providing forward rent, assistance can only be given for 3 months, though households can subsequently reapply for additional assistance. • Recipients can use up to 10% of funds to provide case management and other services related to the pandemic. 	Uses specific to housing counseling include: <ul style="list-style-type: none"> • Payment of back and forward rent, utility payments, and other housing expenses incurred due to the pandemic • Case management and other services related to the pandemic to help keep households stably housed 	The Treasury Department has issued its methodology for allocations and eligible units of local government .

When Should you use Rental Housing Counseling?

- As owners and managers of HUD-assisted and FHA-insured multifamily properties you should refer tenants to housing counseling agencies when:
 - A tenant has missed rent payments or is struggling to pay on time
 - Tenant job loss or other pandemic-related hardship
 - At time of lease or lease application
 - To restore communication

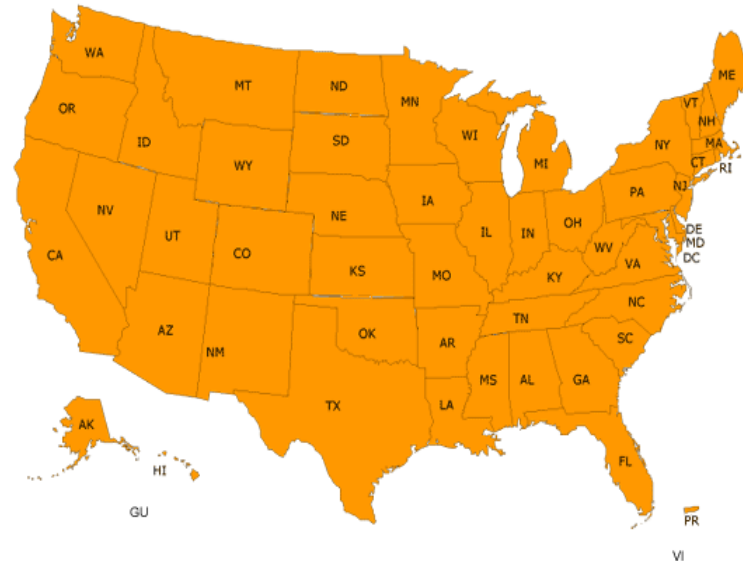

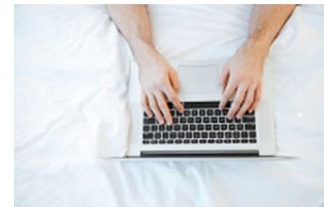
