

#### The FHA Single Family Housing Policy Handbook: Origination through Post-Closing/Endorsement Pre-recorded Training Module Descriptions

MODULE 0: Introduction and Navigating the SF Handbook (Recorded on 4/21/15): Provides introductory and background information on the structure of the new Single Family Housing Policy Handbook (SF Handbook; HUD Handbook 4000.1), specifically, the Origination Through Post-Closing/Endorsement for Title II Forward Mortgage section. Webinar duration: 29 minutes.

**MODULE 1: Origination/Processing** (Recorded on 3/31/15): Provides an indepth walk through of the section and how to use its Definition, Standard, and Documentation structure. **Webinar duration**: 42 minutes.

MODULE 2: Allowable Mortgage Parameters (Recorded on 3/31/15): Highlights the section as it pertains to the basic underwriting standards for Single Family (1- to 4-unit) mortgages insured under the National Housing Act. Webinar duration: 16 minutes.

MODULE 3A: Appraisals (Recorded on 4/2/15): Discusses the Property Acceptability Criteria for FHA mortgage insurance under this section and details on the Minimum Property Requirements (MPR) and Minimum Property Standards (MPS). Webinar/Module duration: 31 minutes.

**MODULE 3B: Underwriting the Property** (Recorded on 4/2/15): Highlights the Underwriting the Property section of the SF Handbook. **Webinar/Module duration**: 117 minutes.

MODULES 4 and 5: Using the TOTAL Mortgage Scorecard, AND, Manual Underwriting (Recorded on 4/9/15): These modules highlight policies for effectively conducting both a TOTAL Scorecard and Manual Underwrite evaluation using the new SF Handbook. Webinar duration: 170 minutes.

**MODULE 6: Closing** (Recorded on 4/16/15): Reviews policies and provides clarity for effectively preparing for closing and disbursement on a mortgage loan to be insured by FHA. **Webinar duration**: 64 minutes.

**MODULE 7: Post-Closing/Endorsement** (Recorded on 4/28/15): Provides an overview for the Post-Endorsement Review; case binder documentation requirements; and FHA insurance endorsement. **Webinar duration**: 45 minutes.

MODULE 8A: Programs and Products-Refinance (Recorded on 4/15/15): Reviews the different types of refinance products and eligibility requirements of FHA Refinance programs. Webinar duration: 91 minutes.

MODULE 8B: Programs and Products-Continued (Recorded on 4/20/15): Provides a policy overview on specialized programs such as the Energy Efficient Mortgage; 203(h) Mortgage for Disaster Victims; Adjustable Rate Mortgages (ARMs); New Construction; Construction-to-Permanent; Assumptions; Weatherization, and more. Webinar duration: 151 minutes.

MODULE 9: 203(k) and Consultant Requirements (Recorded on 4/10/15): The Section 203(k) program is the agency's primary program for the rehabilitation and repair of single family properties. This module reviews aspects of the Section 203(k) Rehabilitation Mortgage Insurance Program and the 203(k) Consultant Requirements and Responsibilities. Webinar duration: 164 minutes.
