

## **Housing Counselor Certification**

## **Housing Counselor Certification**



#### **KEY PROVISIONS**

Housing counseling required under or provided in connection with **any** program administered by HUD shall be provided **only** by organizations and counselors certified by the Secretary.

A HUD Certified Housing Counselor is a housing counselor who has **passed** the HUD certification examination **and** works for a HUD-approved housing counseling agency.

Effective date: August 1, 2020

### **Benefits of Certification**



Broader knowledge = Better counseling	Create professional recognition for housing counselors	Elevate the value of the program for consumers
Consumers avoid scammers and con artists	A credential for counselors	Consumers benefit from HUD approved agencies
Housing counseling offered in connection with HUD programs meets OHC standards	Programs and counselors eligible for grants and scholarships	Increased visibility and awareness of housing counseling

#### Who Needs to be Certified?



All individuals working for a Participating Agency who provide Housing Counseling services, or oversee group education, or both, must be HUD certified.

• includes Home Equity Conversion Mortgage (HECM) counselors.

"Works for" means both paid employees and volunteers, on a full- or part-time basis. If an agency validates the employment of an individual, the agency will:

- be responsible for any housing counseling activity conducted by the housing counselor pursuant to that certification
- be responsible for ensuring that the counselor's activities comply with all regulations and requirements of HUD's Housing Counseling program, including requirements pertaining to conflicts of interest and subcontracting.

# Who Needs to be Certified? Group Education



- A HUD Certified Counselor overseeing a group education class must approve the curriculum and the materials provided to the clients.
- Must monitor the delivery of the education.
- For in- person classes, a HUD Certified Housing Counselor need not be physically present at all times, provided the counselor exercises control over the content of the session.
- For online classes, a HUD Certified Counselor must approve the curriculum and the materials provided to the clients.

### Who Doesn't Need to be Certified?



 Staff of entities whose roles are limited to funding, overseeing or administering a housing counseling program <u>and</u> who do not provide housing counseling services directly to clients or oversee group education are not required to become HUD-certified housing counselors

#### **Practice Exam**



- Free Available on www.hudhousingcounselors.com
- Designed to provide example of test format
- Not scored, but feedback provided
  - Areas recommended for continued success.
  - Areas for additional study is needed for moderate improvement
  - Areas where significant study is needed for considerable improvement
- Recommend taking practice exam after study and before taking the certification examination

## NEW! Knowledge Assessment Tool (KAT)



- Free Available on www.hudhousingcounselors.com
- Suggested best practice take the KAT first to help identify topic areas that require study.
- KAT does not replace the existing practice exam but does provide candidates with detailed feedback and a score.
- The assessment offers insight into the correct answers and provides recommended topics for further study.
- Recommendations will identify areas of strength and weakness for continued study.
- Also available in Spanish.

## **Housing Counselor Exam**



- Only need to pass the certification examination once
- Examination may be taken on-line or at a proctoring center
- Test is available in English and Spanish
- Exam fee: \$60 online \$100 for proctoring center
- Test may be taken multiple times; fee must be paid each time
- On-line proctors may be available 24 hours a day
   7 days a week except for major holidays

## **Housing Counselor Exam**



- Test has 90 multiple-choice questions
- 2 hours to complete
- On-line calculator and white pad on screen
- 500 out of 800 score required to pass



## **Housing Counselor Certification Exam**



I PASSED! NOW WHAT?

## Passing Exam ≠ HUD Certified



- Counselor must authorize transfer of exam results and then begin the application process in FHA Connection
- Employment must be verified in FHA Connection by the agency Application Coordinator
  - Agencies must designate an FHAC Application
     Coordinator to validate counselor's employment

## **Email Notification of Passing Score**



#### **Result: PASS**

- Congratulations! You achieved a passing score on the HUD Housing Counselor Certification written examination.
- To continue the process to become certified, you must take the following steps:
  - Sign into your account on <a href="www.HUDHousingCounselors.com">www.HUDHousingCounselors.com</a> to provide additional information and authorize the transfer your testing results to FHA Connection. Note that you will receive a Counselor Exam ID during this step.
  - Begin your HUD Certified Housing Counselor Application in FHA Connection. You will need to enter your Counselor Exam ID that you received in the previous step.

# FHA Connection and Housing Counselor Certification



## **Every agency requires an FHA Connection Application Coordinator**

- Validates employment and certify counselors who pass exam
- Counselors cannot self-verify their own employment status or HECM Roster in FHA Connection
- Once counselor's employment is validated, a HUD certified housing counselor certificate can be printed and/or downloaded

## Certification Application Process in FHAC

#### **HUD Certified Housing Counselor Application Process**

After passing the HUD Certified housing counselor examination and transferring the exam results to the FHA Connection (FHAC), Counselors must apply for certification in the FHA Connection and have their employment validated by the agency FHA Connection application coordinator. Every agency must designate at least one person to serve as the agency application coordinator. This page provides detailed instructions and accompanying screenshots for Housing Counselors and Agency FHA Connection application coordinators.

You may apply as a **HUD certified housing counselor**, as an **application coordinator**, or as **both**. Each of these roles require different actions to be taken within FHA Connection.

This page has 3 different sets of instructions. Click on the icons below to refresh the page at the start of each instruction set. **Note that both counselors and coordinators can print counselor certificates**.



Please read these notes in their entirety before taking any action.

- · Read the eligibility requirements.
- · Applications must be submitted online.
- In addition to the application, your exam score must have been transferred and accepted into FHA Connection.
- · You must include a valid email address in your application.

#### Beginning your application in FHA Connection:

 Go to the HUD Certified Housing Counselor Application page and change the Counselor Type to Certified. A pop-up warning message appears advising the user that any HECM training data will be cleared. Click OK to clear the message.


#### **Some Statistics**

## **Most Frequent Certification Issues**



- Did not know the process for certification through FHAC
- Failed to transfer exam results to FHAC
- Never received FHAC User ID
- Coordinator Conflicts for secure systems users
- Did not know the HCS agency ID
- Could not find counselor exam ID
- Transposed social security numbers

# **Post-Certification FAQs**

#### **After Certification**



- Q. Can an individual be certified with more than one agency at the same time?
- A. Yes.
- Q. When does the HUD certified housing counselor certification expire?
- A. There is no expiration date of the certification provided that the individual passed the examination and continues to work for a Participating Agency.

#### **After Certification**



- Q. If an individual is a HUD Certified Counselor working and then leaves that agency does the certification follow that individual?
- A. An individual's HUD housing counselor certification is connected to the HUD-participating agency that has verified the individual's employment. If the individual leaves that agency, the counselor's certification with that agency will end.

# Understanding Certification and Other HUD Programs

## **Housing Counselor Certification**



#### **KEY PROVISIONS**

Housing counseling required under or provided in connection with any program administered by HUD shall be provided only by organizations and counselors certified by the Secretary.

Effective date: August 1, 2020

## **Covered Programs**



# Required under or provided in connection with any program administered by HUD means:

- 1. Housing Counseling is required by HUD
- Housing Counseling that is funded under a HUD program.
- 3. Housing Counseling that is required by a grantee or sub-grantee of a HUD program as a condition of receiving assistance
- 4. Client served by a HUD program is referred to housing counseling

#### **Other HUD Programs**



In addition to HUD's Housing Counseling Program, 26 other HUD Programs are also covered by Housing Counselor Certification requirements. The other covered HUD programs with greatest number of stakeholders:

- Community Planning and Development programs
- Public and Indian Housing programs

# Community Planning and Development (CPD) Covered Programs



#### **CPD Programs covered include:**

- HOME
- Community Development Block Grant Program including Disaster Recovery
- Housing Trust Fund
- Housing Opportunities for Persons With AIDS
- Emergency Solutions Grant
- Continuum of Care program

## **Programs Under Public and Indian**



Example of some of the programs covered under the housing counseling rule

- Family Self Sufficiency
- Resident Opportunity Self-Sufficiency (ROSS)
- Section 8 Homeownership Voucher Program
- Programs covered will require the use of a HUD certified housing counselor for housing counseling services

## **Covered Programs**



 Any HUD program where a grantee or sub-grantee makes a housing counseling referral to a family assisted under the HUD program must make the referral to an agency approved to participate in HUD's Housing Counseling program and counseling must be provided by a HUD certified housing counselor effective August 1, 2020.

## **Options for Compliance**



- Apply to participate in HUD's Housing Counseling Program directly or as an affiliate of an intermediary or state housing finance agency
- Partner with an existing HUD Approved Housing Counseling Agency to deliver housing counseling
- Modify covered programs in order to become compliant
- Stop delivering housing counseling services effective on August 1, 2020
