



#### Housing Counseling Agency and Homeless Service System Partnerships




- Housing instability vs. homelessness difficulty in predicting who will experience homelessness
- Homeless programs do not address larger economic and housing conditions that lead to deep poverty
- Need for a systemic response and strategic allocation of resources to maximize impact

# Understanding the Structure of Homeless Service Systems

- The **Continuum of Care** (CoC) Program is designed to:
  - promote communitywide commitment to the goal of ending homelessness
  - provide funding for nonprofit providers and State and local governments to quickly rehouse homeless individuals and families
  - minimize trauma and dislocation caused to homeless individuals, families, and communities by homelessness
  - promote access to and utilization of mainstream programs by homeless individuals and families
  - optimize self-sufficiency among individuals and families experiencing homelessness

## Partnering to Prevent Eviction

- How can HCAs and homeless service systems partner to prevent eviction?
  - Share data to identify community needs
  - Collaborating on intake and assessment to identify and support households at risk of eviction (effective triage)
  - Collaborate to supplement rental assistance funding resources (for example, ESG-CV and CDBG-CV)
  - Pool resources to work with local landlords and identify available rental units
  - Make referrals to other rental housing resources when appropriate (legal services, mediation, landlord/tenant education)



#### Housing Stabilization Coalition

- Community Shelter Board and the Homeless Prevention Network Risk Typology
  - No one entity can support the entire spectrum of housing needs
- A group of organizations that provide emergency assistance (rent and utilities) and an array of programs embedded in eviction court
  - Coordinating service delivery, influencing policy
- Identify resources and for whom those resources are available
- Develop front-end prioritization and resource guides
- Accelerated by the COVID-19 pandemic move to a systemic approach

#### Shared Strategy & Intervention Framework for Family Housing Stabilization in Columbus/Franklin County



#### Housing Stabilization Coalition - Results

- Improved trust between organizations
- Improved data coordination, including heat mapping and geocoding
- Monthly roundtables with landlords and property managers to share struggles and promote solutions
- Built relationships with municipal court resulting in changes in eviction trends
- Developed strong connection with the Community Shelter Board and Homeless Prevention Network



#### Columbus Urban League

- HUD Housing Counseling Agency
- Affiliate of the National Urban League
- Participates in the Housing Stability Coalition
- Provides rental housing counseling services, including counseling and mediation between landlords and tenants to resolve conflicts and prevent homelessness
- If a tenant takes the initiative to resolve rental issues in a timely manner, mediation will keep them in current housing approximately 70% of the time, according to CUL's experience

## Franklin County Eviction Snapshot



- Data as of October 13, 2020
- Eviction Complaints Filed: The initial step which a gets a court date set up
- Writs of Restitution Issued: Red tags issued, case went to judgment or a failed agreement/mediation that resulted in the landlord asking for the door to be tagged by the service bailiffs office which then gives the tenant 5-10 days to leave
- Request for Set Outs Processed: The final step after the door is tagged
- Note that for Q2 2020, court was not open during the majority of the quarter due to COVID-19
