- What app is Michigan State Housing Development Authority (MSHDA) using to text appt reminders?
 - o Veronica Depotty at MSHDA said that SMS Magic is a popular app.

- As agencies switch towards an online intake process, do clients have to physically sign disclosures and/or privacy policy? Or is it enough that agencies provide the information and review during counseling/education?
 - Way Finders does not get signed disclosures back every time, they upload a copy into the client's account and/or email a copy.
 - o HPN automatically sends a copy every time that they interact with a client and notes it in their file.
 - Affordable Homes of South Texas sends the disclosure via HelloSign and gets it back before the appointment.

- How should agencies collect the class rosters for online group education? How should we obtain a sign-in sheet when using a virtual platform, especially if some individuals called in on the telephone?
 - Way Finders uses Cognito Forms. Clients receive the link before the workshop via email. Another
 option is to have clients complete a small check in and submit electronically which saves time

- Is there any funding outside of the HUD grant to cover internet or phone services?
 - Check with community housing agencies, local community foundations, and non-profits.

 - Utilize IT dept resources and/or dial *67 before dialing phone number to mask. Way Finders has phone masking built into their telephone system.

 housing counseling requirements"
