



NDRC Overview

- The National Disaster Resilience Competition (NDRC) makes available nearly \$1 billion to communities that have been impacted by natural disasters **between 2011-2013**.
- The competition encourages communities to not only consider how they can recover from a past disaster but also how to avoid future disaster losses...**to be more Resilient**
- Applicants need to link or “tie-back” their proposals to the disaster from which they are recovering, as well as demonstrate how they are reducing future risks and advancing broader community development goals within in their target geographic area(s).

Appendix J: Crosswalk Checklist

- Use Appendix J: “CDBG-RDR” Crosswalk Checklist to ensure that NDRC Application is complete
 - NOTE: Pending Technical Correction will update this checklist to also include the MID-URN Summary Checklist, which must be completed and submitted for each target area in an application.




Exhibit A: Executive Summary

- Summarize application briefly and specifically
- Suggested 2 pages maximum




Exhibit B: Phase 1 Threshold Narrative

NOFA Section III.C.3

Exhibit B – Threshold Narrative Includes:

- General Section – (Some may not need responses.)
- Eligible Applicant – Identify which eligible Applicant is submitting application (see list of 67 eligible applicants in the NOFA)
- Eligible County – Area primarily benefiting from the CDBG-NDR funding to be requested must be a county listed in NDRC NOFA Appendix B. State county name.
- Most Impacted and Distressed (MID) Target Area – See prior webinars on MID. NOTE: Three (3) additional pages are allowed for each project (target) area after the first if application includes multiple, separate areas.



Exhibit B: Phase 1 Threshold Narrative

NOFA Section III.C.3

Exhibit B – Threshold Narrative Includes (cont.):

- Eligible Activity – Addressed by CDBG-NDR Applicant certification in Phase 1
- Proposal Incorporates Resilience – Demonstrate that each proposed CDBG-NDR activity (including any planning activity) can reasonably be expected to improve the MID-URN areas resilience to current and future threat(s) and hazard(s)
- National Objective – Addressed by CDBG-NDR Applicant certification in Phase 1
- Overall Benefit - Addressed by CDBG-NDR Applicant certification in Phase 1




Exhibit B: Phase 1 Threshold Narrative

NOFA Section III.C.3

Exhibit B – Threshold Narrative Includes (cont.):

- Tie-back – Application must establish a tie-back to a Qualified Disaster for each proposed CDBG-NDR assisted activity. In Phase 1, MID-URN target area must relate to Soundness of Approach response.
- Certifications – CDBG-NDR Applicant Certifications must be signed by the Applicant and submitted (see NDRC NOFA Appendix F)



Exhibits C-G: Phase 1 Factor Narratives

NOFA Section V.A.1

Exhibit C: Factor 1 – Capacity

Provide a narrative response to the capacity factor, including:

- General Management
- Technical Capacity
- Community Engagement
- Regional Capacity

Exhibit D: Factor 2 – Need/Extent of the Problem

Provide a narrative response to the Need Factor, including:

- Unmet Needs
- Most Impacted and Distressed
- Response to questions

Note: MID-URN Threshold response should not be restated here, rather cross-referenced as necessary.



Exhibits C-G: Phase 1 Factor Narratives

NOFA Section V.A.1

Exhibit E – Soundness of Approach

Provide a narrative response to the Soundness of Approach Factor, including:

- Stakeholder Consultation
- Idea/Concept

Exhibit F – Leverage and Outcomes

Provide a narrative response to the Leverage and Outcomes Factor, including:

- Outcomes
- Leverage narrative
- Leverage Commitments

Exhibit G: Factor 5 – Long –Term Commitment

Provide a narrative response to the Long-Term Commitment Factor
