


Anticipated Changes for 2023 HIC and PIT Count

The only anticipated change is an expansion to the age categories for the PIT count.

Current Response Options	
1) Under 18	

2) 18-24

3) 25 and Older





Is 2023 a Required Count Year?

- The regulatory requirement for the PIT count is to conduct a full count – sheltered and unsheltered - every other year.
- If your CoC conducted a full count in 2022 it is not required to conduct a full count in 2023.
- Most CoCs choose to conduct a full count every year.
- HUD strongly encourages CoCs to conduct a full count each year.






VISTA expands the ability of organizations to do their work. Rather than providing services directly to individuals and communities, VISTAs strengthen and support organizations by building infrastructure, expanding community partnerships, securing longterm resources.

AmeriCorps VISTA and the PIT Count

During the PIT Count...

- Develop and implement PIT count timeline
- Develop PIT count surveys
- Write training curriculum
- Develop press kits and press releases
- Fundraise or gather donations for incentives
- Develop PIT count taskforce/working group
- Design brochures, posters, social media posts for volunteer recruitment
- Analyze PIT count data and develop PIT count reports



AmeriCorps VISTA and the PIT Count

Before/After PIT Count...

- Develop community partnerships
- Secure media partners
- Develop volunteer management system and procedural guide
- Develop volunteer handbook and training manual
- Research other community methodologies/practices
- Develop supplemental questions for future PIT count surveys
- Create mechanism for project evaluation
- Complete deeper data dives and recommendations



MLK National Day of Service & the PIT Count

AmeriCorps administers the <u>MLK National Day of Service</u>. In the past we've cross-promoted volunteering for the PIT count with the <u>MLK National Day</u> <u>of Service</u>, since they both occur in January.

 Consider using the MLK Day of Service as a way to also market the PIT count. There are individuals across the country looking for ways to volunteer is support of it and joining a PIT count may be a great way to do so.



AmeriCorps VISTA Days of Service

AmeriCorps VISTA sponsors play an important role in supporting Days of Service by actively encouraging members to host or participate in Days of Service events.

 In some cases, members may be involved in organizing Days of Service events that engage other volunteers. In others, they may serve as volunteers alongside community members at events that are organized by other groups or in roles distinct from their VISTA projects. We encourage our National Service participants and partners to make MLK, Jr. Day a "Day On, Not a Day Off" and serve the community to bring Dr. King's vision closer to reality. Members can participate in community events or can coordinate events of their own.
