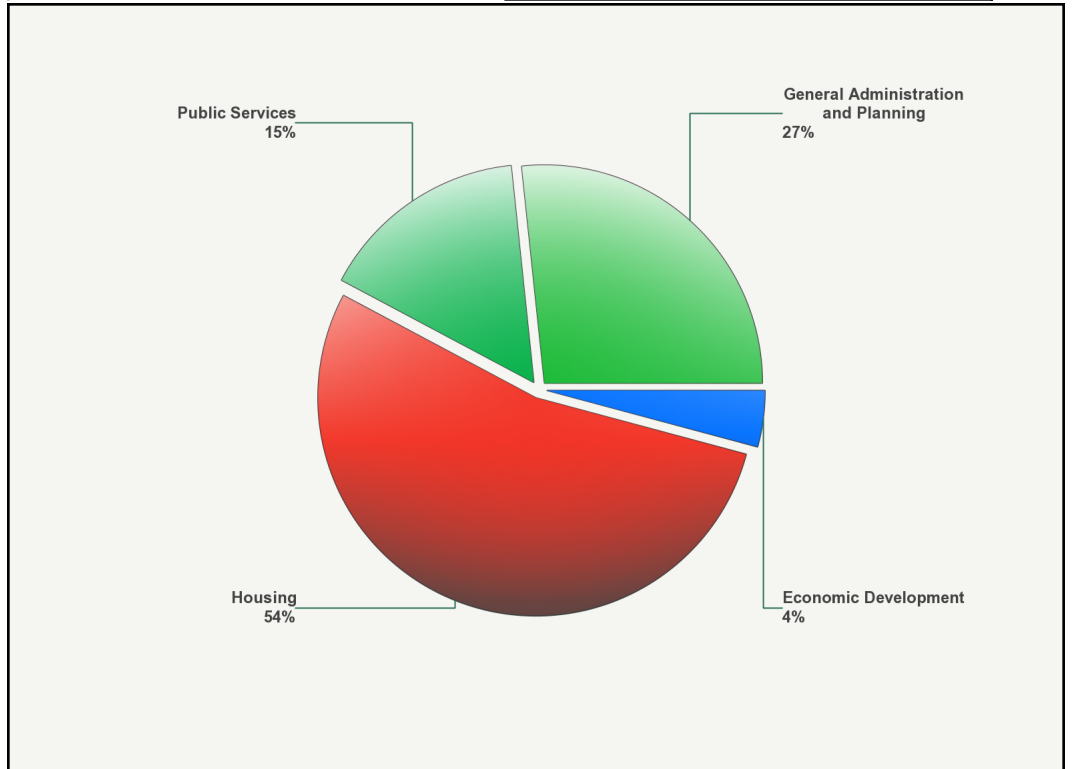

Timeliness Ratio - unexpended funds as percent of 2017 allocation 2.07

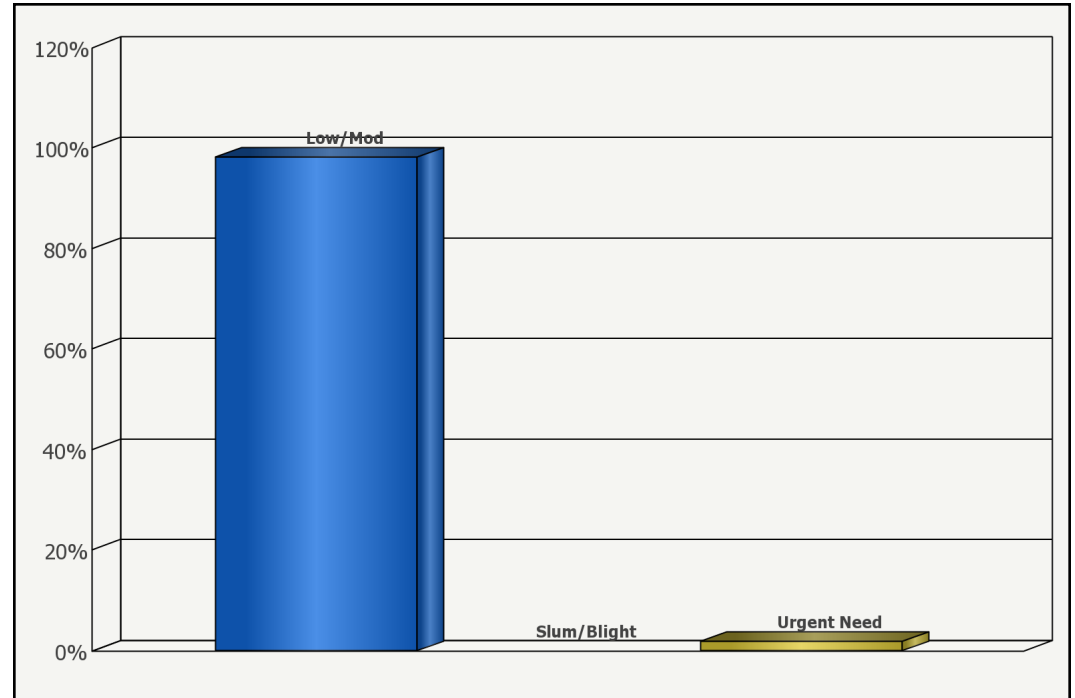
Expenditures by Type of Activity (%) Expenditures by Type of Activity (\$)

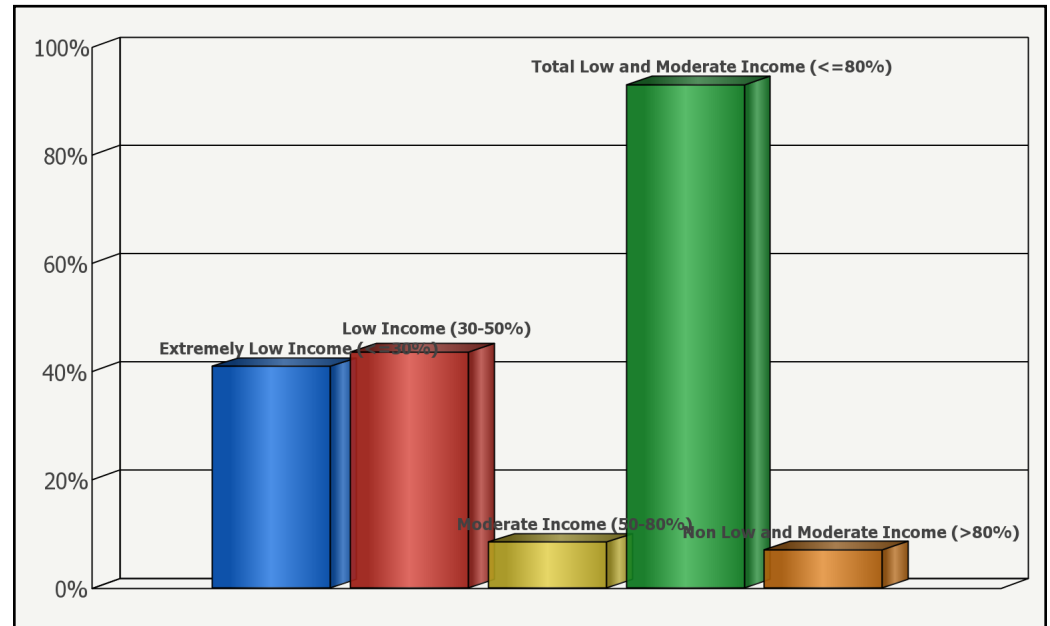

5 This number represents the total number of persons/households for whom services/facilities were available for [in many cases] multiple area benefit activities as reported by grantees. If one or more activities had the same or overlapping service areas, the number of persons served by each activity was used to calculate the total number served; e.g., if two activities providing different services had the same service area, the number of persons in the service area would be counted twice; once for each activity.
