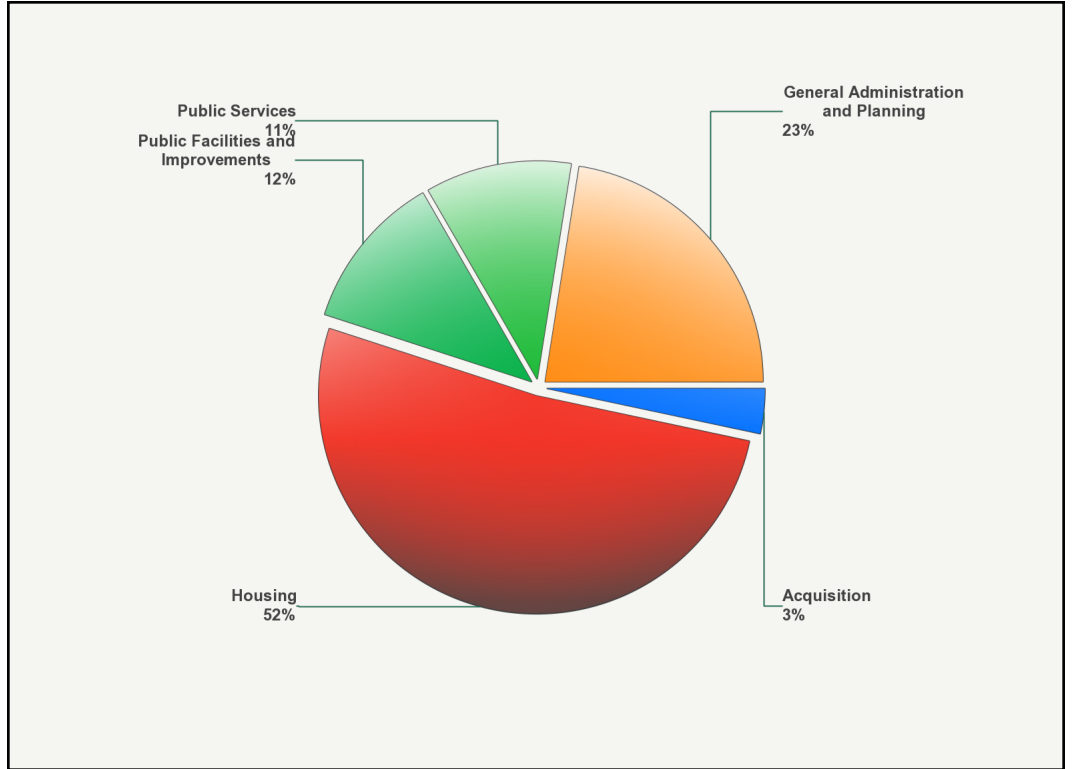

Timeliness Ratio - unexpended funds as percent of 2018 allocation 5.63

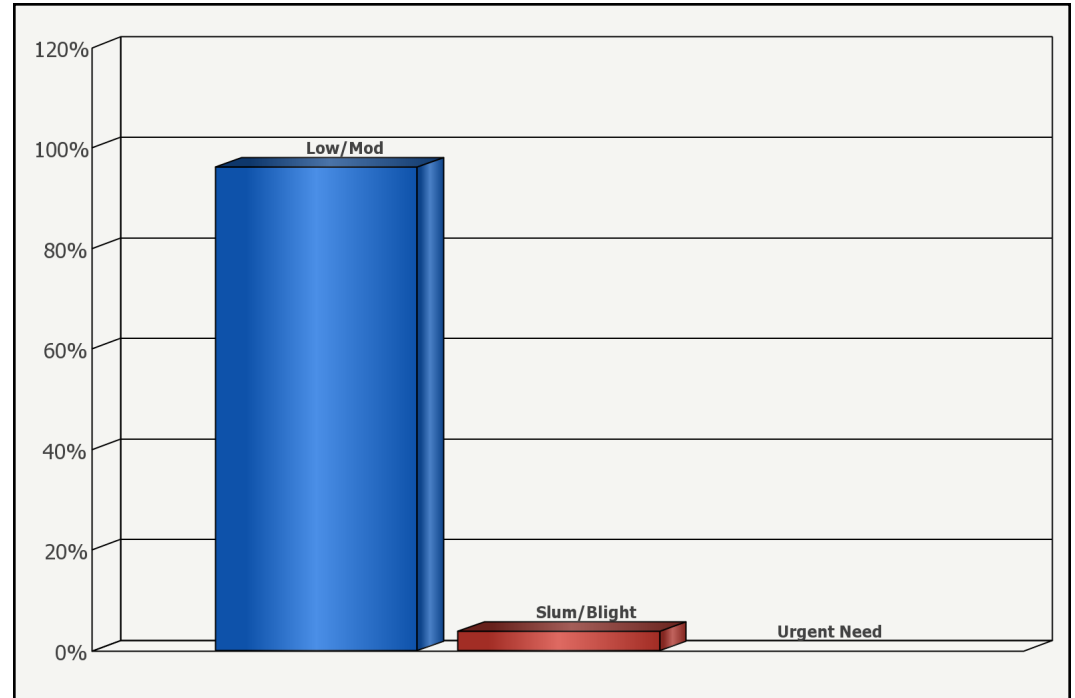
**Expenditures by Type of Activity (%) Expenditures by Type of Activity (\$)**

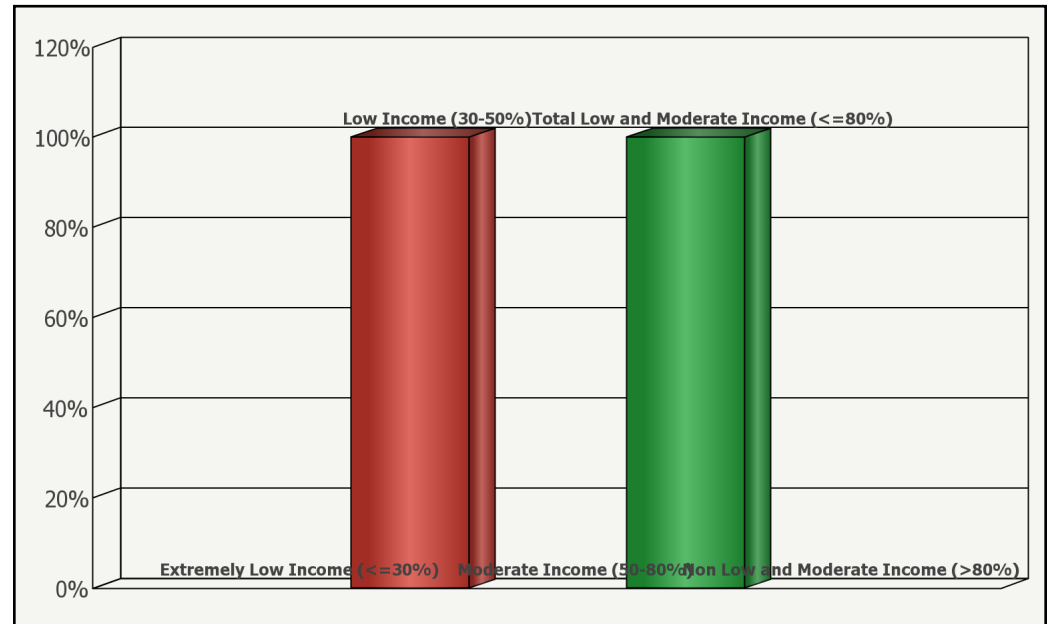
