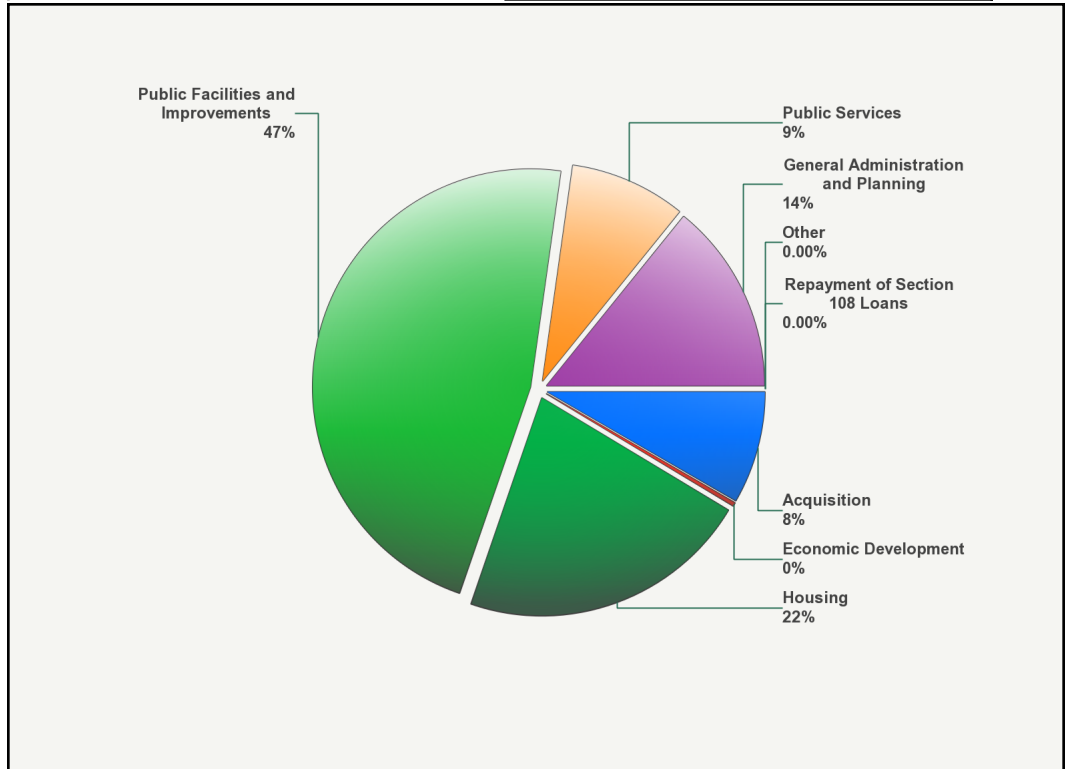

Timeliness Ratio - unexpended funds as percent of 2020 allocation 1.31

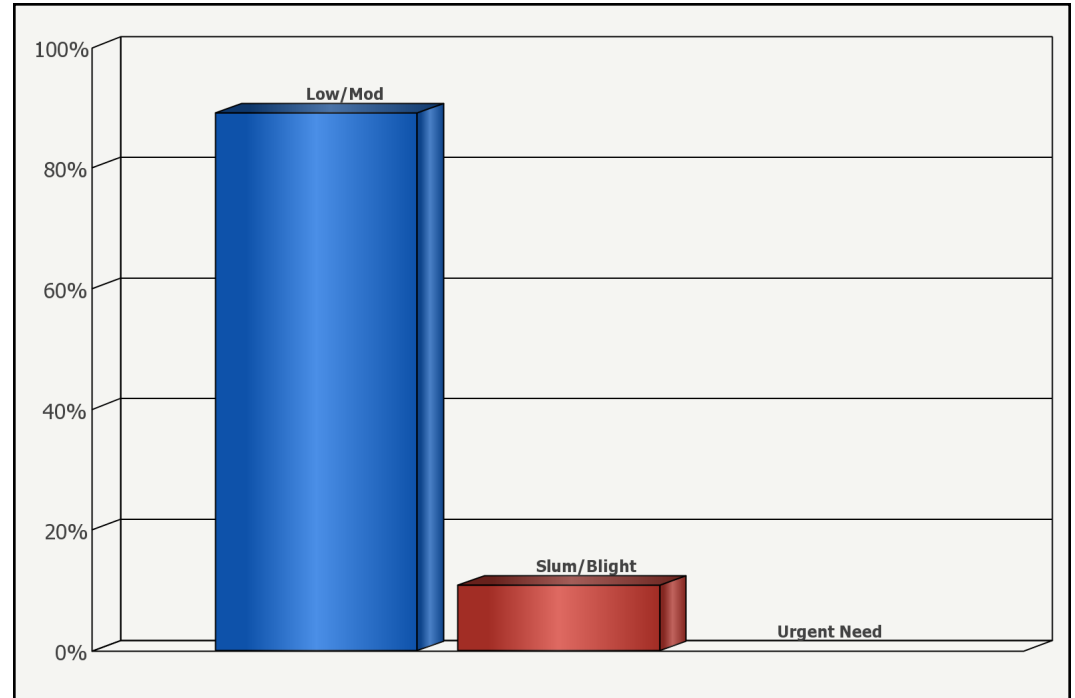
Expenditures by Type of Activity (%) Expenditures by Type of Activity (\$)

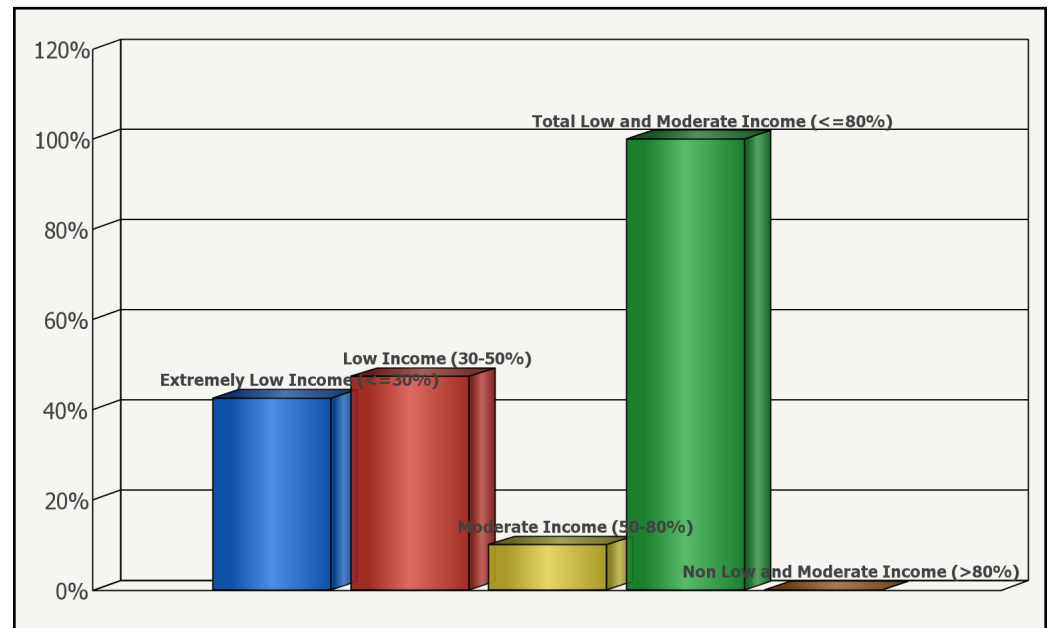
