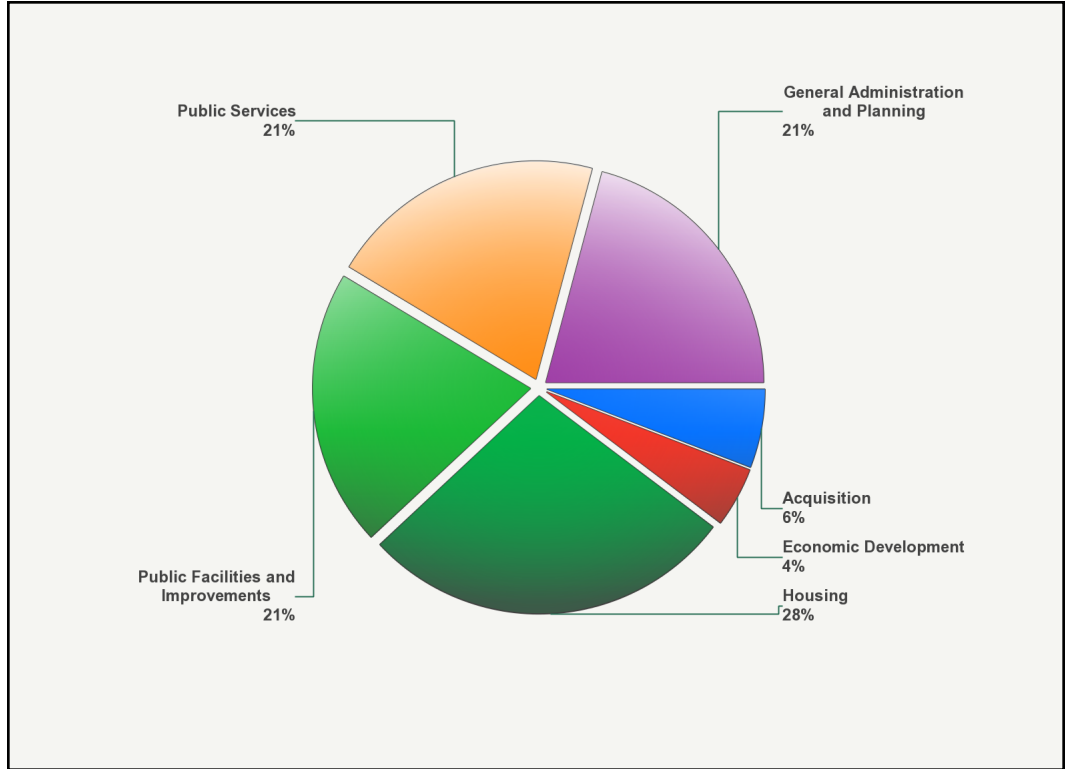

Timeliness Ratio - unexpended funds as percent of 2017 allocation 0.93

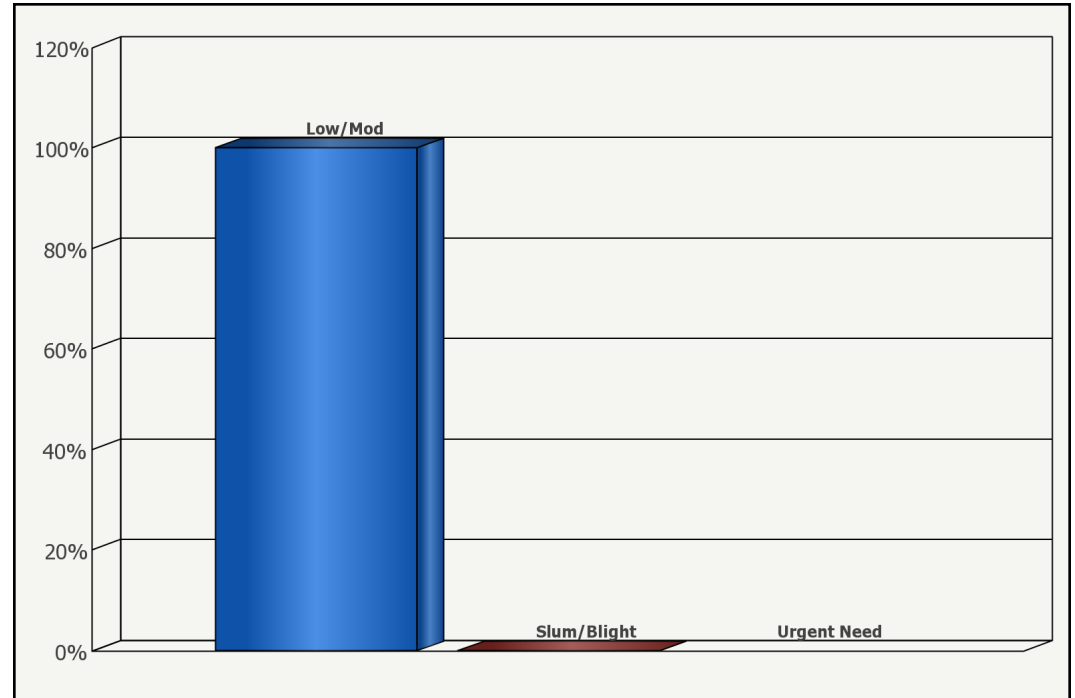
**Expenditures by Type of Activity (%) Expenditures by Type of Activity (\$)**

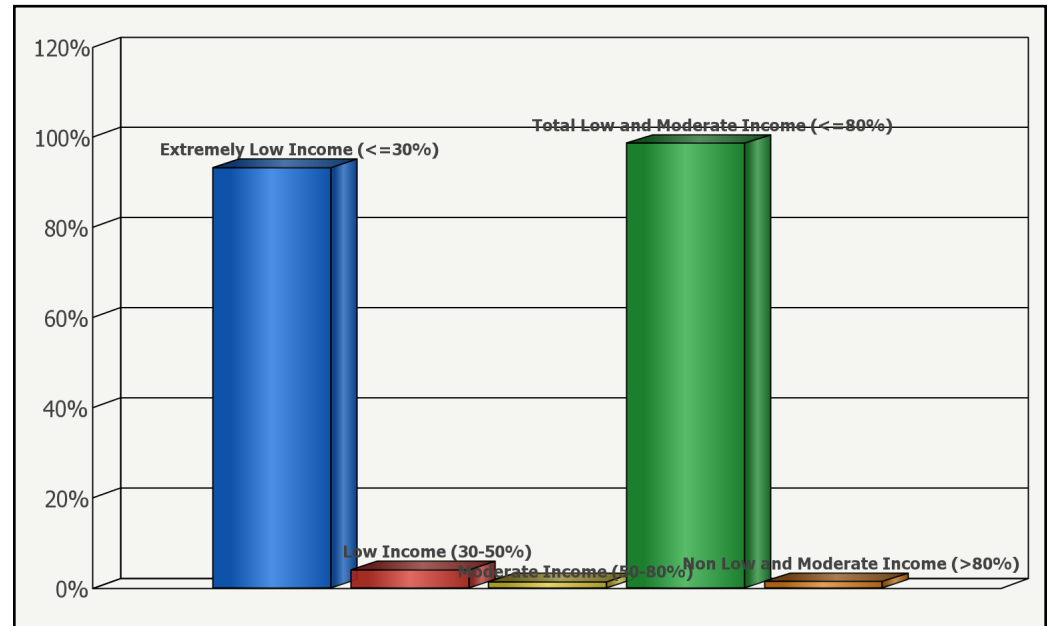
