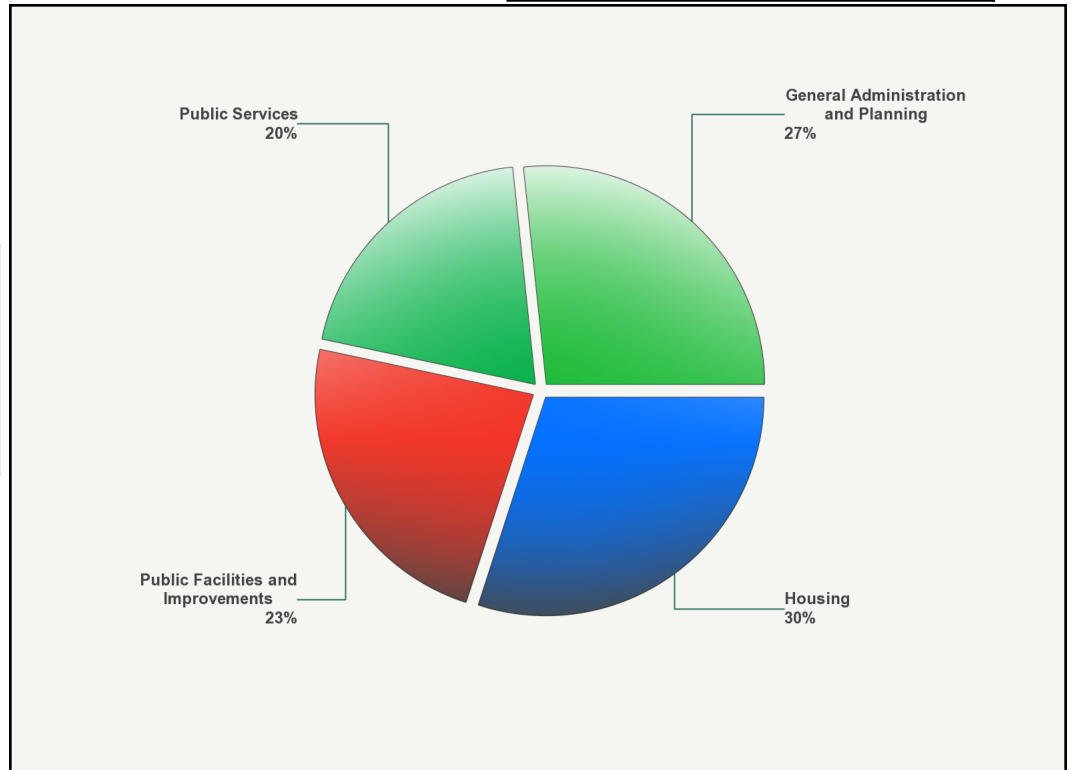

Timeliness Ratio - unexpended funds as percent of 2018 allocation 1.34

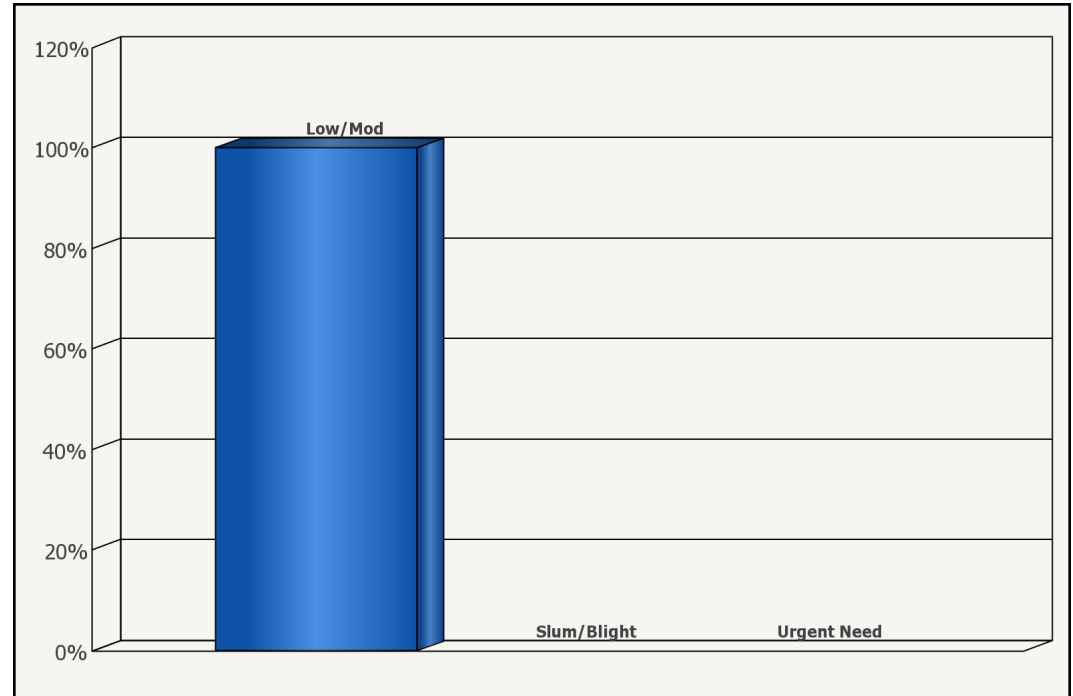
## Expenditures by Type of Activity (%) Expenditures by Type of Activity (\$)

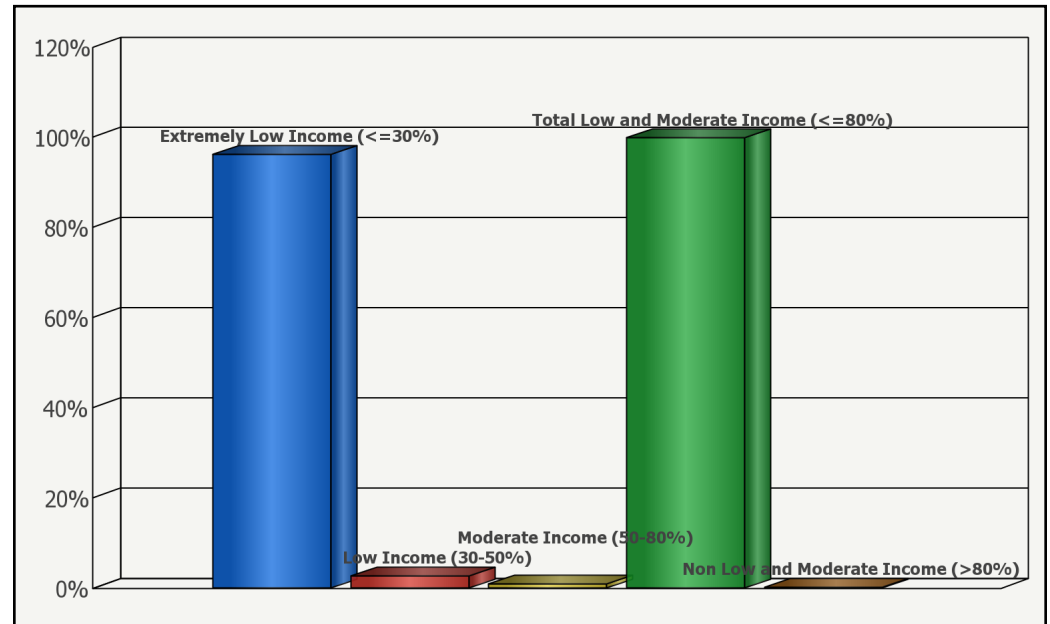
