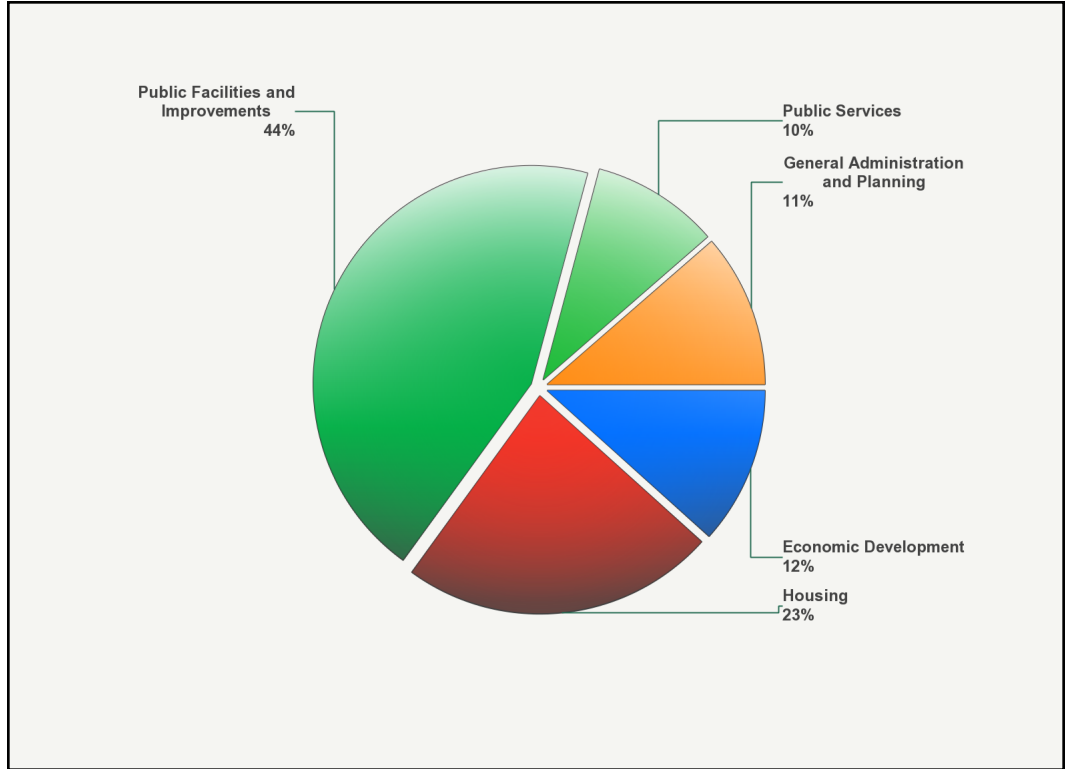

Timeliness Ratio - unexpended funds as percent of 2018 allocation 1.21

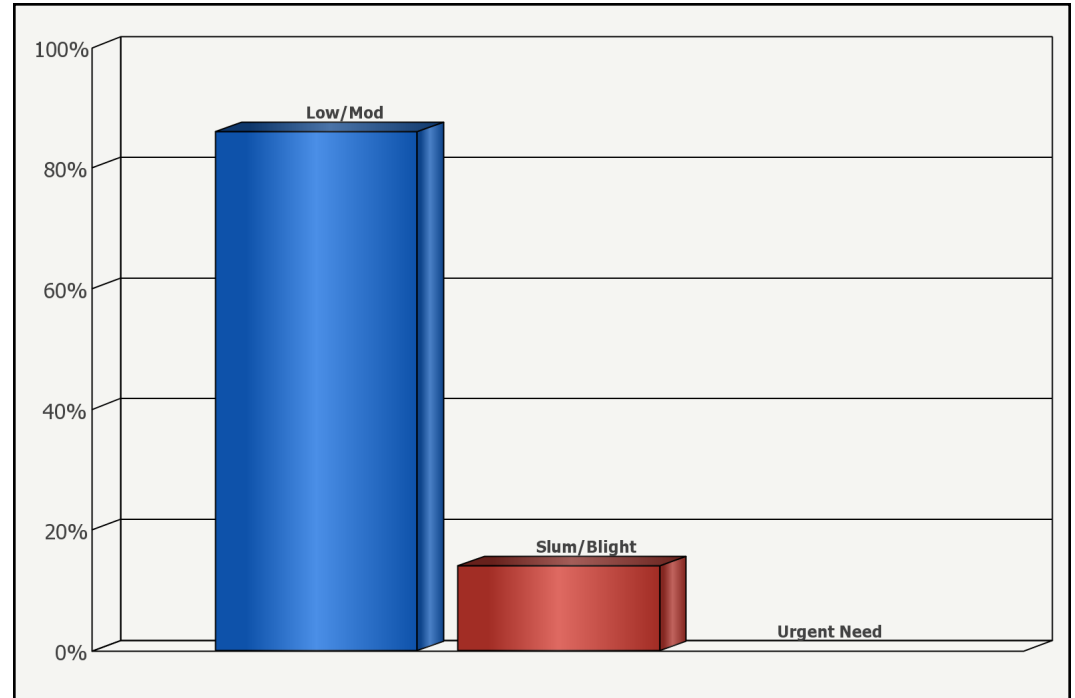

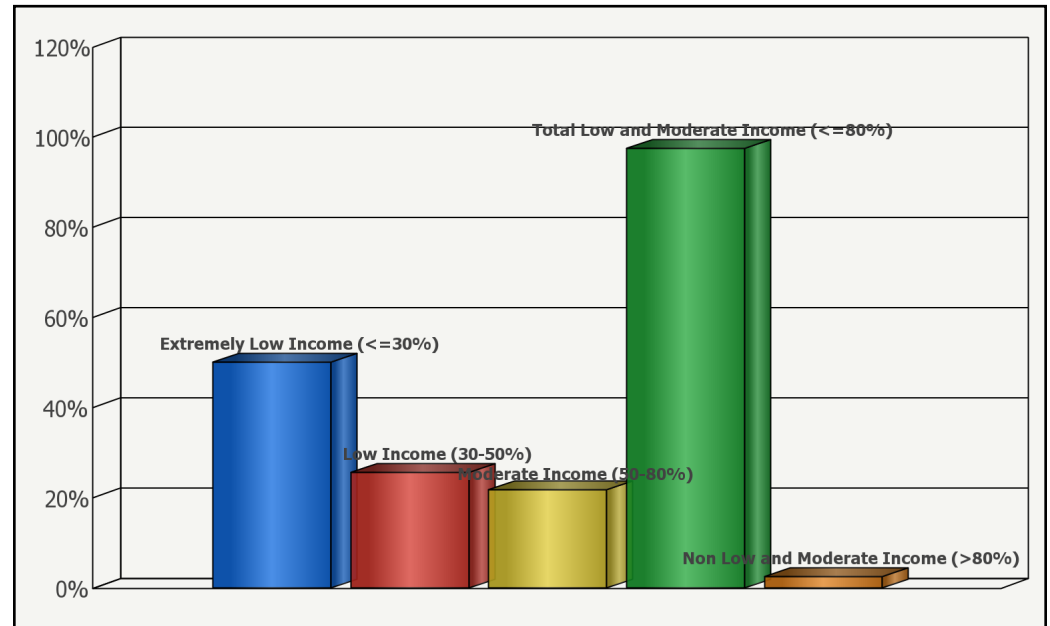
