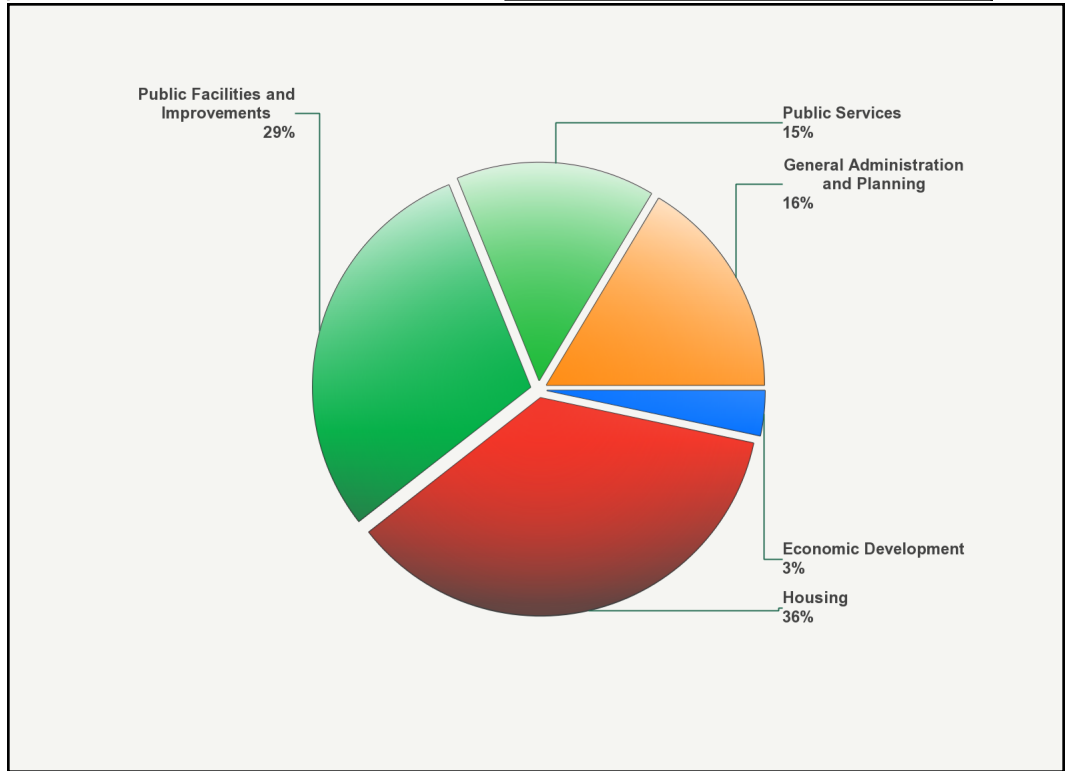

Timeliness Ratio - unexpended funds as percent of 2017 allocation 1.16

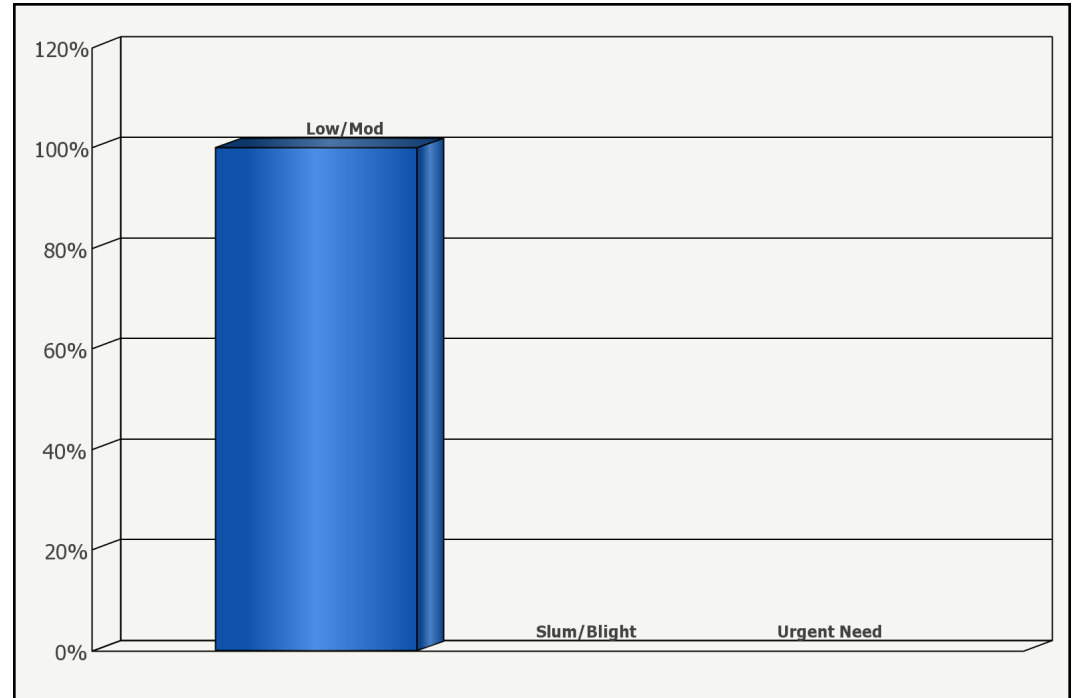

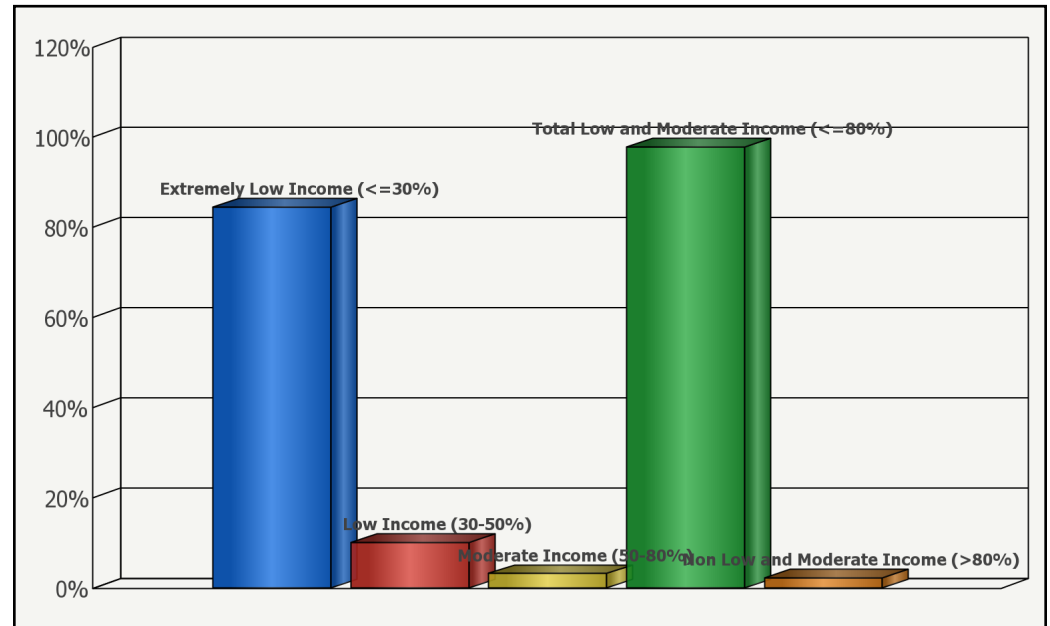
