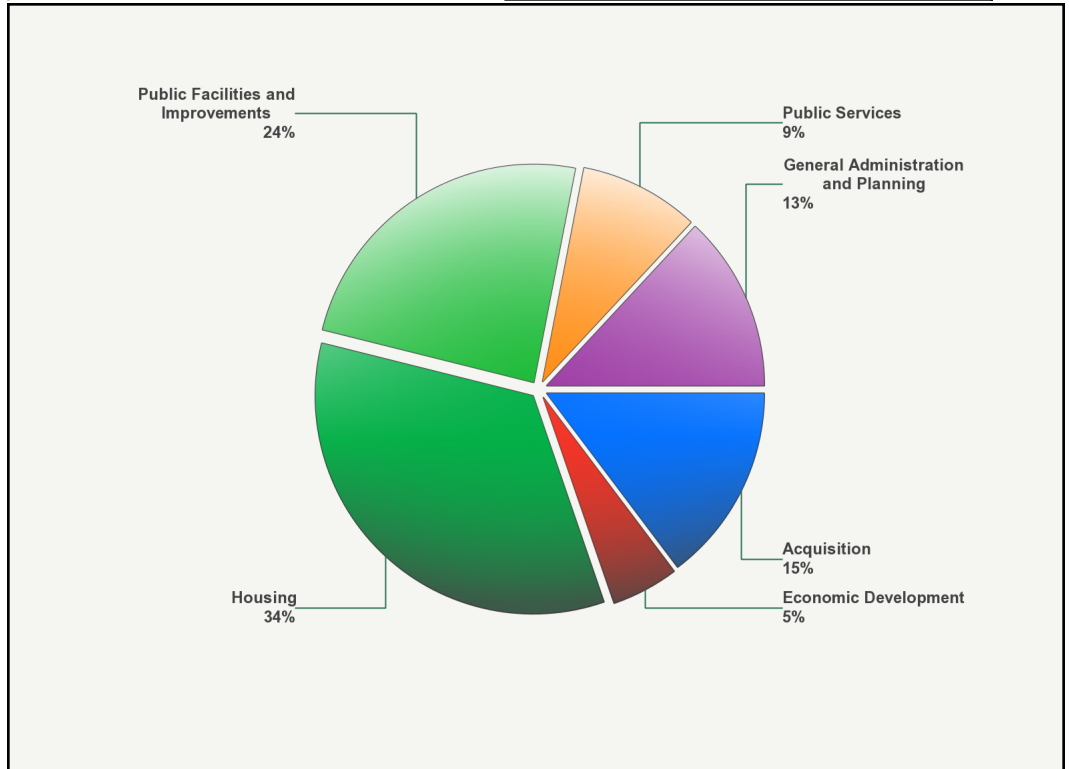

Timeliness Ratio - unexpended funds as percent of 2018 allocation 0.57

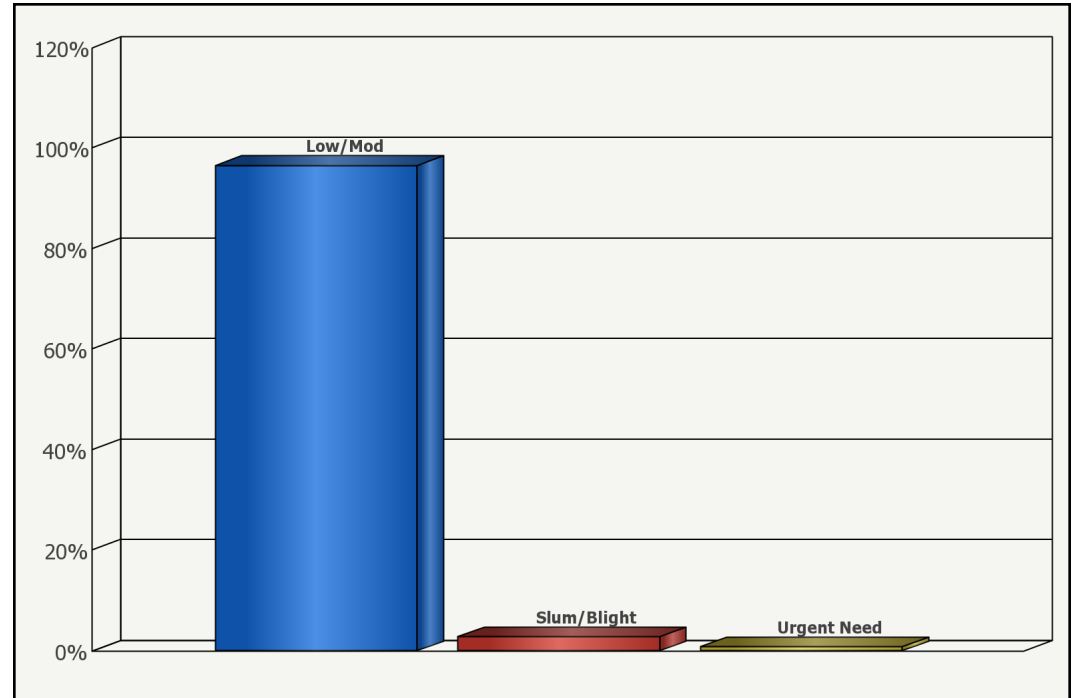

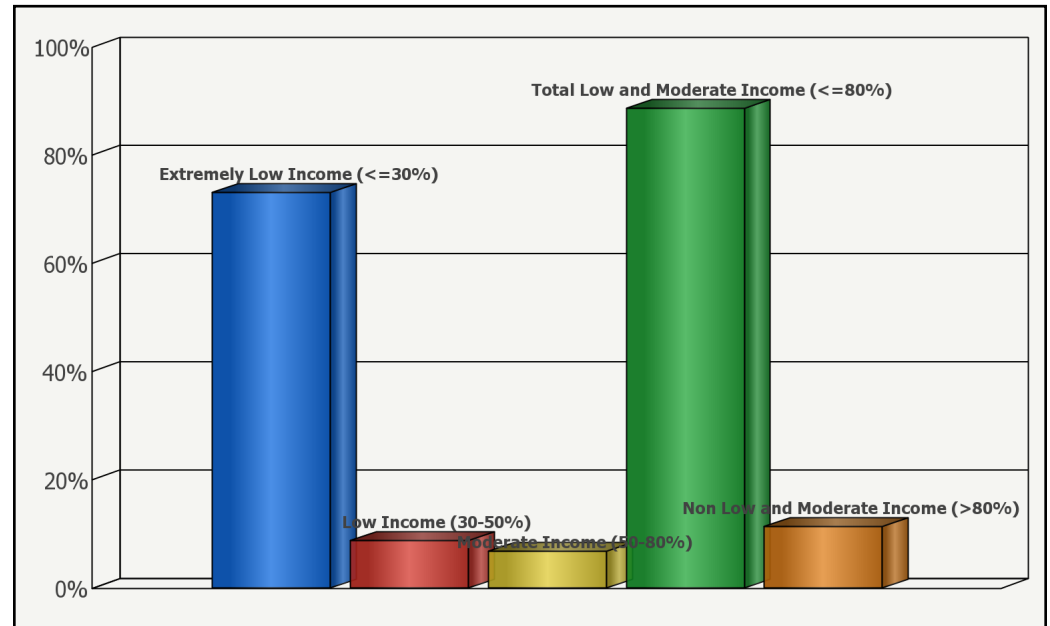

5 This number represents the total number of persons/households for whom services/facilities were available for [in many cases] multiple area benefit activities as reported by grantees.
