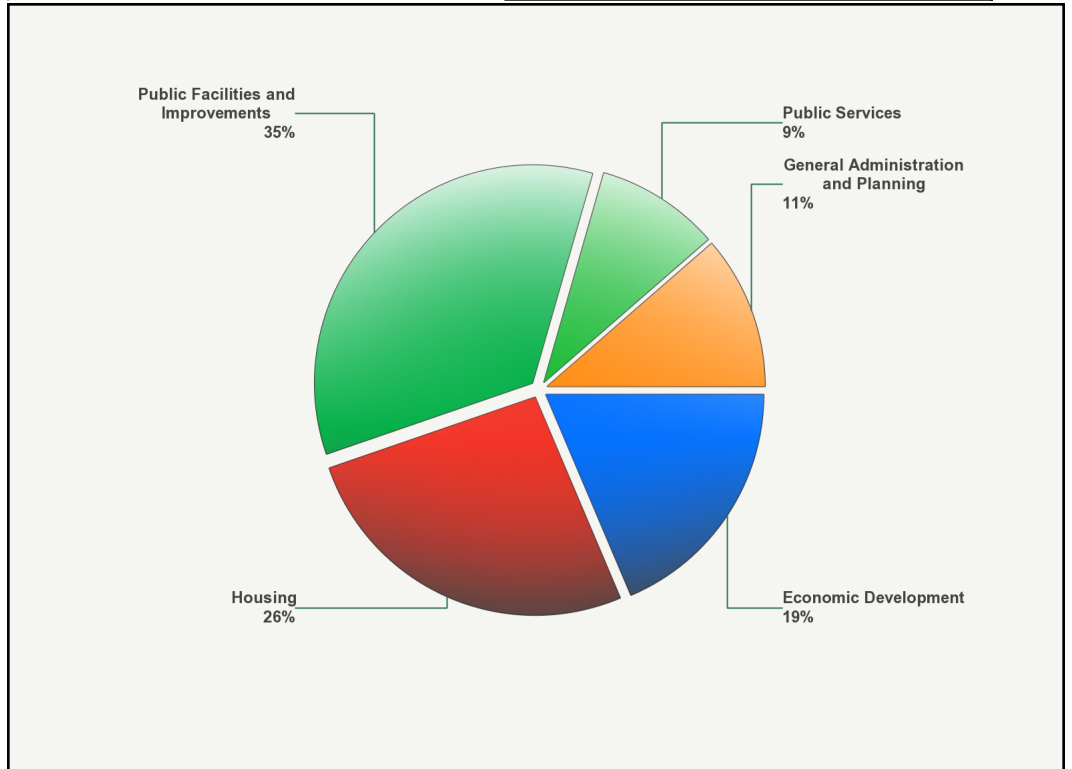

Timeliness Ratio - unexpended funds as percent of 2016 allocation 0.39

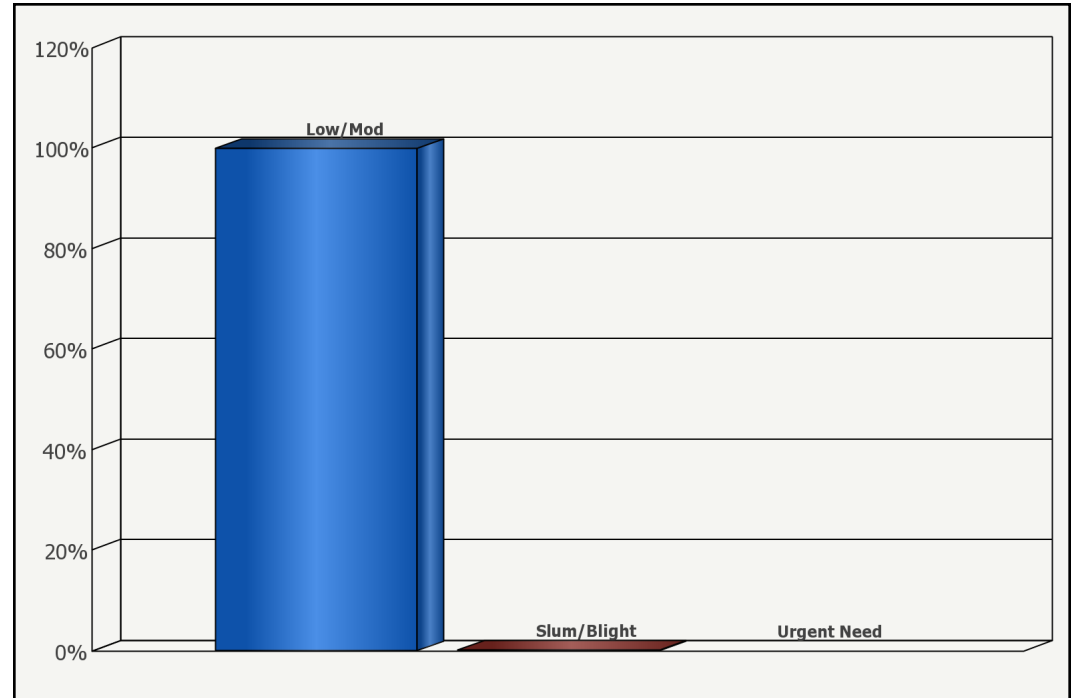
Expenditures by Type of Activity (%) Expenditures by Type of Activity (\$)

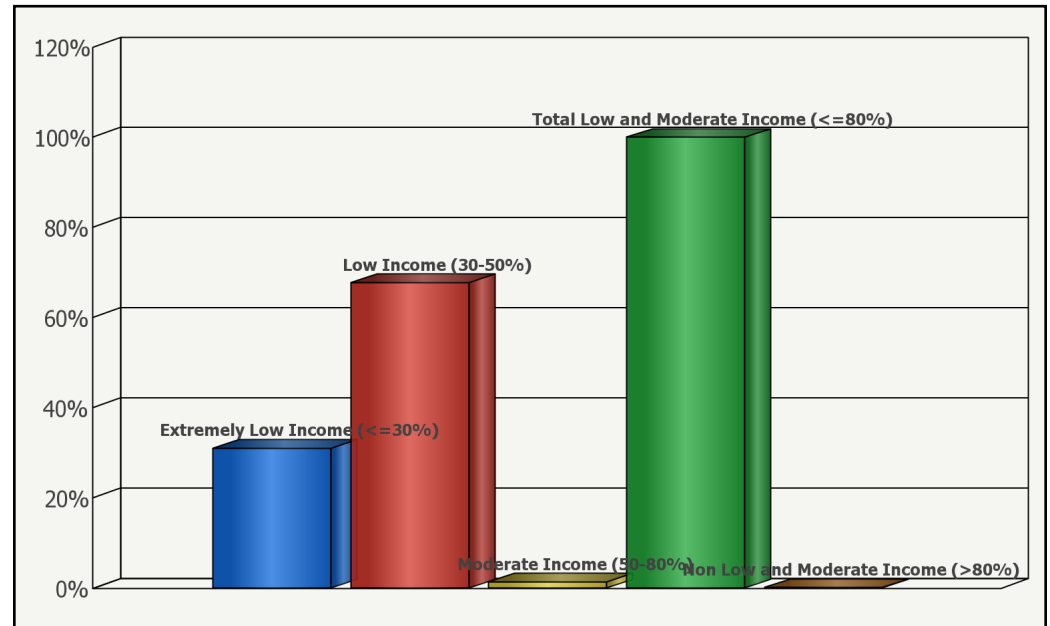

5 This number represents the total number of persons/households for whom services/facilities were available for [in many cases] multiple area benefit activities as reported by grantees.
