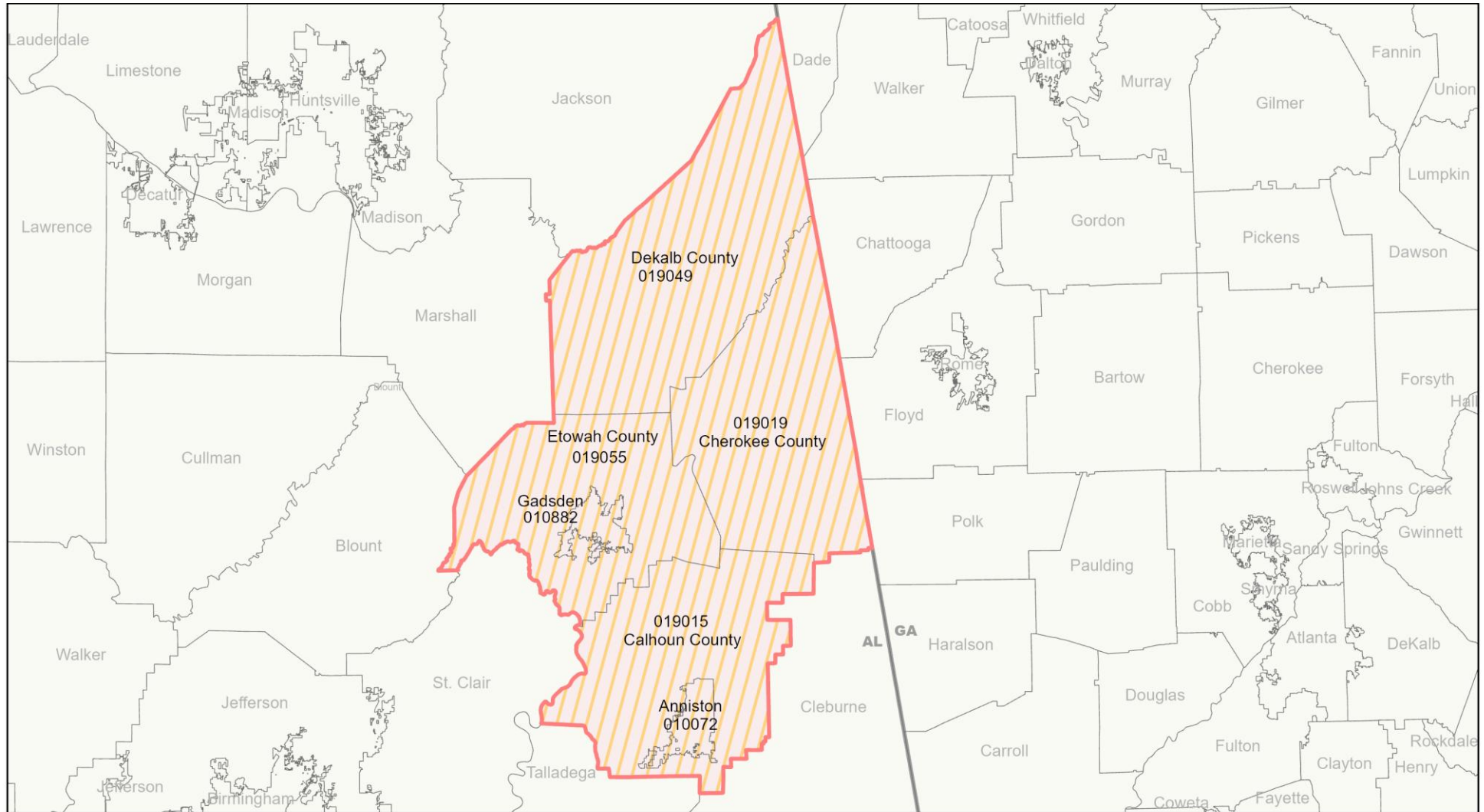

 2021 CoC Boundary  2020 CoC Boundary



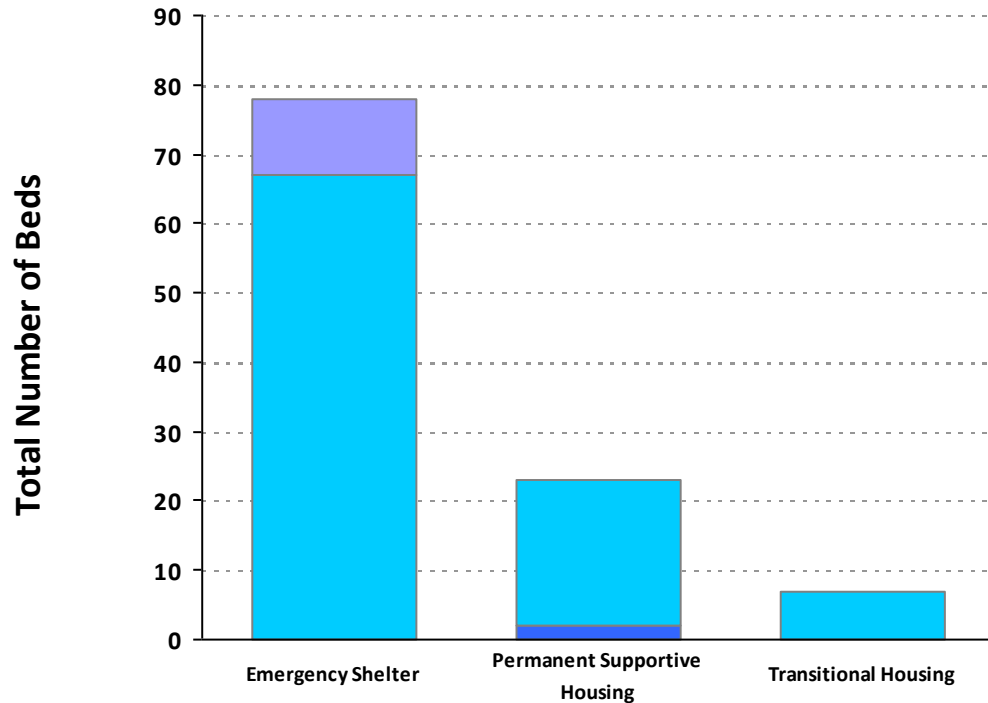

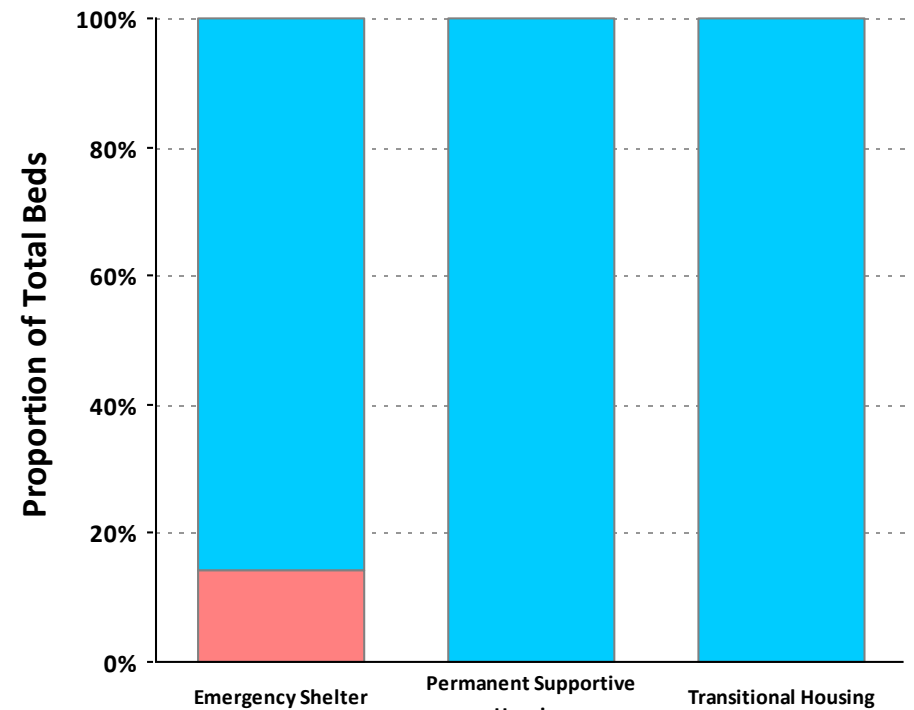

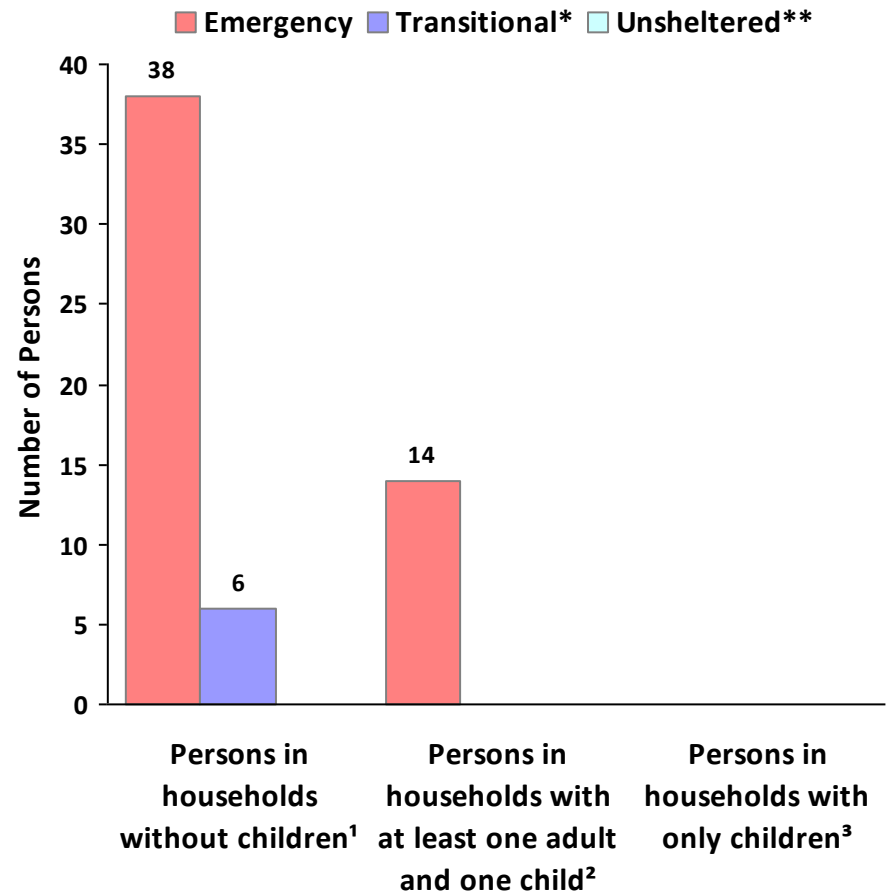

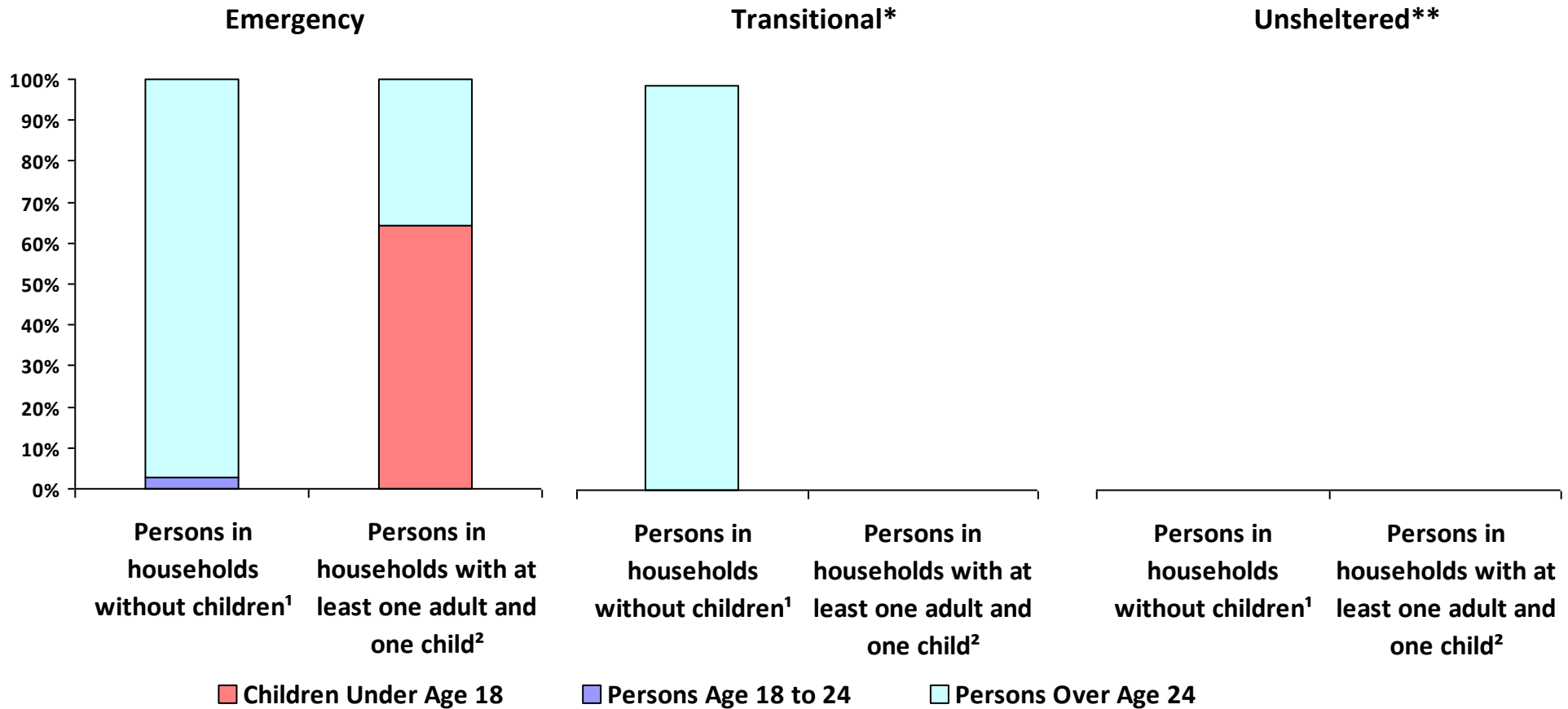

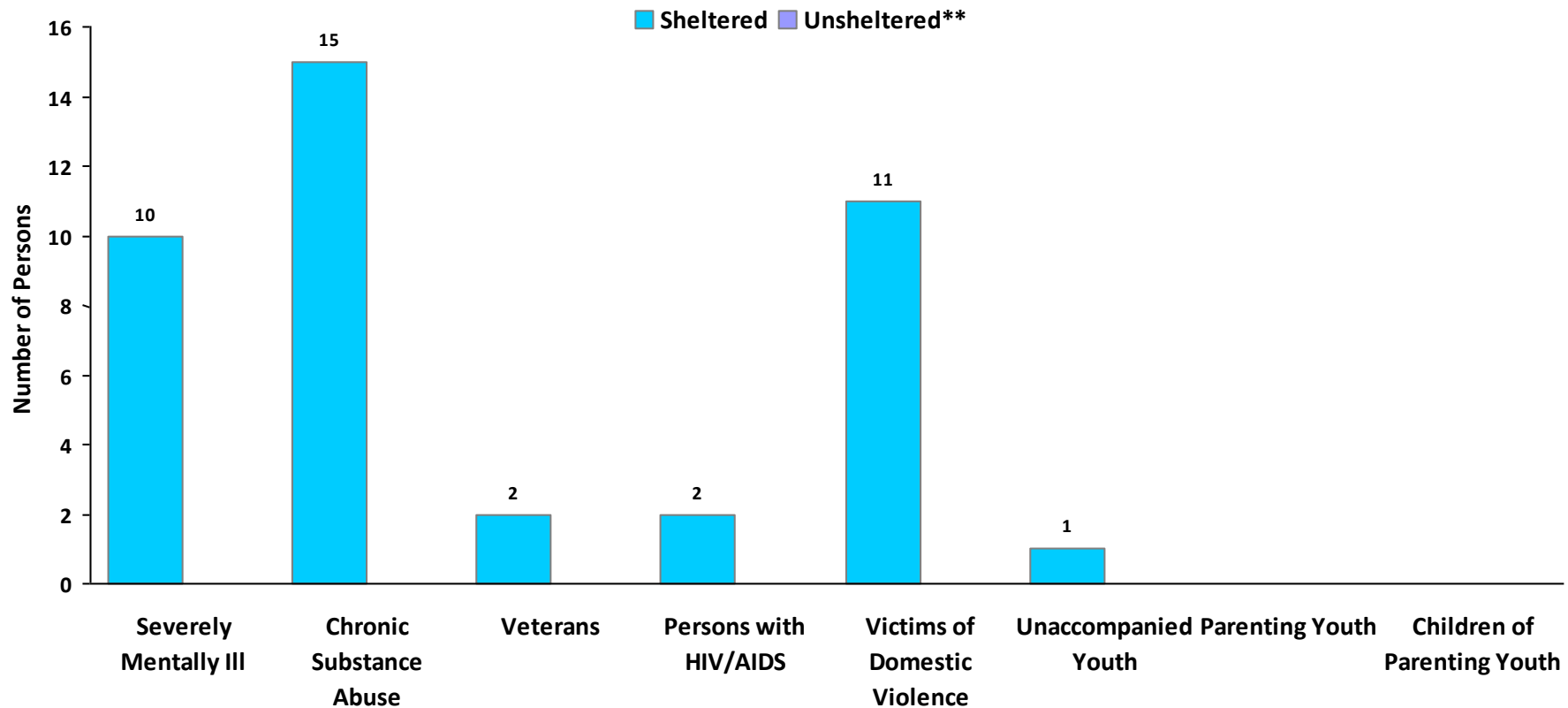
