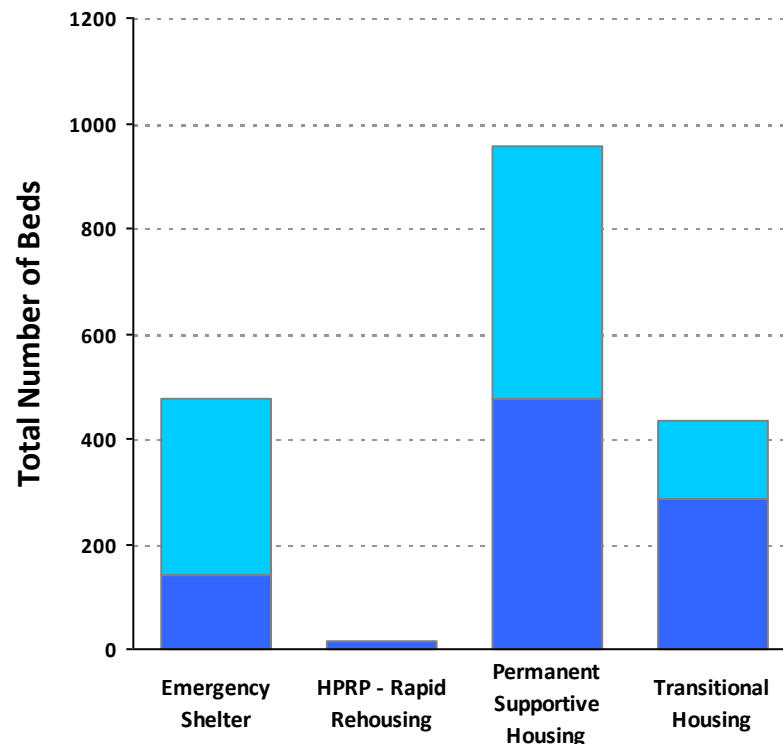

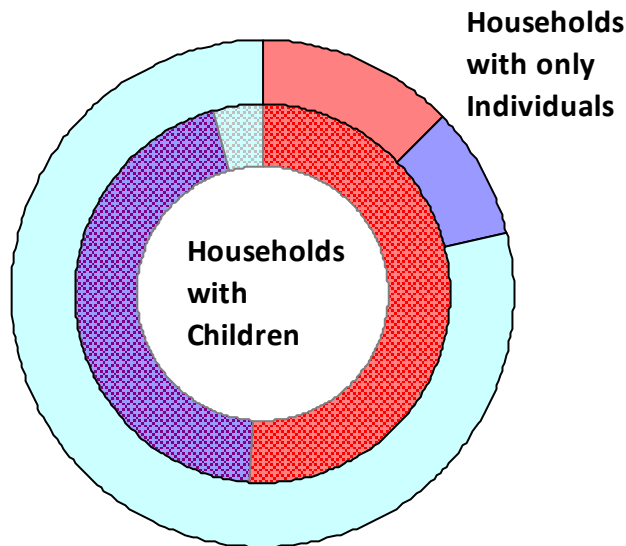

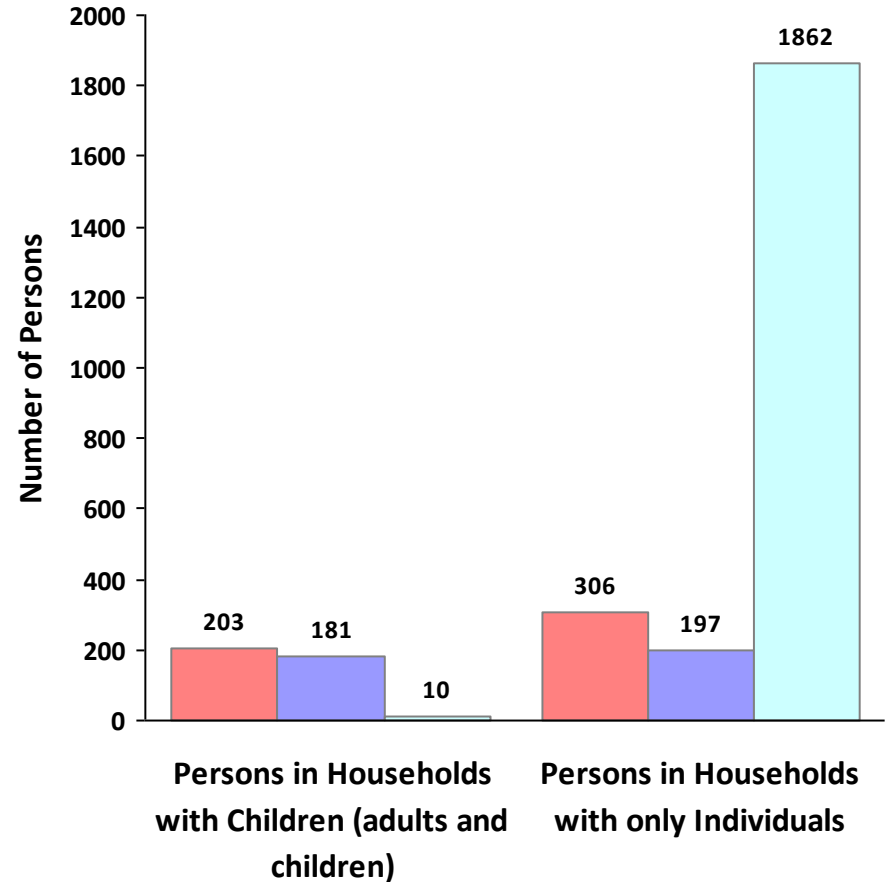
2010 Point in Time Count Summarized by Household Type
