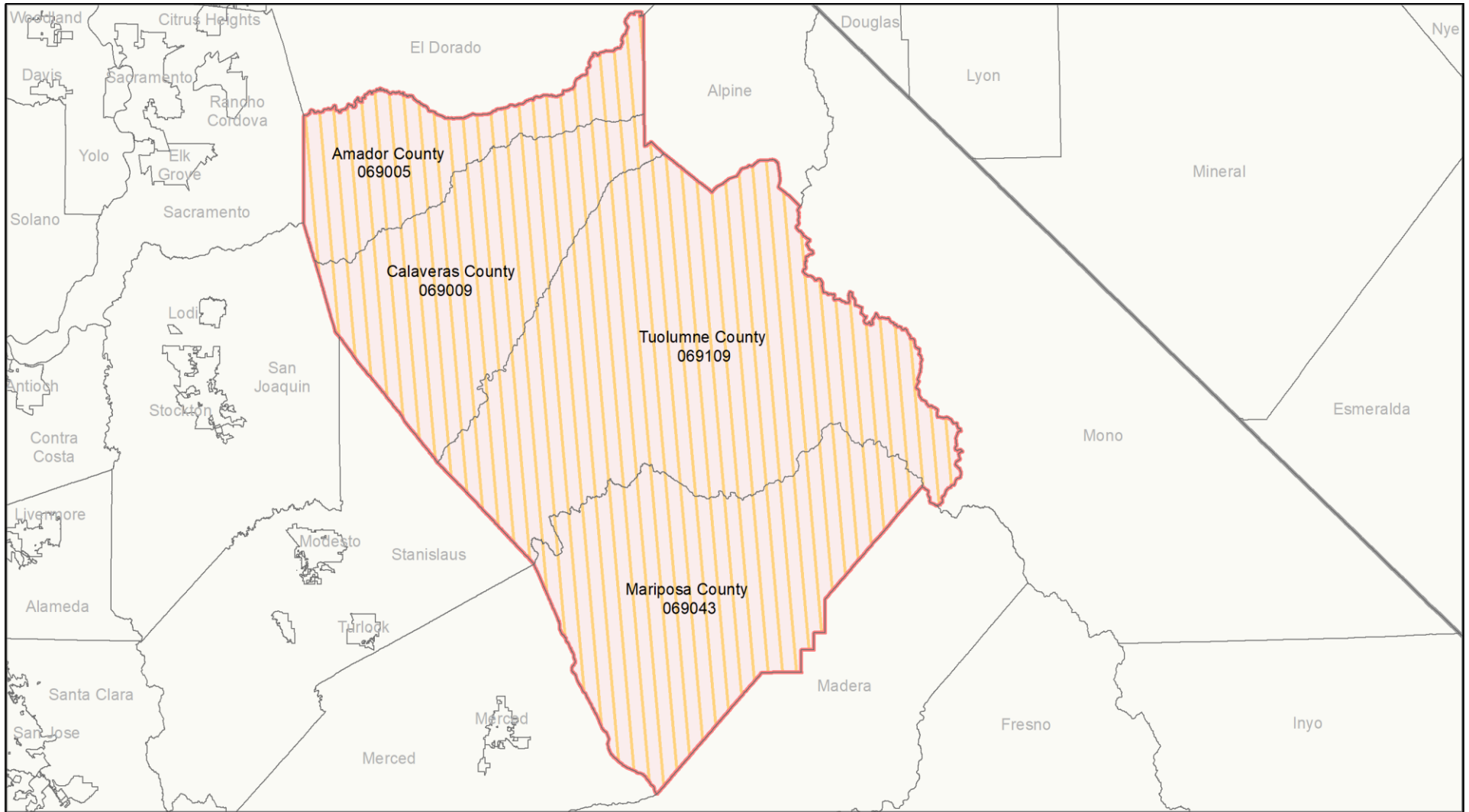

 2020 CoC Boundary  2019 CoC Boundary



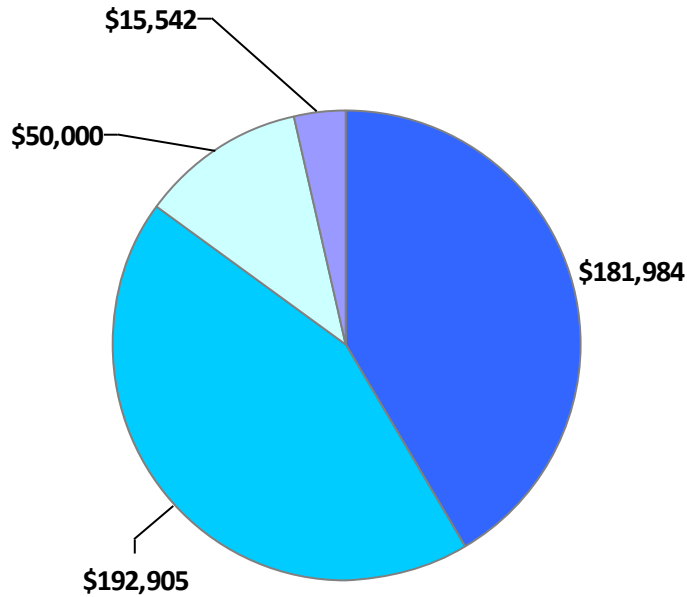

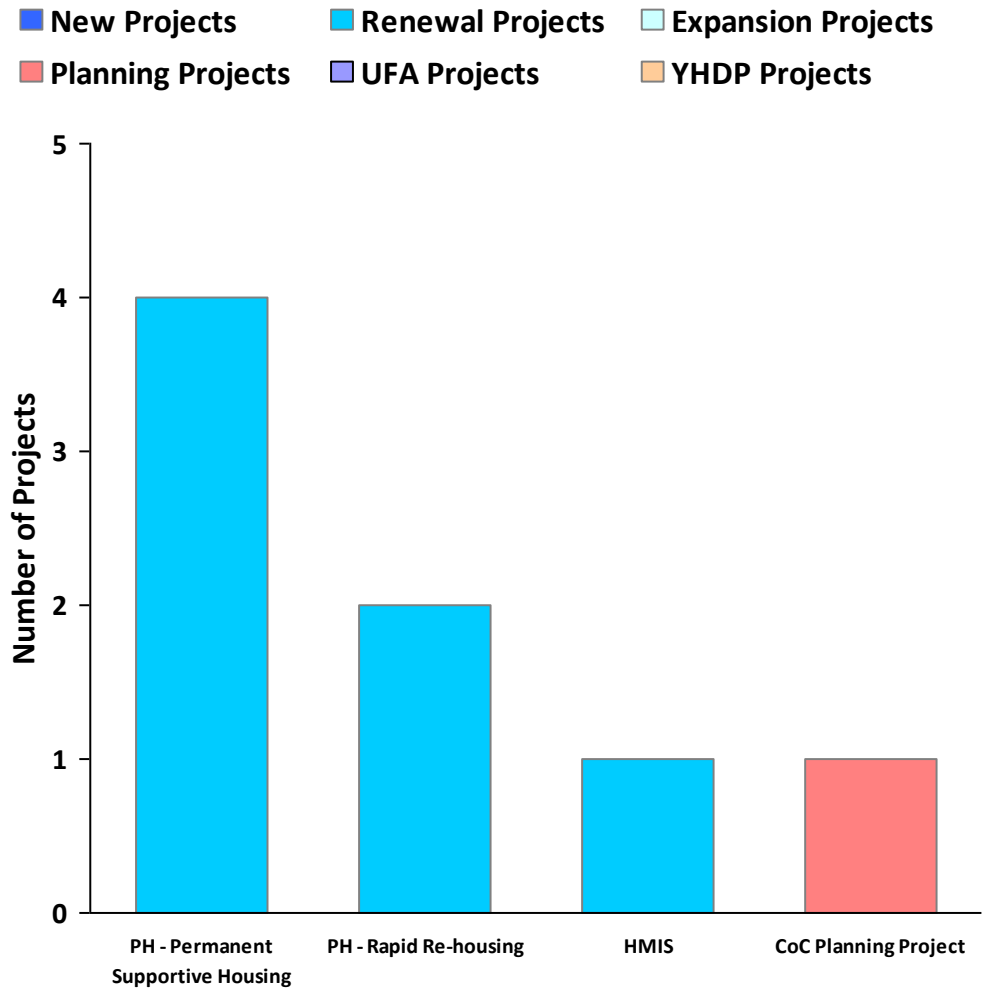

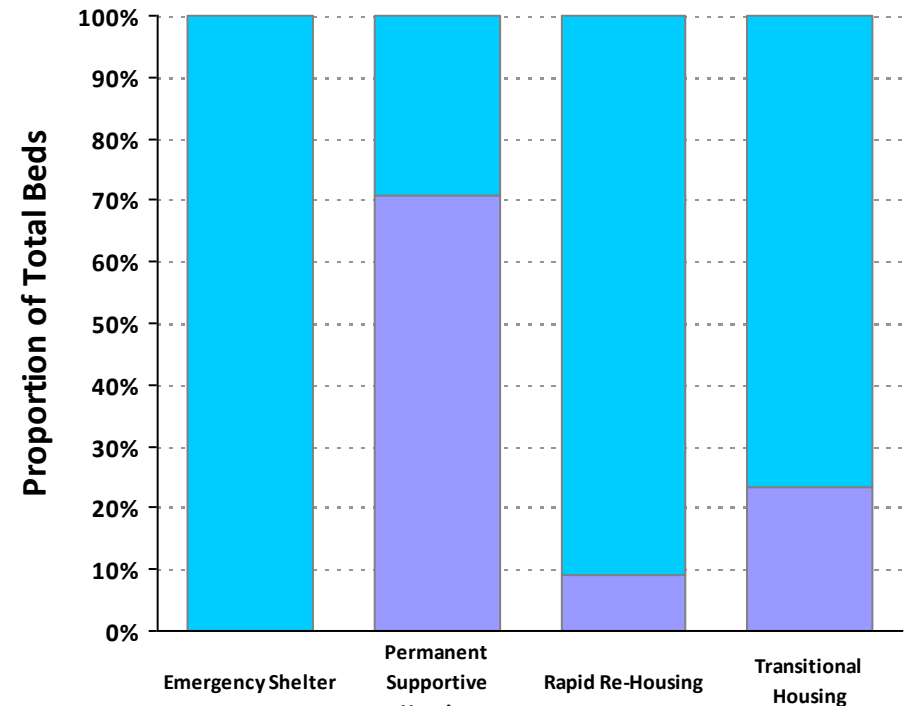

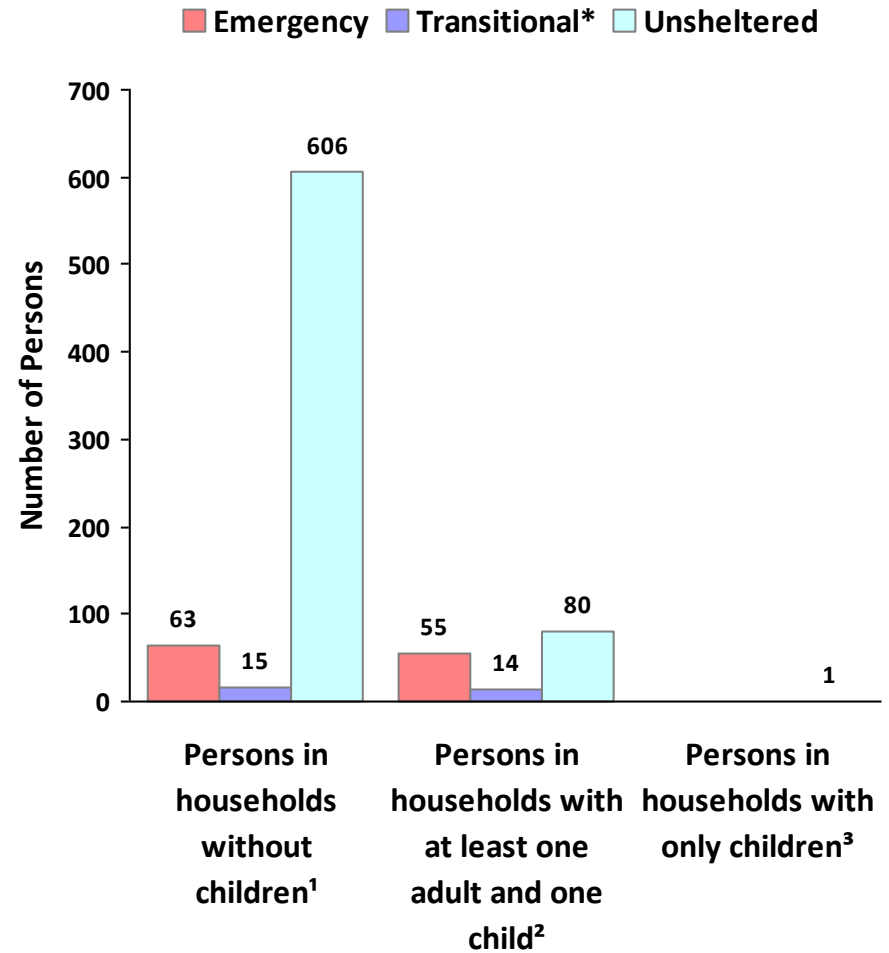

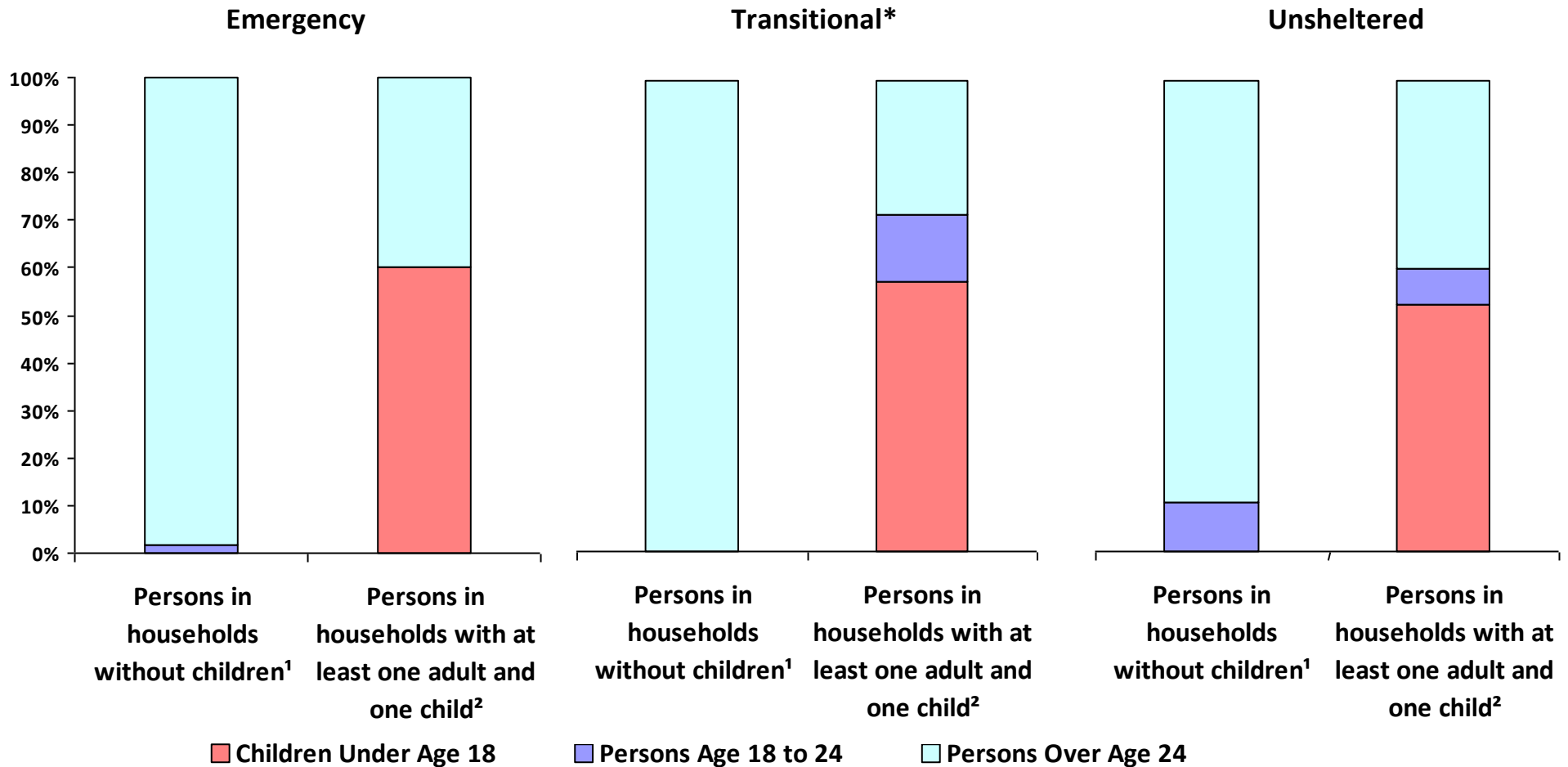

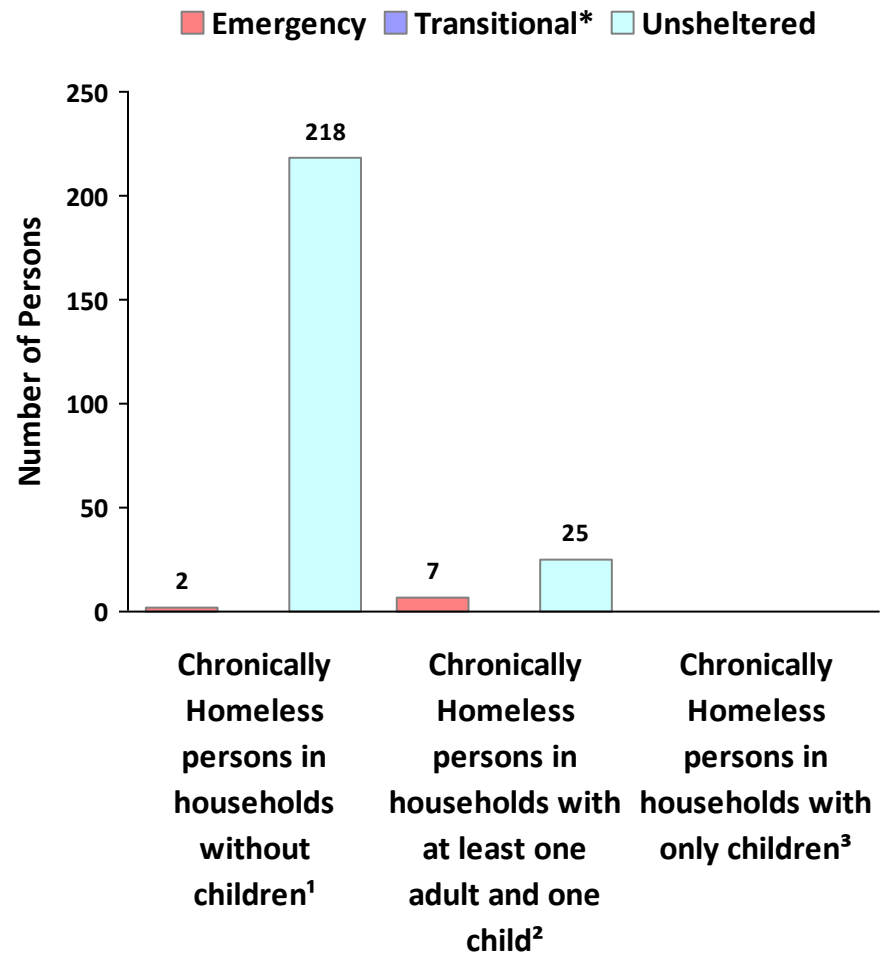
