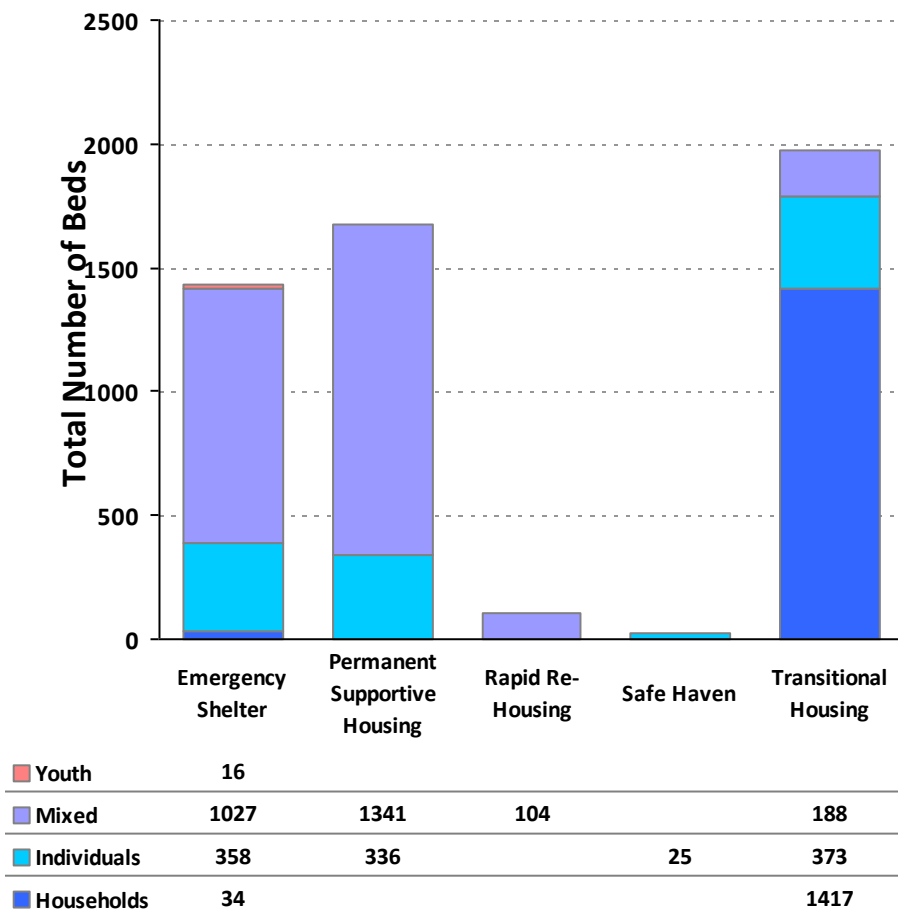

2016 Housing Inventory Summarized by Target Population and Bed Type

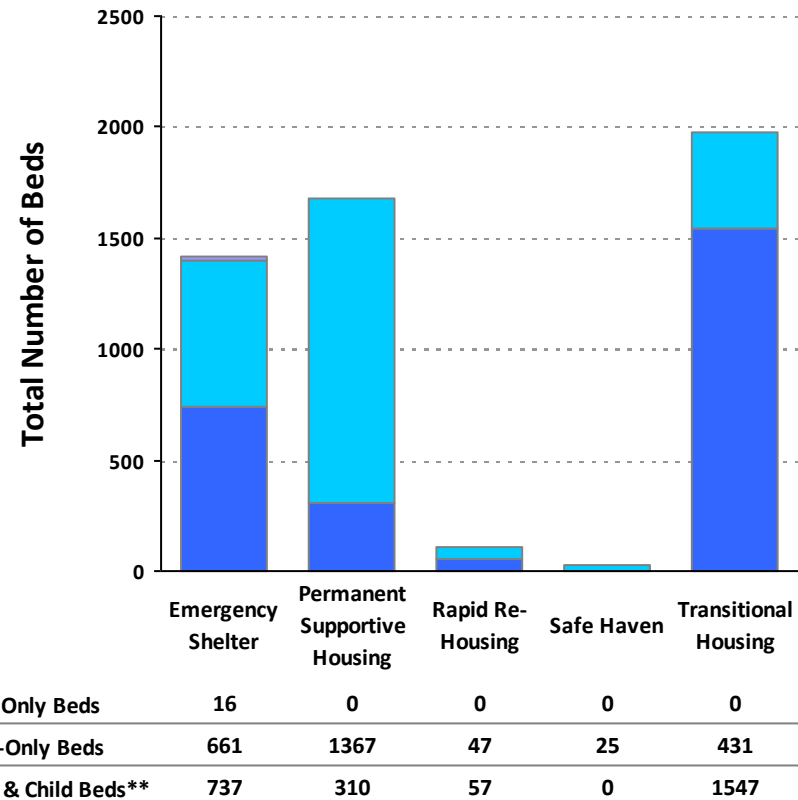
Beds by Designated Target Population

Beds by Intended Household Type Served





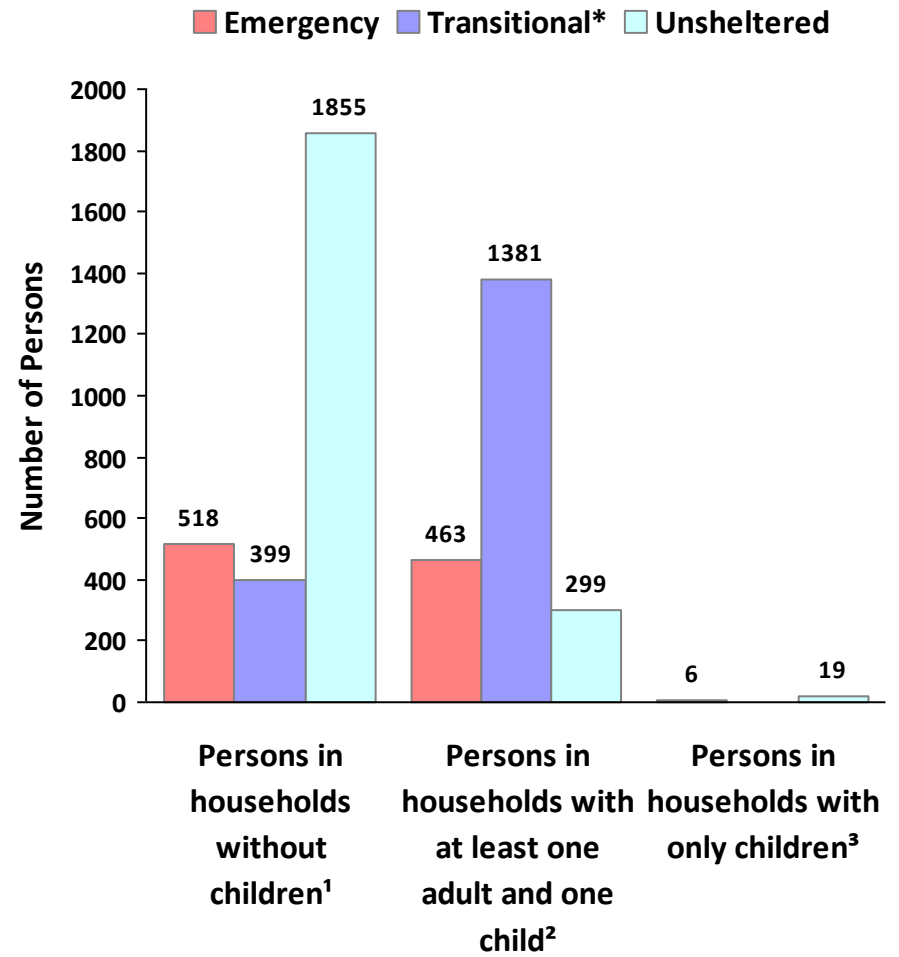
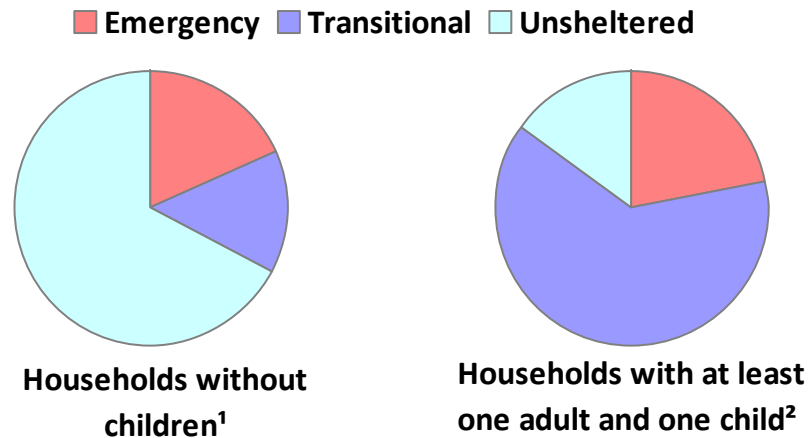

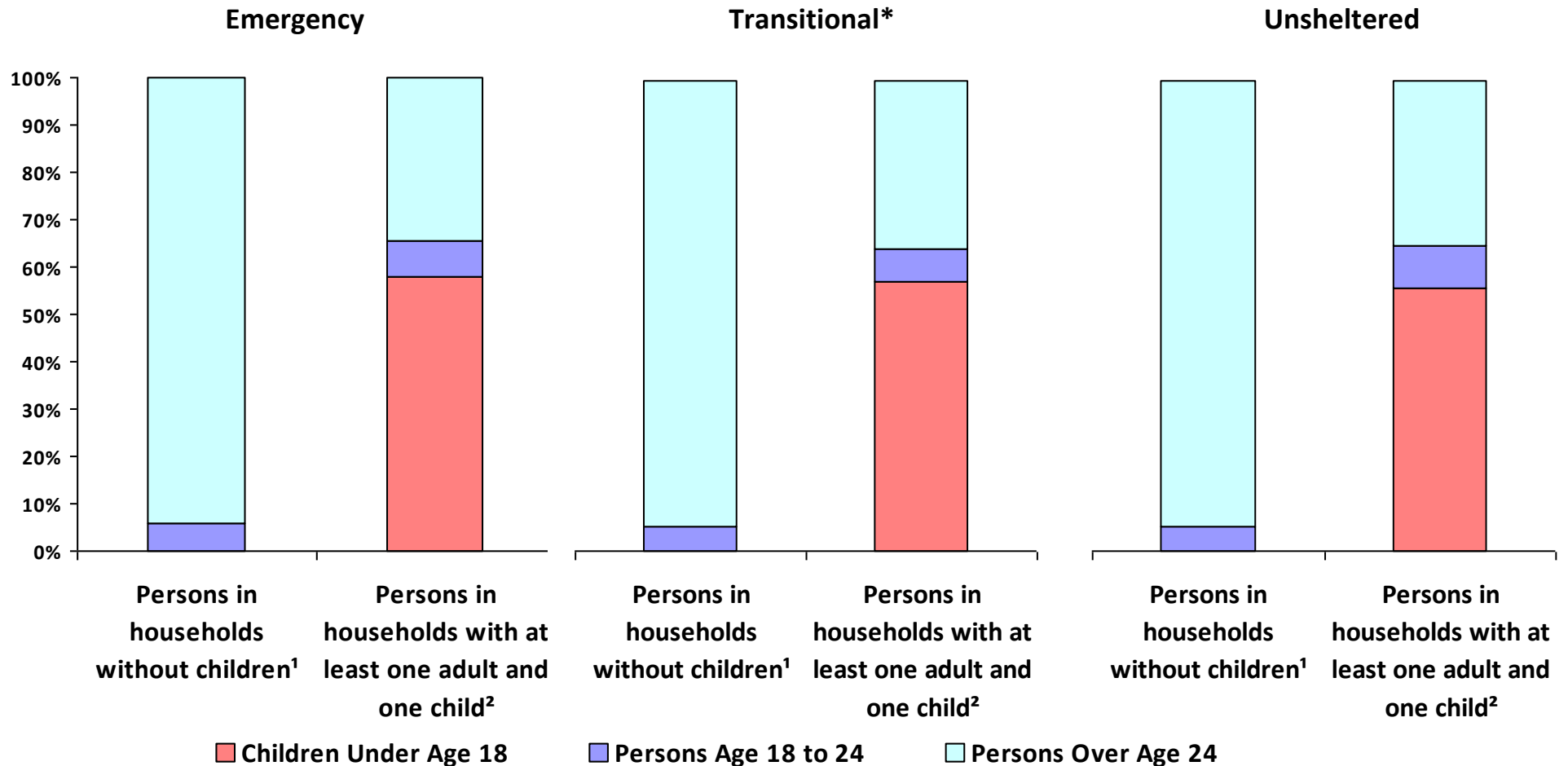
