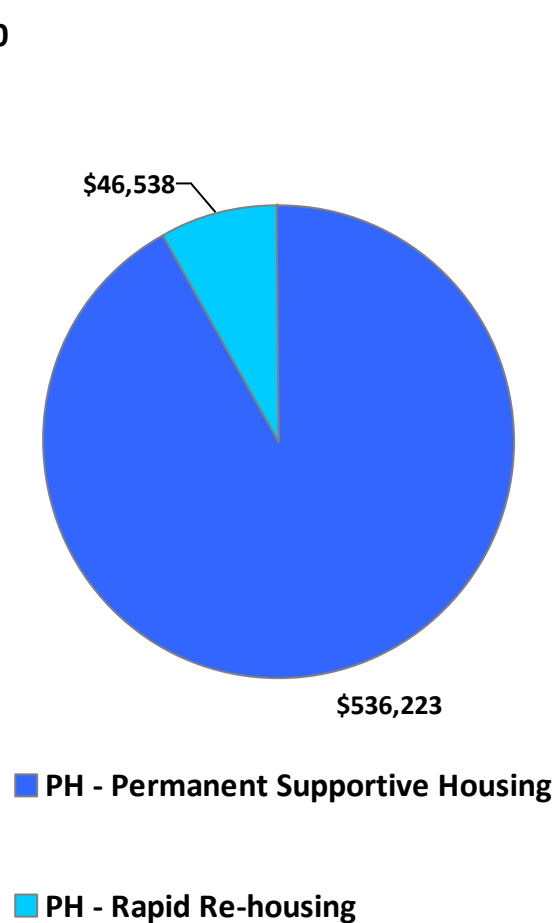

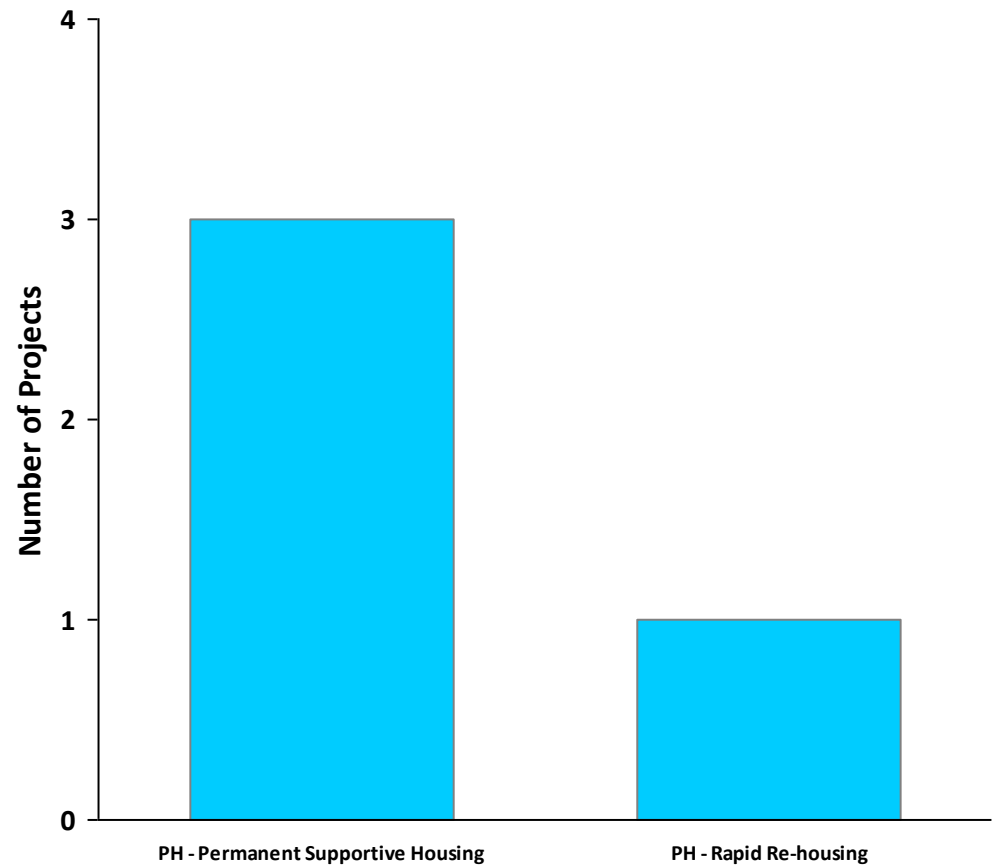

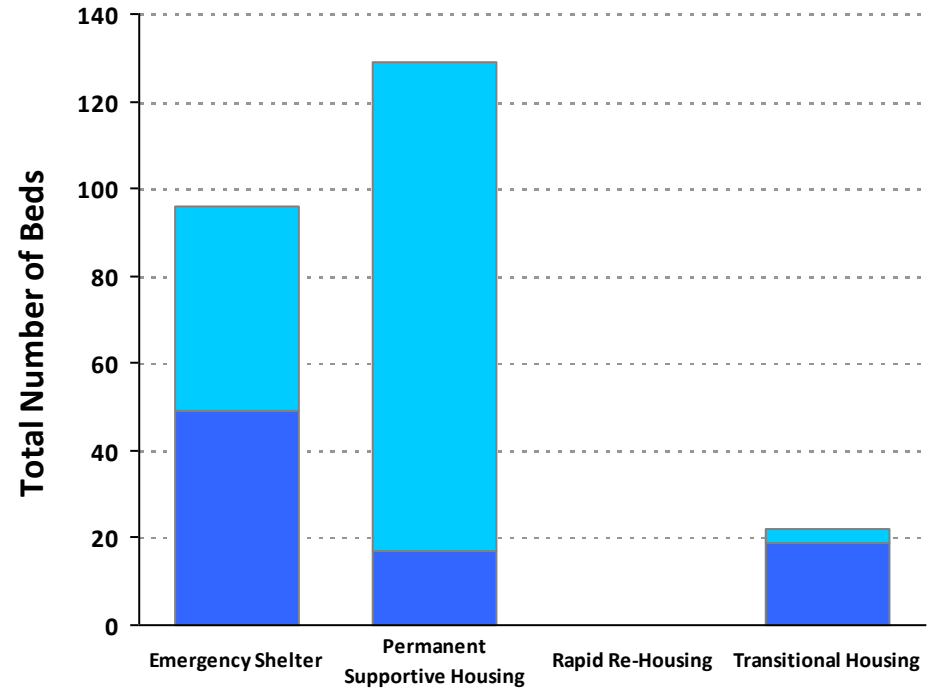
2018 Housing Inventory Summarized by Target Population and Bed Type

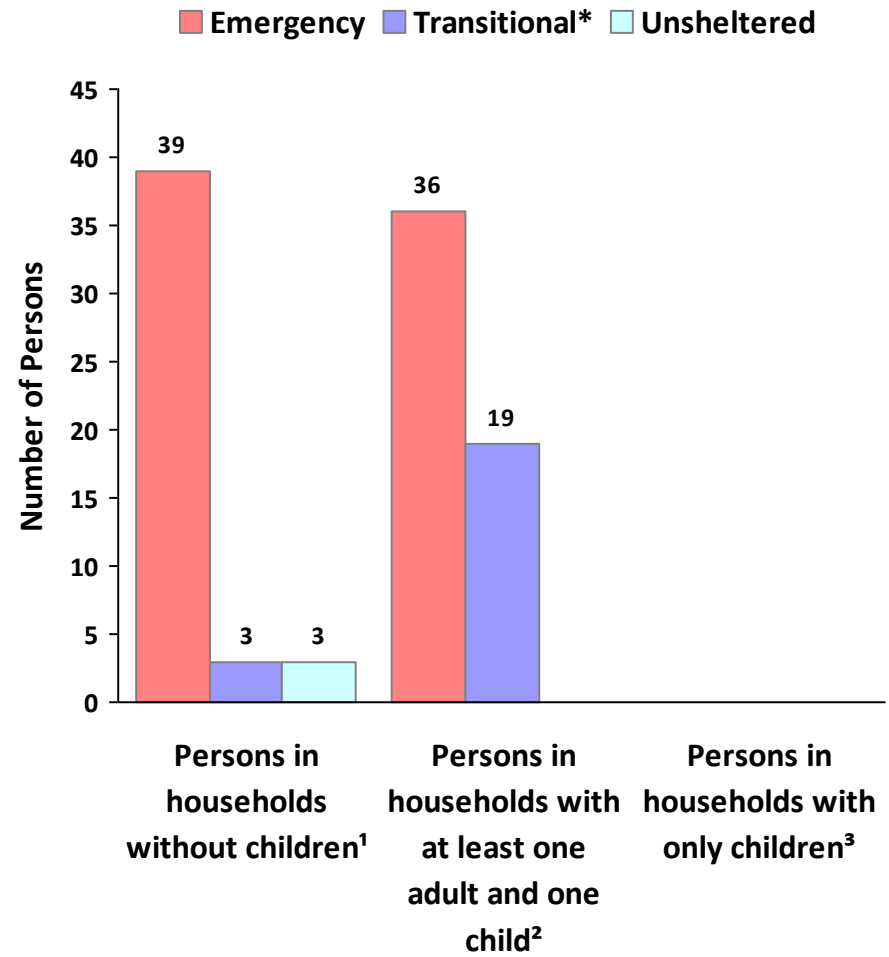

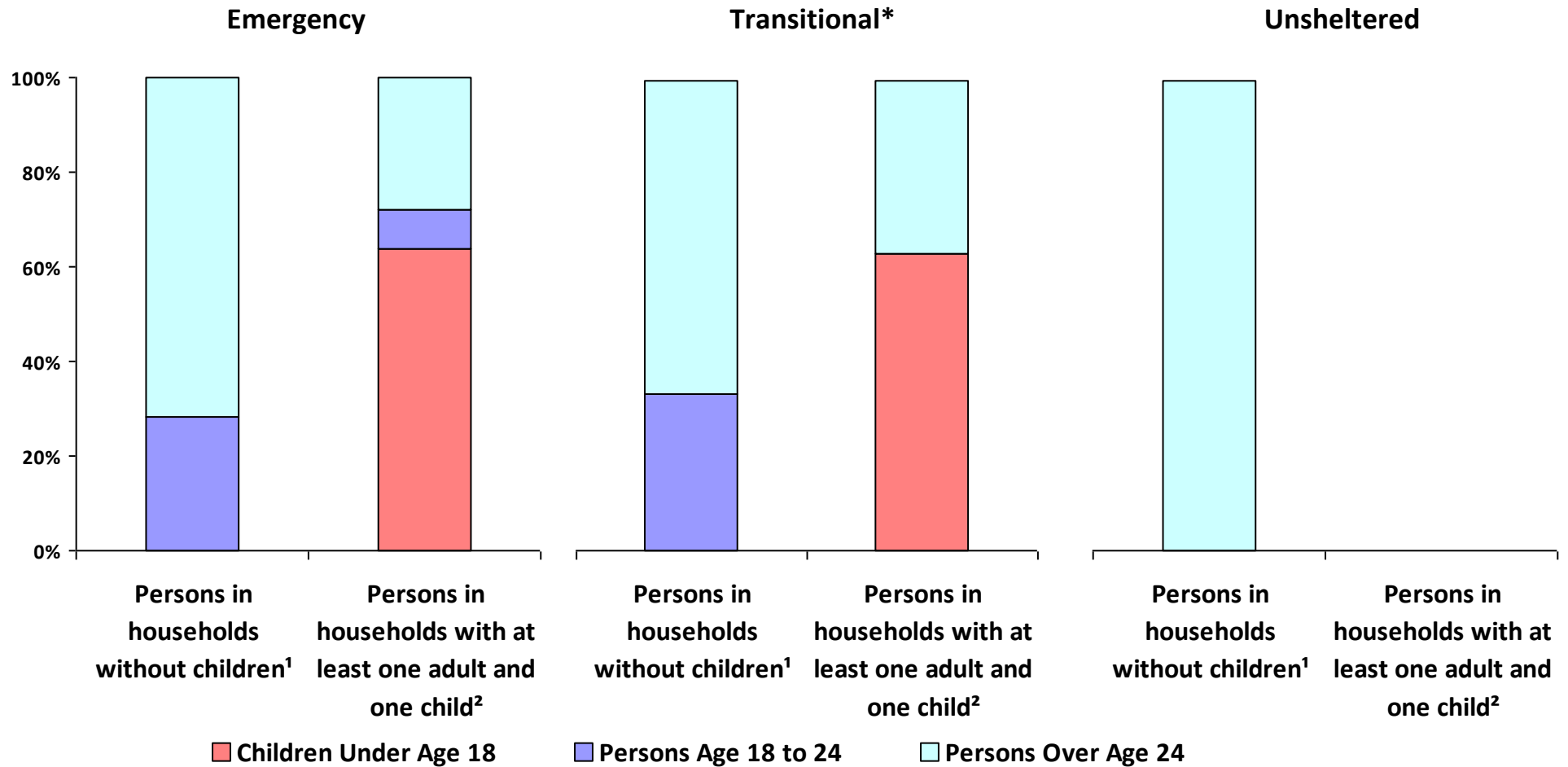

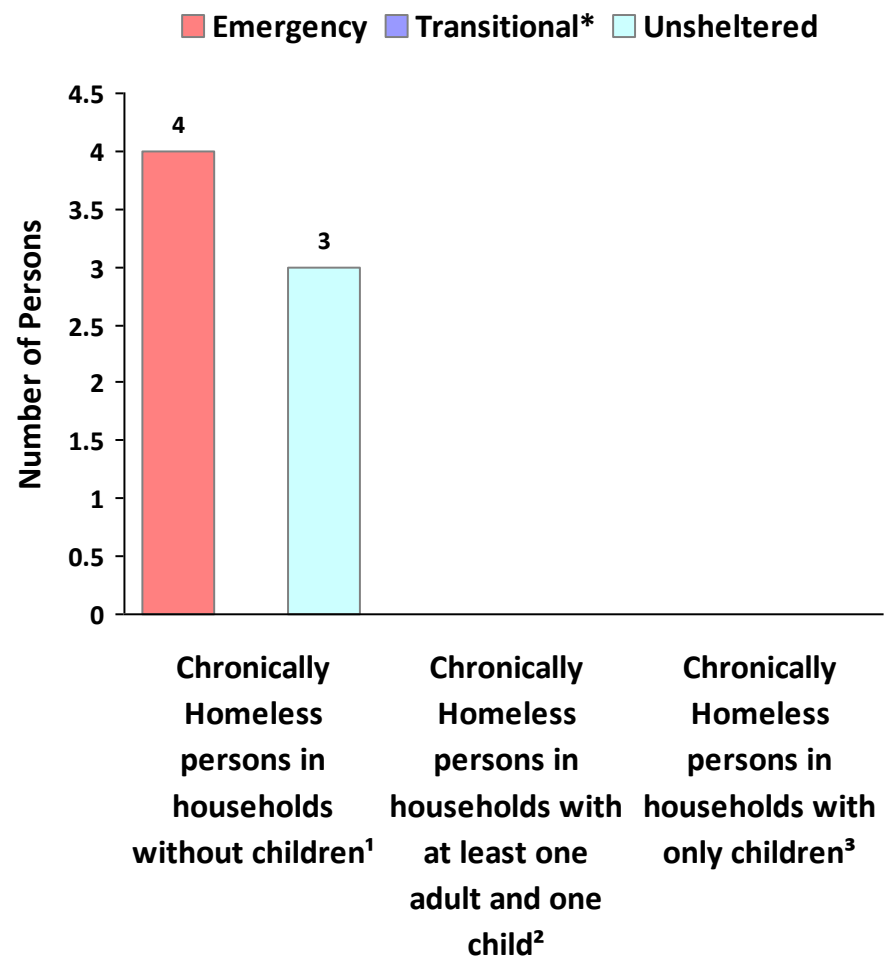
