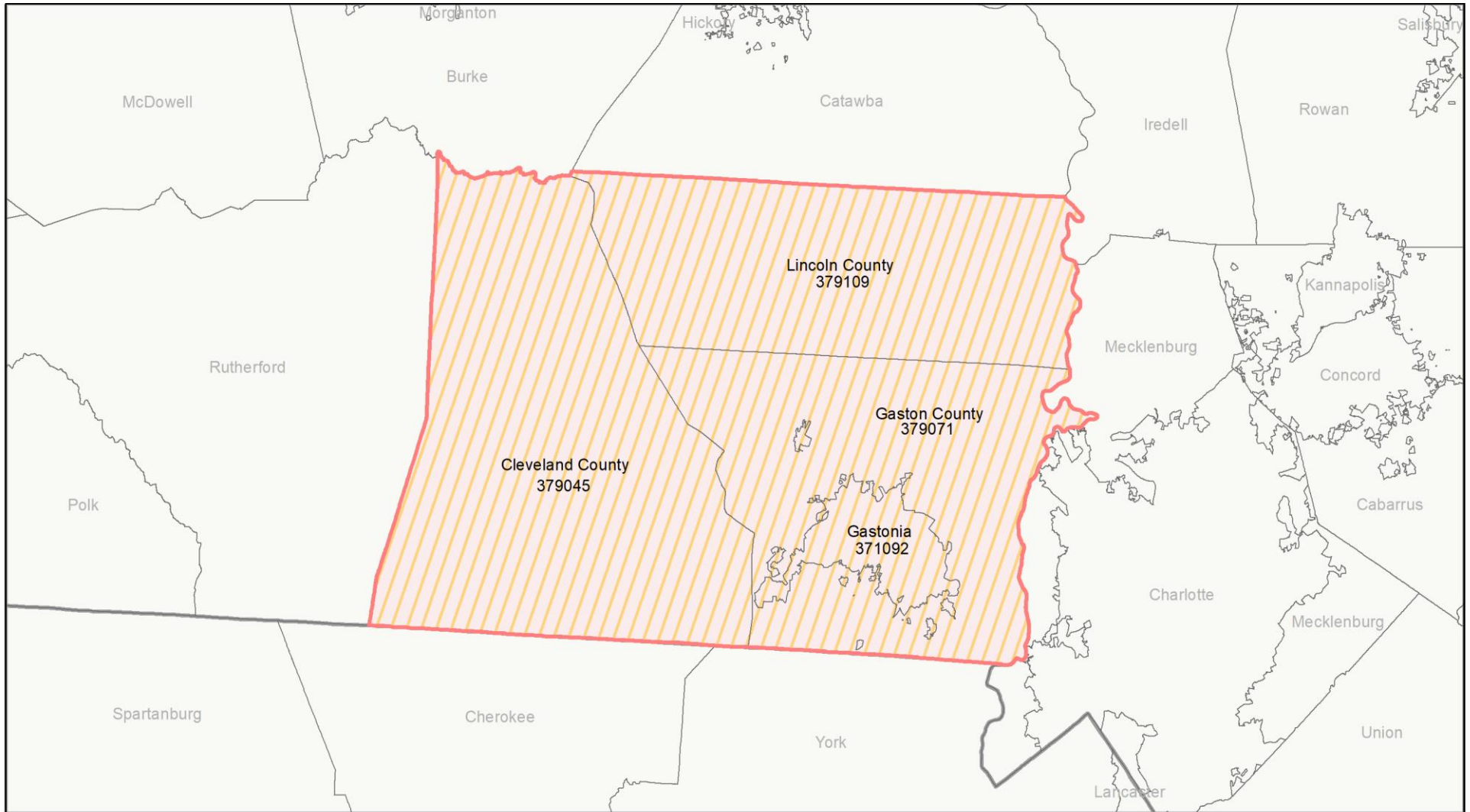

 2019 CoC Boundary  2018 CoC Boundary



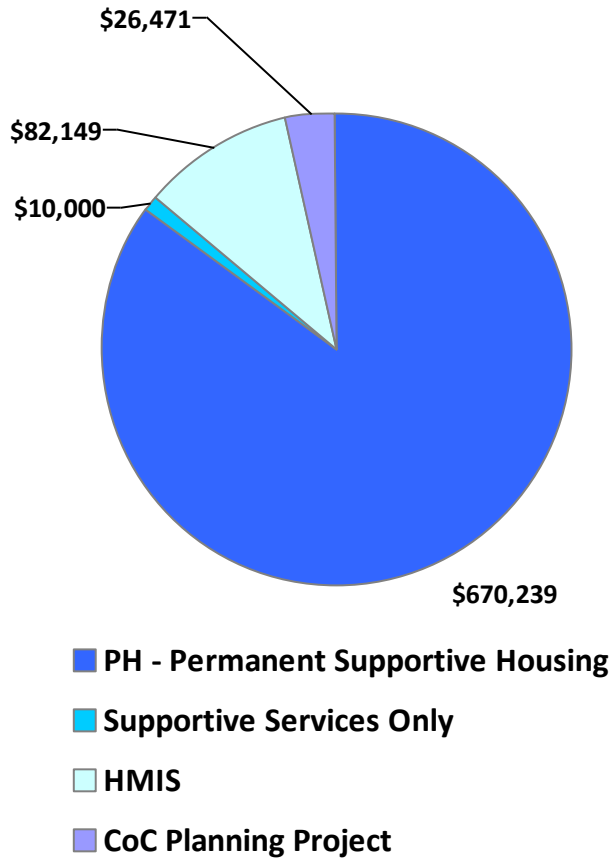

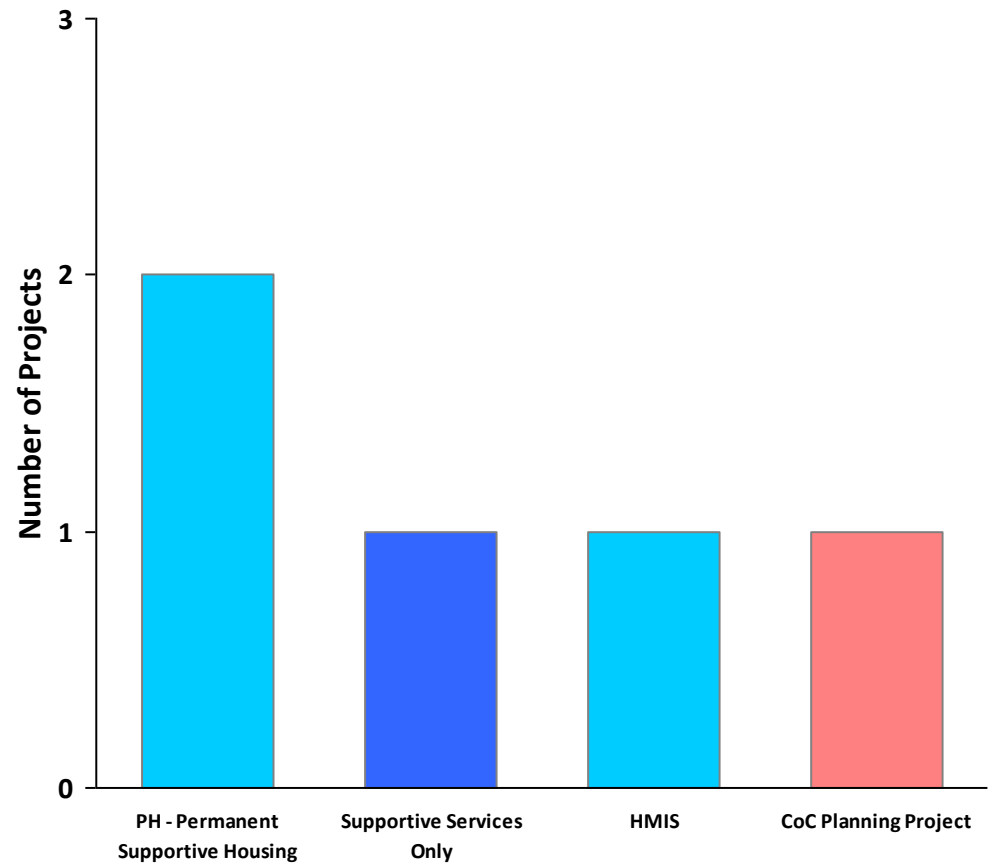

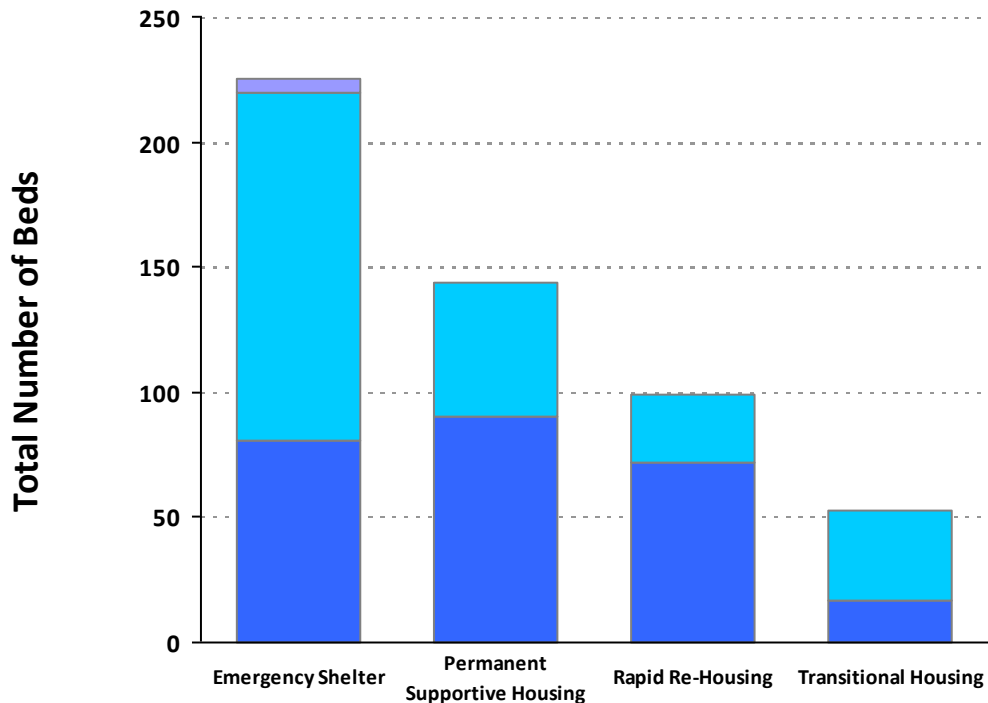

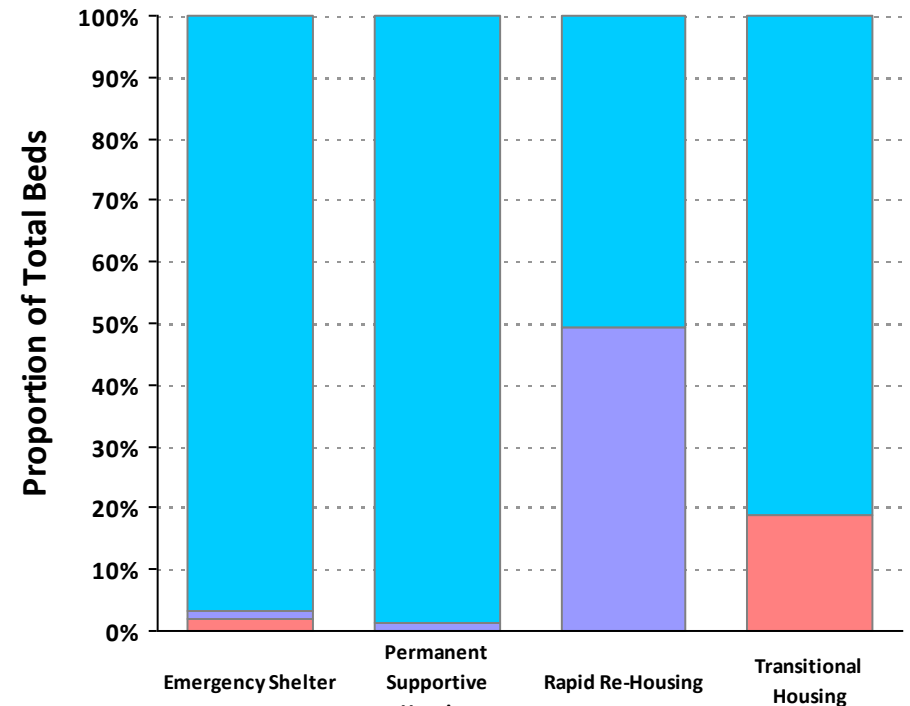

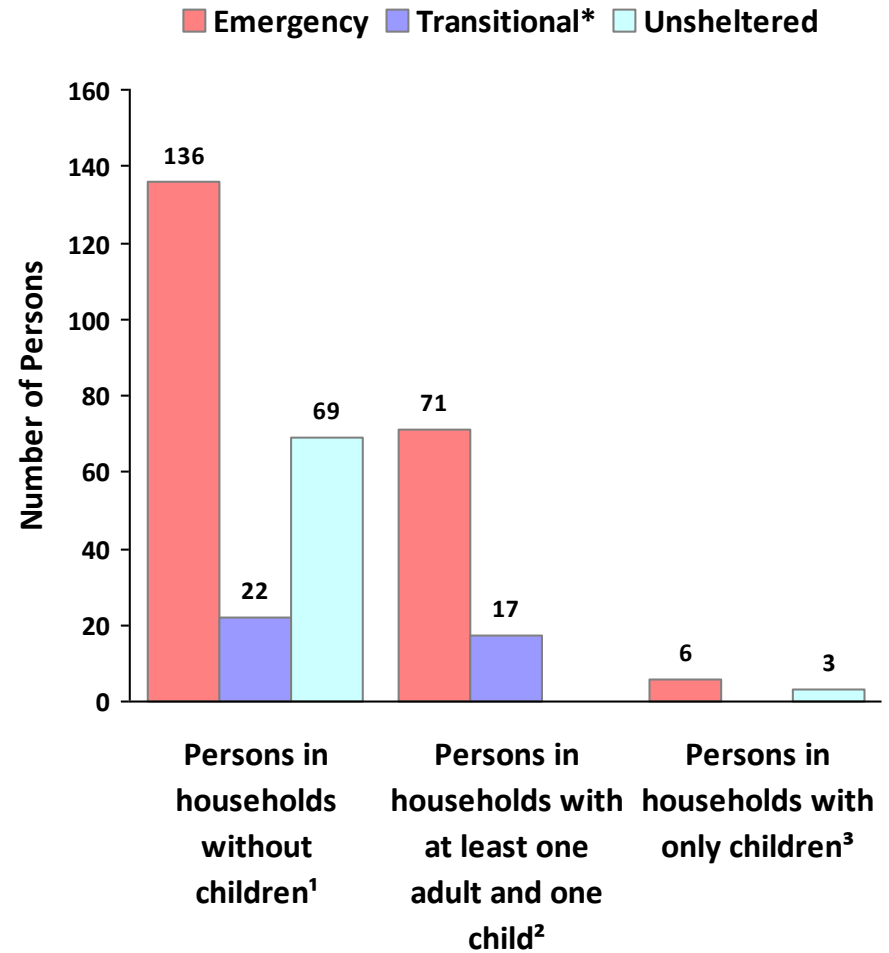

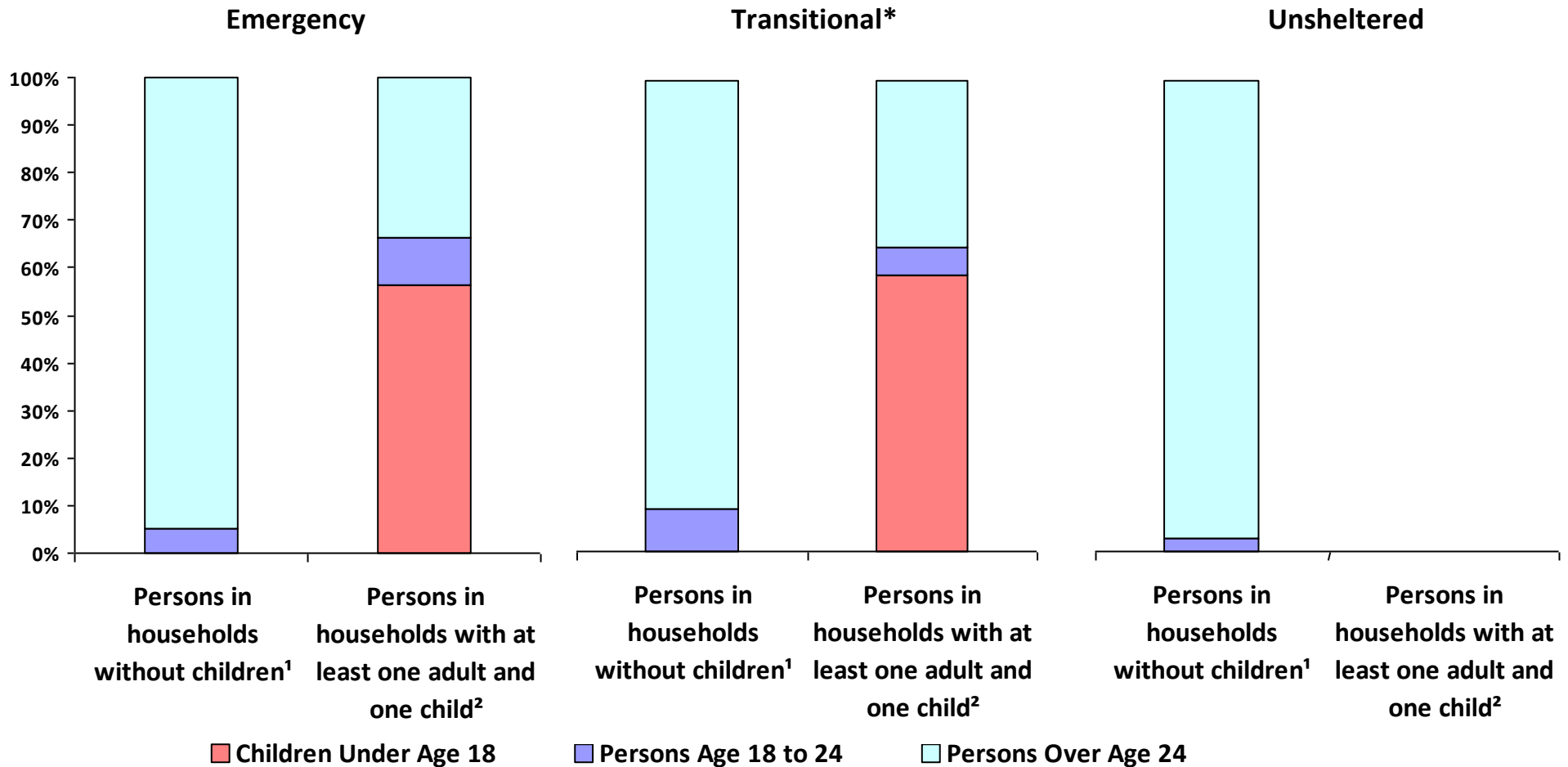

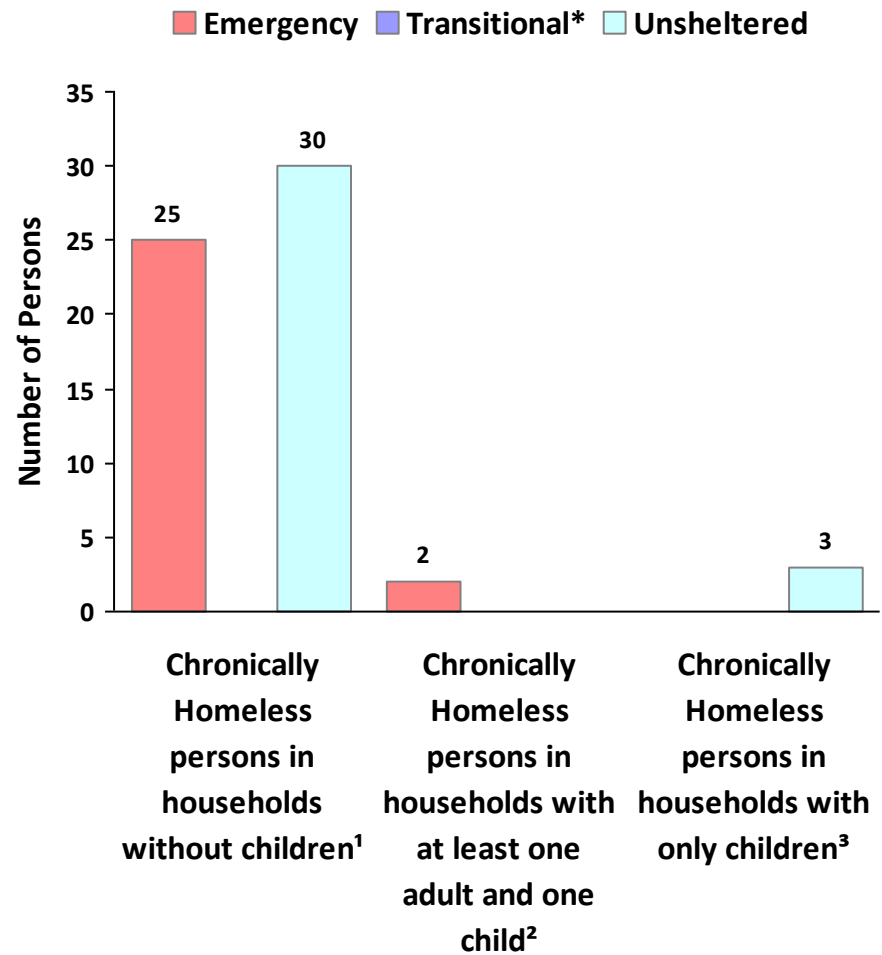
