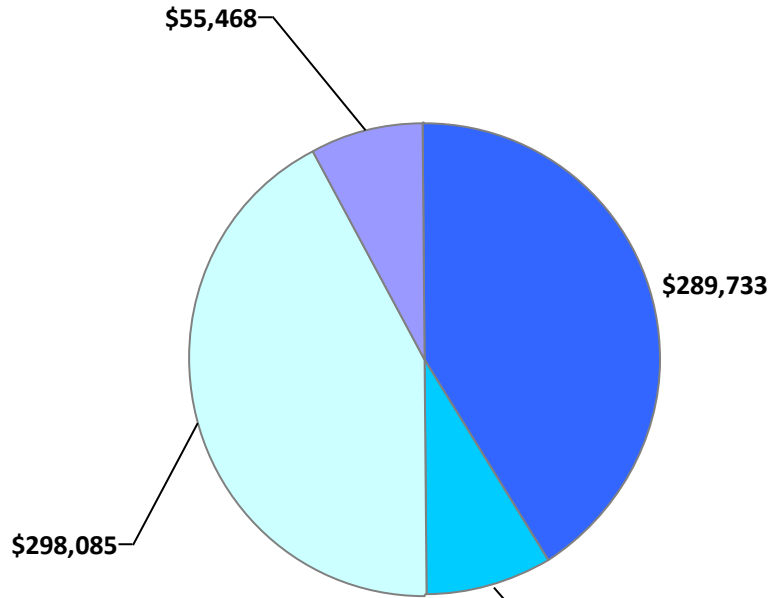

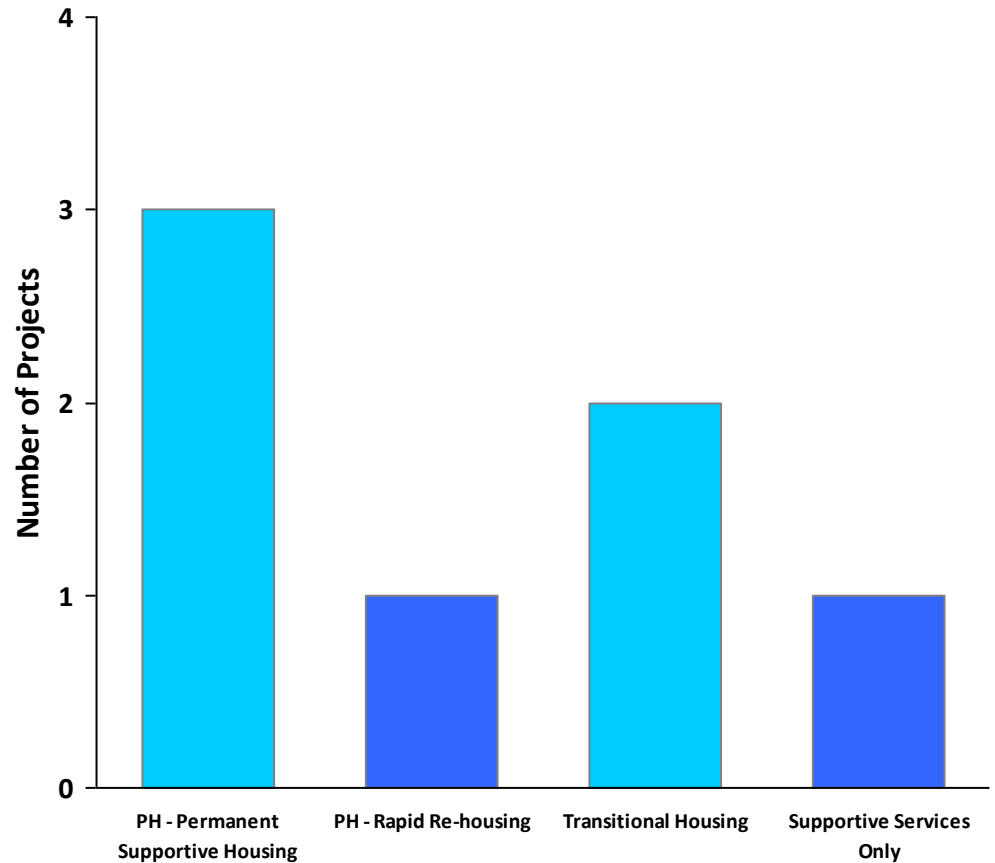

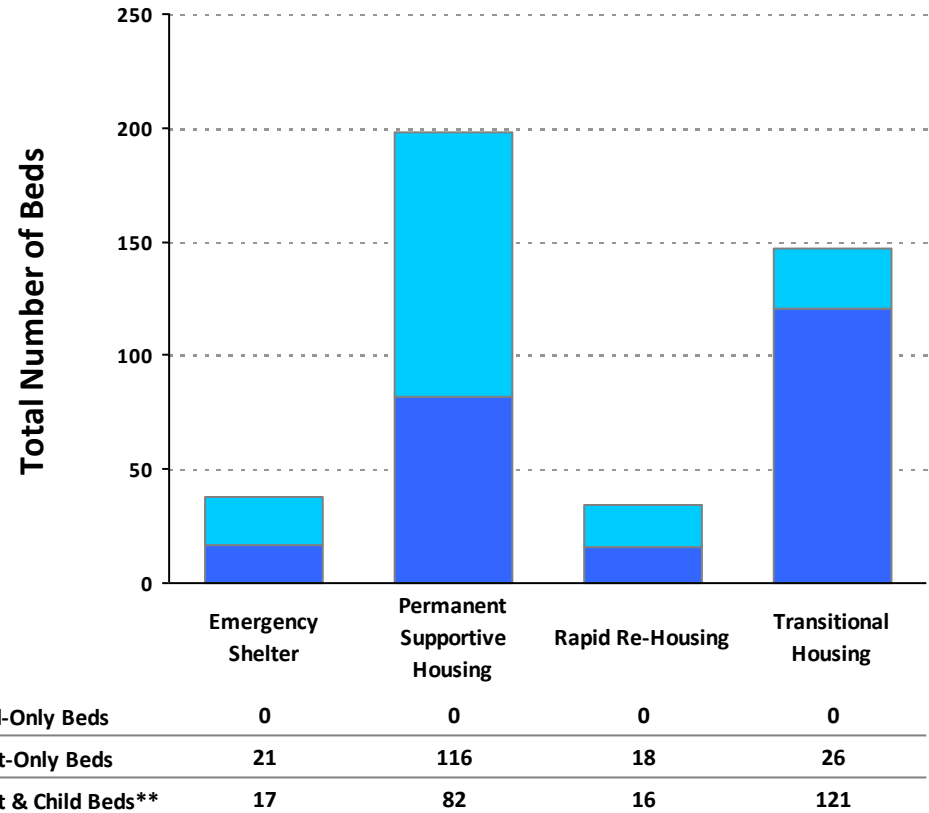

**Adult & Child and Adult & Child Beds refer to beds for households with one adult and at least one child under age 18



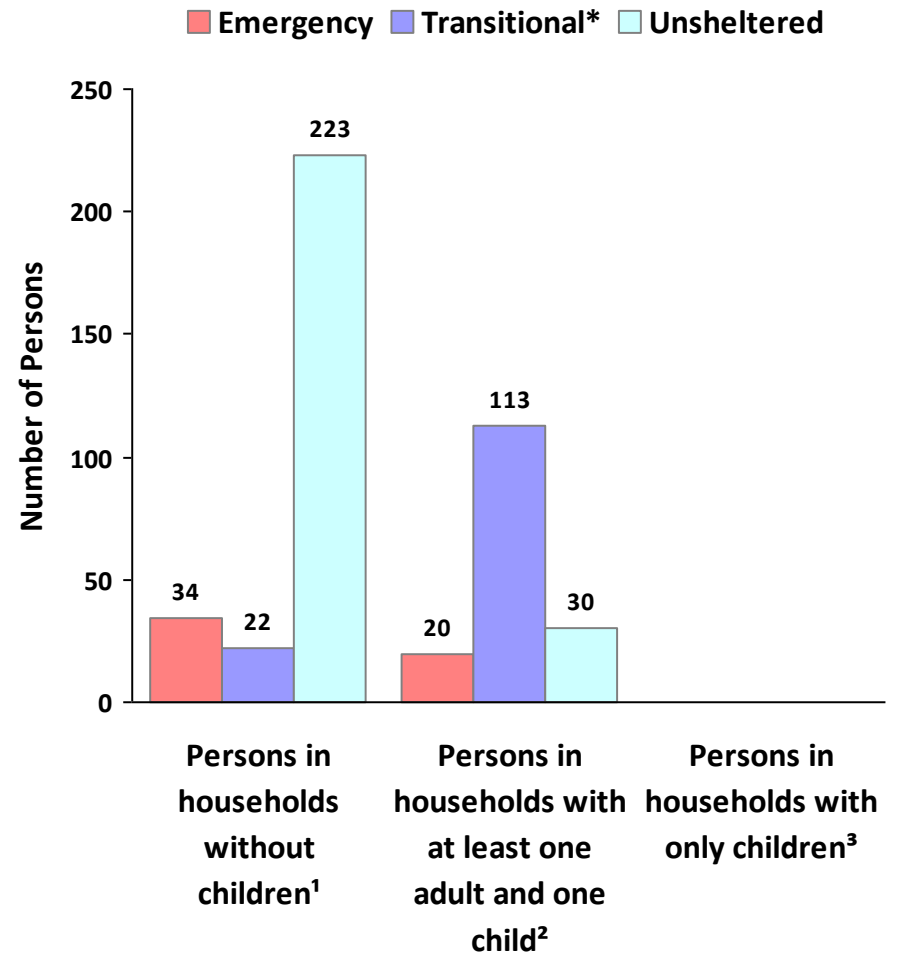
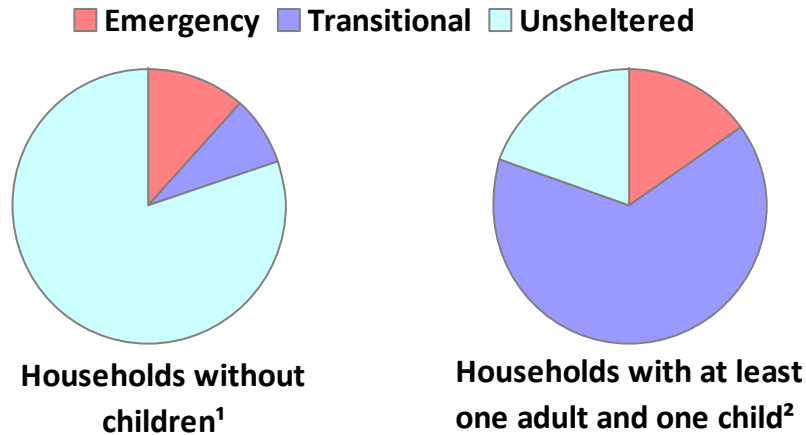

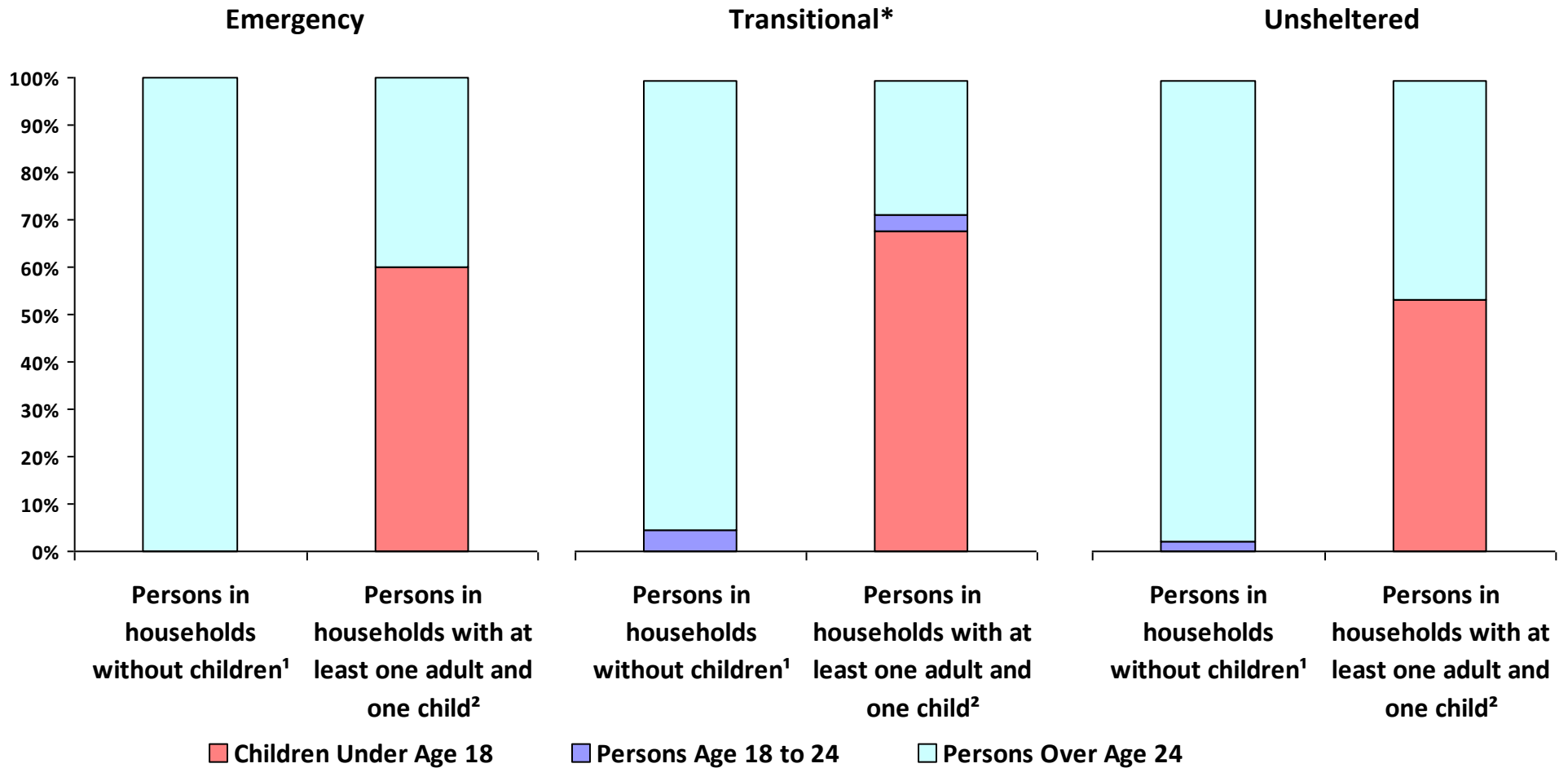

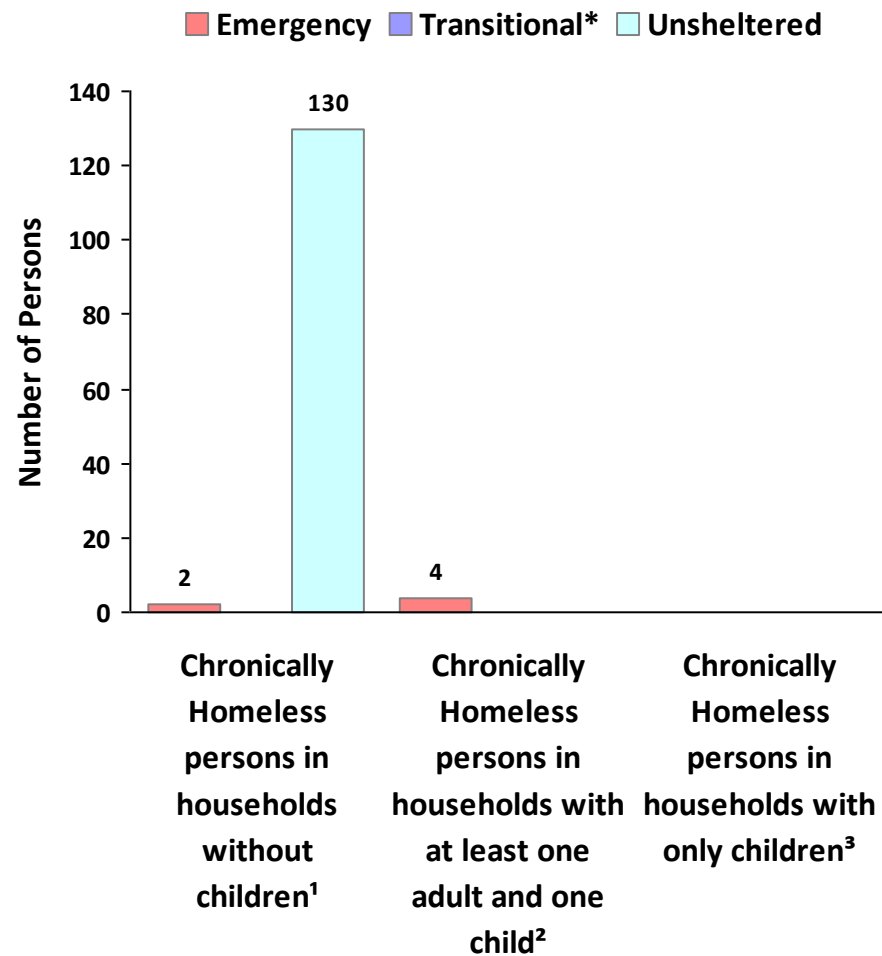
