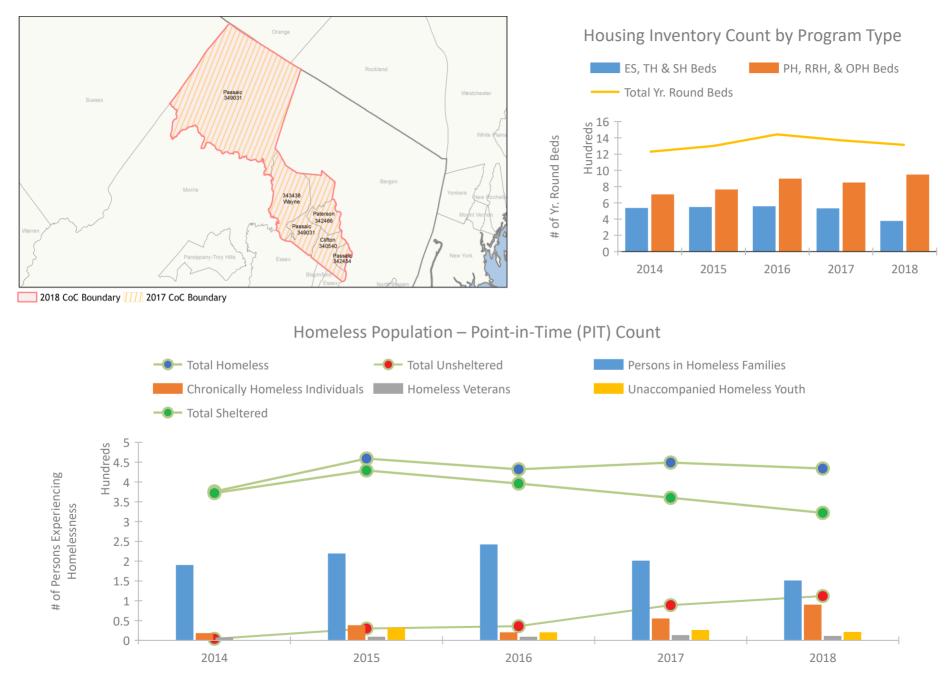

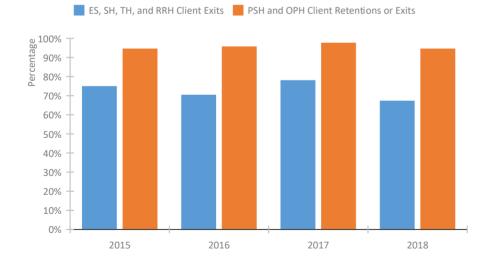


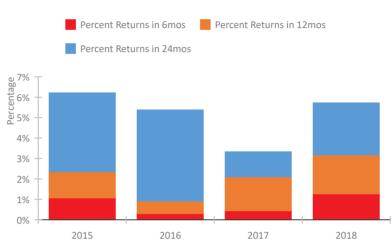

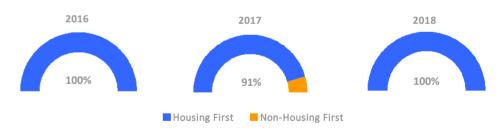
Exits to Permanent Housing by Program Type
