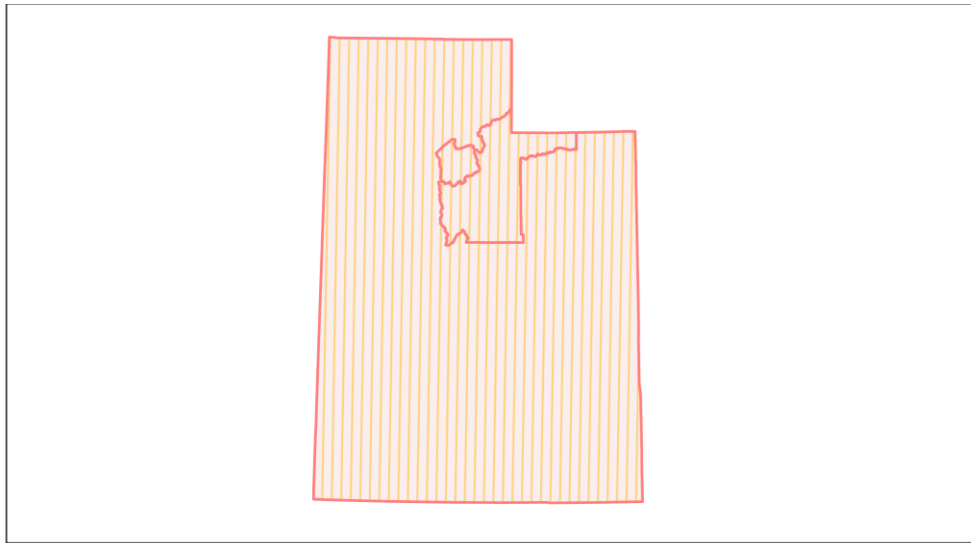
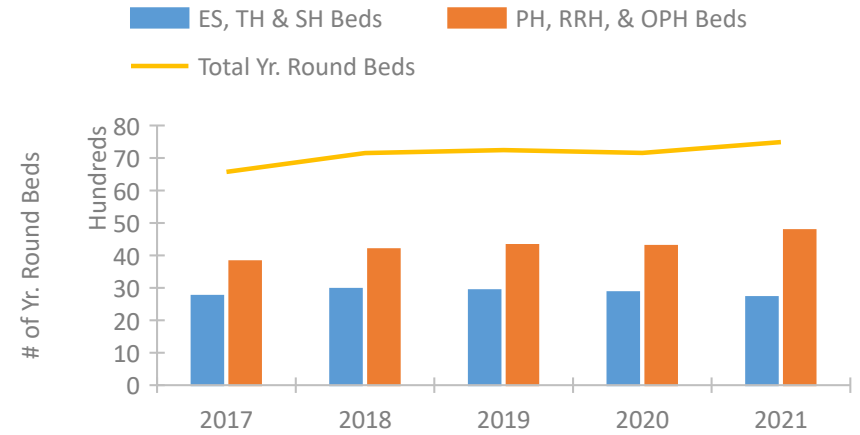

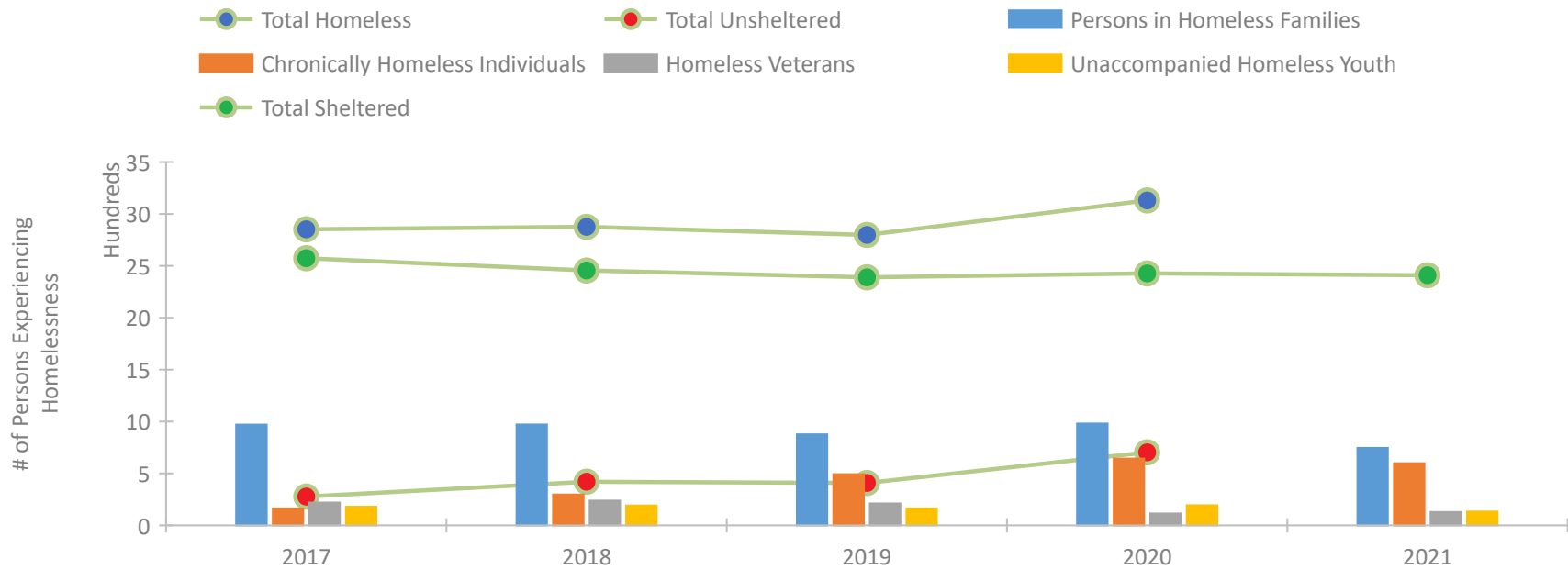


2021 CoC Boundaries 2020 CoC Boundaries

Housing Inventory Count by Program Type



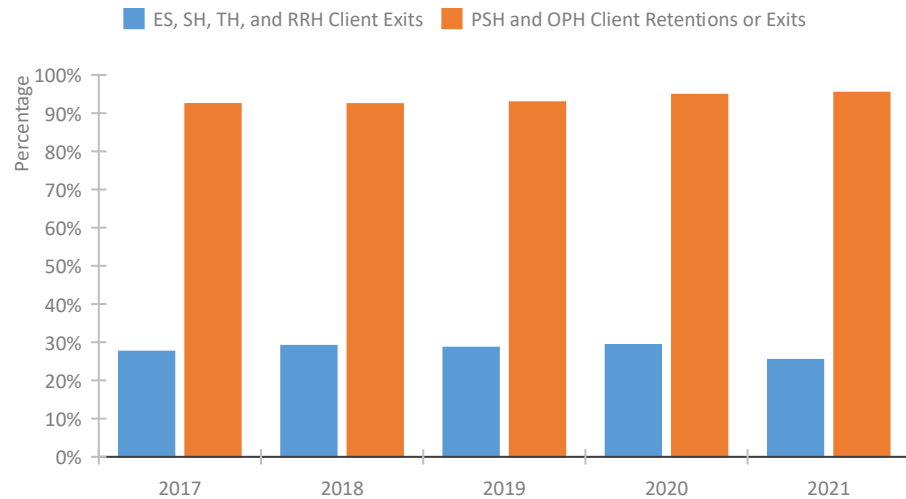
Homeless Population – Point-in-Time (PIT) Count*



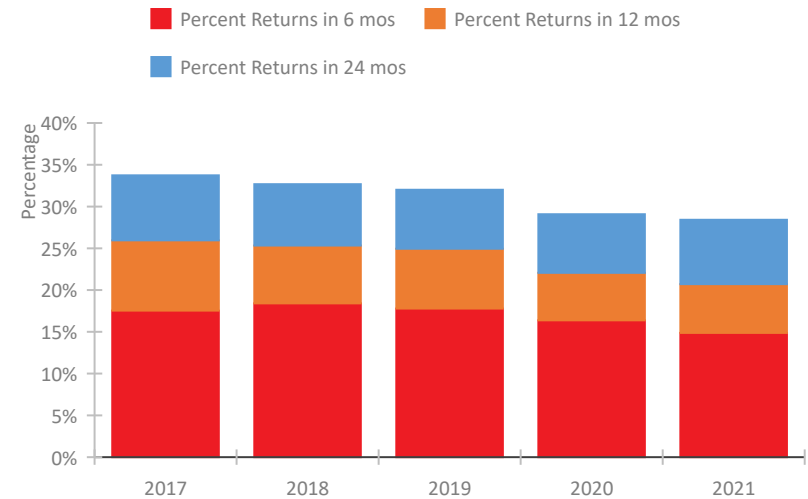

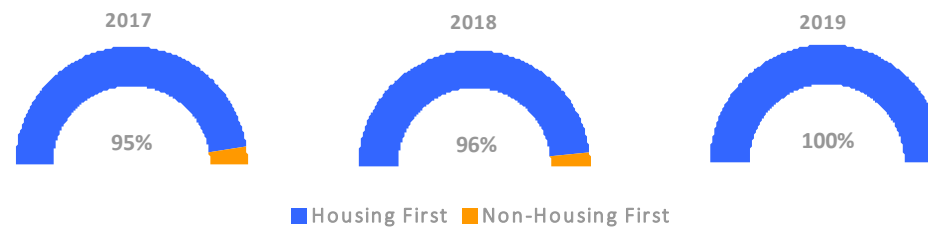
Exits to Permanent Housing by Program Type
