



Outcomes



Outcomes by Type of Housing Assistance: TBRA (n=27) is 80% Stable, 20% Unstable. Permanent Housing Facilities (n=22) is 75% Stable, 10% Temporary, 15% Unstable. Transitional/Short Term Housing Facilities (n=2) is 100% Stable. STRMU (n=43) is 100% Temporary. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




