





Outcomes



Outcomes by Type of Housing Assistance: TBRA (n=58) is 86% Stable, 14% Unstable. Transitional/Short Term Housing Facilities (n=3) is 67% Stable, 33% Temporary. STRMU (n=56) is 32% Stable, 59% Temporary, 9% Unstable. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.





Age and Gender of HOPWA Eligible Individual







Percentage of Expenditures by Type of Activity




