



Outcomes



Outcomes by Type of Housing Assistance: TBRA (n=7) is 86% Stable, 14% Unstable. Permanent Housing Facilities (n=10) is 100% Stable. Transitional/Short Term Housing Facilities (n=34) is 73% Stable, 21% Temporary, 6% Unstable. This Grantee did not provide: STRMU. Outcomes do not include households where head of household died during operating year.





Age and Gender of HOPWA Eligible Individual







Percentage of Expenditures by Type of Activity




