



Outcomes



Outcomes by Type of Housing Assistance: TBRA (n=29) is 93% Stable, 7% Unstable. Permanent Housing Facilities (n=9) is 89% Stable, 11% Unstable. STRMU (n=31) is 52% Stable, 48% Temporary. This Grantee did not provide: Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.





Age and Gender of HOPWA Eligible Individual







Percentage of Expenditures by Type of Activity




