


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=102) is 93% Stable, 7% Unstable. STRMU (n=56) is 79% Stable, 16% Temporary, 5% Unstable. 







Percentage of Expenditures by Type of Activity




