



Outcomes



Outcomes by Type of Housing Assistance: TBRA (n=125) is 91% Stable, 1% Temporary, 8% Unstable. Transitional/Short Term Housing Facilities (n=133) is 68% Stable, 12% Temporary, 20% Unstable. STRMU (n=875) is 29% Stable, 67% Temporary, 4% Unstable. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




