




Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=161) is 87% Stable, 1% Temporary, 12% Unstable. Transitional/Short Term Housing Facilities (n=95) is 63% Stable, 15% Temporary, 22% Unstable. STRMU (n=955) is 27% Stable, 71% Temporary, 2% Unstable. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




