


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=166) is 93% Stable, 1% Temporary, 6% Unstable. Permanent Housing Facilities (n=60) is 95% Stable, 5% Temporary. Transitional/Short Term Housing Facilities (n=16) is 87% Stable, 13% Unstable. STRMU (n=70) is 84% Stable, 16% Temporary. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




