




Outcomes by Type of Housing Assistance: TBRA (n=185) is 91% Stable, 5% Temporary, 4% Unstable. Permanent Housing Facilities (n=83) is 95% Stable, 2% Temporary, 3% Unstable. Transitional/Short Term Housing Facilities (n=27) is 78% Stable, 3% Temporary, 19% Unstable. STRMU (n=89) is 79% Stable, 21% Temporary. Outcomes do not include households where head of household died during operating year.







Percentage of Expenditures by Type of Activity




