



Outcomes by Type of Housing Assistance: TBRA (n=59) is 98% Stable, 2% Unstable. STRMU (n=154) is 71% Stable, 26% Temporary, 3% Unstable. This Grantee did not provide: Permanent Housing; Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.





Age and Gender of HOPWA Eligible Individual







Percentage of Expenditures by Type of Activity




