


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=146) is 96% Stable, 3% Unstable. Permanent Housing Facilities (n=41) is 92% Stable, 8% Unstable. STRMU (n=384) is 48% Stable, 51% Temporary, 1% Unstable. This Grantee did not provide: Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




