


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=291) is 87% Stable, 1% Temporary, 12% Unstable. STRMU (n=204) is 91% Stable, 9% Temporary. 







Percentage of Expenditures by Type of Activity




