


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=202) is 95% Stable, 1% Temporary, 4% Unstable. STRMU (n=338) is 47% Stable, 52% Temporary, 1% Unstable. This Grantee did not provide: Permanent Housing; Transitional/Short Term Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




