


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=10) is 100% Stable. Transitional/Short Term Housing Facilities (n=7) is 86% Stable, 14% Unstable. STRMU (n=34) is 62% Stable, 38% Temporary. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.







Percentage of Expenditures by Type of Activity




