


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=126) is 94% Stable, 6% Unstable. Permanent Housing Facilities (n=8) is 75% Stable, 25% Unstable. STRMU (n=205) is 9% Stable, 90% Temporary, 1% Unstable. This Grantee did not provide: Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.





Percentage of Expenditures by Type of Activity




