




Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=32) is 93% Stable, 7% Unstable. Transitional/Short Term Housing Facilities (n=77) is 93% Stable, 7% Unstable. STRMU (n=377) is 27% Stable, 72% Temporary, 1% Unstable. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




