


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=667) is 96% Stable, 1% Temporary, 3% Unstable. Transitional/Short Term Housing Facilities (n=45) is 93% Stable, 2% Temporary, 5% Unstable. STRMU (n=511) is 39% Stable, 51% Temporary, 10% Unstable. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




