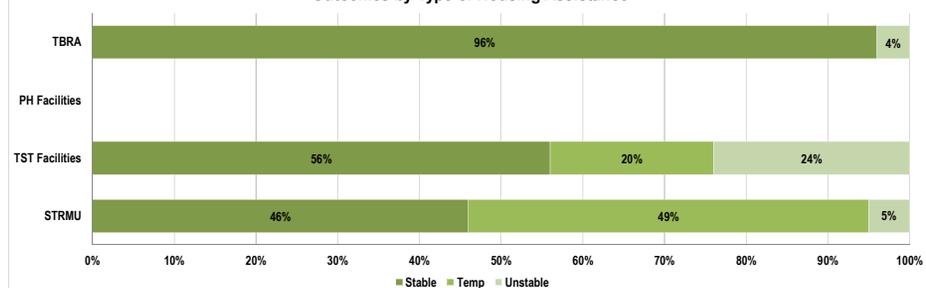

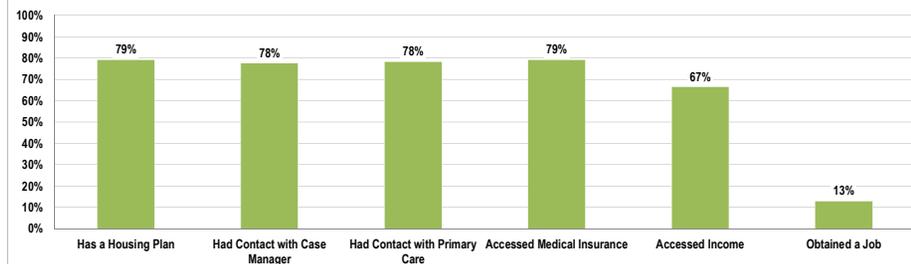
Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=53) is 96% Stable, 4% Unstable. Transitional/Short Term Housing Facilities (n=85) is 56% Stable, 20% Temporary, 24% Unstable. STRMU (n=99) is 46% Stable, 49% Temporary, 5% Unstable. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.

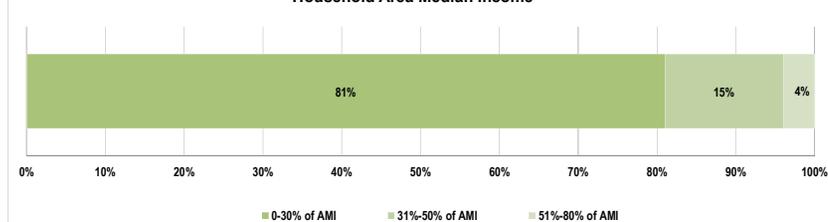

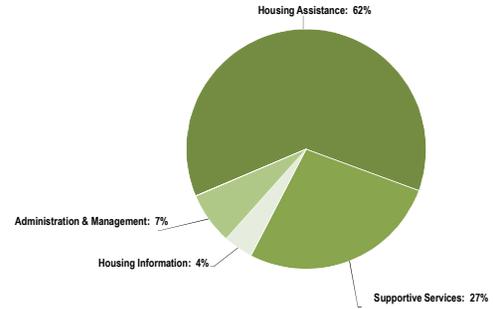

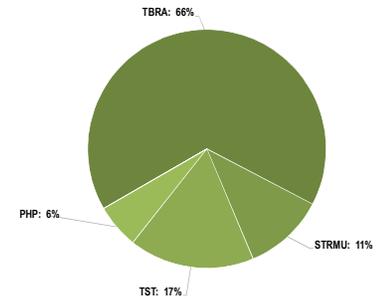

Percentage of Expenditures by Type of Activity



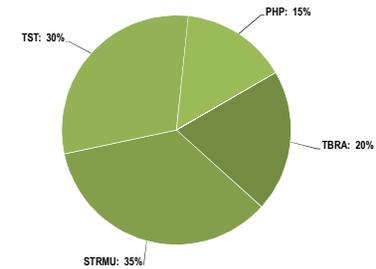
