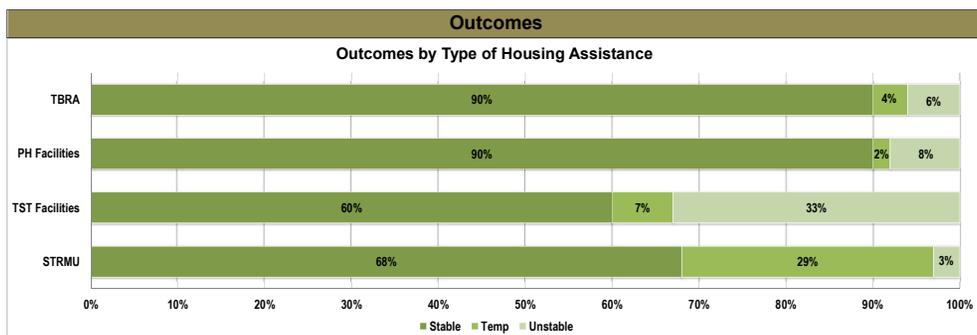
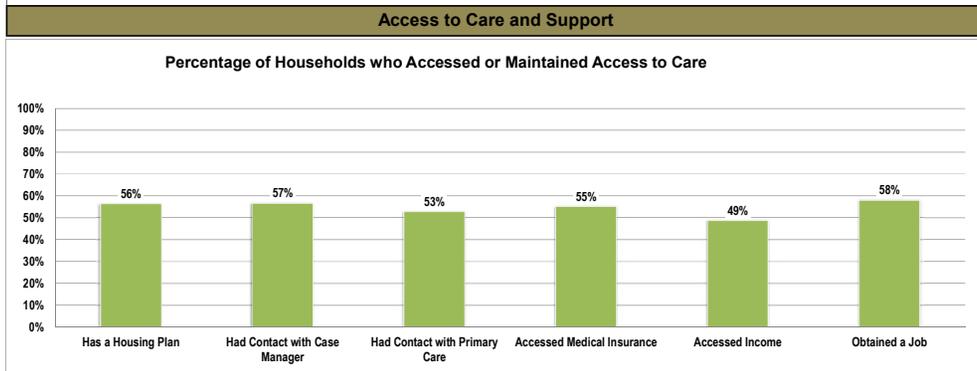

Outcomes by Type of Housing Assistance: TBRA (n=839) is 90% Stable, 4% Temporary, 6% Unstable. Permanent Housing Facilities (n=830) is 90% Stable, 2% Temporary, 8% Unstable. Transitional/Short Term Housing Facilities (n=195) is 60% Stable, 7% Temporary, 33% Unstable. STRMU (n=697) is 68% Stable, 29% Temporary, 3% Unstable. Outcomes do not include households where head of household died during operating year.

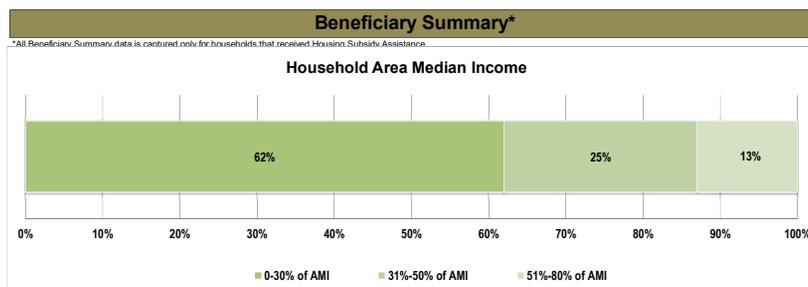

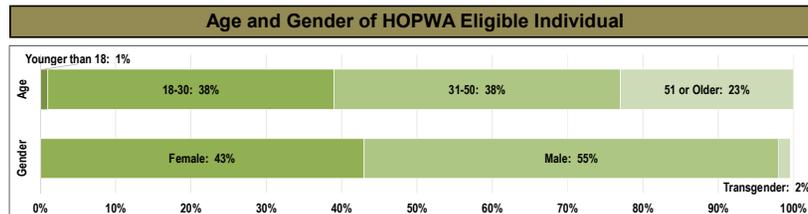

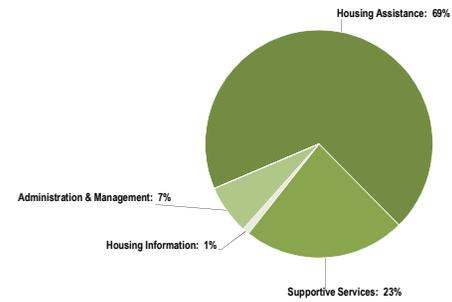

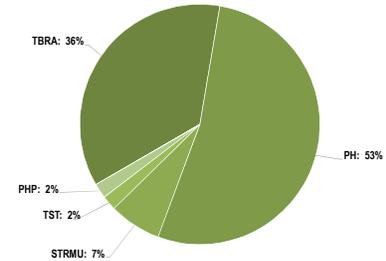

Percentage of Expenditures by Type of Activity



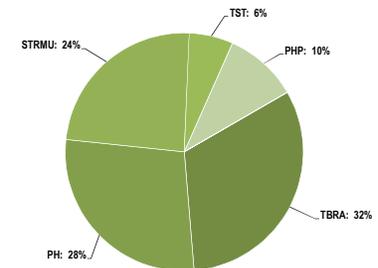
