


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=62) is 85% Stable, 15% Unstable. Transitional/Short Term Housing Facilities (n=145) is 68% Stable, 15% Temporary, 17% Unstable. STRMU (n=96) is 91% Stable, 2% Temporary, 7% Unstable. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




