


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=57) is 94% Stable, 2% Temporary, 4% Unstable. Transitional/Short Term Housing Facilities (n=133) is 55% Stable, 13% Temporary, 32% Unstable. STRMU (n=93) is 83% Stable, 13% Temporary, 4% Unstable. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




